## Narrative:

GE2 RESPONDED TO A SMOKE INVESTIGATION IN THE AREA OF BARCLAY AND KATELLA TO FIND HEAVY SMOKE FROM THE REAR OF A ONE STORY RESIDENTIAL AT THE UPDATED ADDRESS. GE2 BALANCED THE ASSIGNMENT TO A STRUCTURE RESPONSE AND WENT INTO ATTACK MODE USING 1 3/4" PRE-CONNECT. FIRE ATTACK WAS MADE ON THE CHARLIE SIDE OF THE STRUCTURE THROUGH A SLIDING DOOR WHERE A MAJORITY OF THE FIRE WAS LOCATED, FIRE WAS ALSO FOUND TO BE IN THE ATTIC SPACE OF THE STRUCTURE. GB1 ARRIVED ON SCENE, ASSUMED COMMAND, ASSIGNED GE2 TO FIRE ATTACK AND ASSIGNED ALL OTHER RESOURCES AS APPROPRIATE. A PRIMARY AND SECONDARY SEARCH WERE ALL CLEAR, DURING THESE SEARCHES IT WAS FOUND THAT THE HOME WAS BEING UTILIZED AS A MARIJUANA GROW HOUSE WHICH INCLUDED SCABBED-IN ELECTRICITY AND MODIFICATIONS TO THE CONSTRUCTION OF THE HOME. EDISON RESPONDED AND SECURED ELECTRICITY TO THE PROPERTY AND ALL OTHER UTILITIES WERE SHUT-OFF. FIRE KNOCK DOWN WAS ANNOUNCED IN JUST OVER 30 MINUTES. GI1 AND GI4 INVESTIGATED THE FIRE WHICH IS STILL ONGOING. OVERHAUL WAS CONDUCTED BY GE2 AND GT1 UTILIZING FOAM. GGPD REMAINED ON SCENE TO CONDUCT THEIR INVESTIGATION. GEZ COMPLETED.
