Narrative:

GE2 RESPONDED TO A REPORT OF A STRUCTURE FIRE AT A 2 STORY CONDO COMPLEX. GE2 ENTERED THE COMPLEX THROUGH MAN DOOR AND FOUND LIGHT SMOKE SHOWING FROM A SECOND FLOOR UNIT.. GE2 ENTERED THE SECOND FLOOR UNIT AND FOUND MODERATE SMOKE AND SMOLDERING CLOTHS IN A CLOSET. GE2 ASSUMED FIRE ATTACK AND EXTINGUISHED THE SMOLDERING CLOTHS.

AFTER REMOVING THE CLOTHS FROM THE CLOSET, GE2 FOUND A LIGHT FIXTURE BEHIND THE CLOTHS. GE2 DETERMINED THAT THE CLOTHS CAUSED THE LIGHT BULBS TO OVER HEAT AND CATCH THE CLOTHS ON FIRE.

GE2 CHECKED FOR EXTENSION IN THE ATTACK AND FOUND NO FIRE SPREAD. THE OCCUPANTS OF THE RESIDENCE WERE INSTRUCTED TO NOT OCCUPY THE RESIDENCE AND CONTACT THE HOME OWNER ABOUT REPAIRS. THEY WERE ALSO INSTRUCTED TO CONTACT THE BUILDING DEPARTMENT BEFORE THEY OCCUPY THE RESIDENCE. THE POWER WAS SHUT DOWN AND A PROPERTY RELEASE WAS SIGNED AND GE2 CLEARED THE CALL.
