Narrative:

GE2 ARRIVED AT THE REPORTED ADDRESS TO FIND A ONE-STORY SINGLE-WIDE MOBILE HOME WITH FIRE OBSERVED THROUGH A NORTH FACING WINDOW AND CHEST HIGH SMOKE SEEN THROUGH THE OPEN FRONT DOOR. OCCUPANTS FOUND TO THE FRONT OF THE HOME AND THEY STATED THAT EVERYONE WAS OUT OF THE STRUCTURE. GE2 INITIATED AN ALLEY LAY AND WENT INTO ATTACK MODE WITH GE1 ESTABLISHING COMMAND AND SECURING A WATER SUPPLY. GE2 FOUND THE FIRE CONFINED TO THE KITCHEN AREA WITH FIRE KNOCK DOWN WITHIN TEN MINUTES OF ARRIVAL. ocfa BATTALION 1 ARRIVED ON SCENE, ASSUMED COMMAND, AND ASSIGNED ALL OTHER RESOURCES AS APPROPRIATE. PRIMARY AND SECONDARY SEARCHES WERE FOUND TO BE ALL CLEAR AND UTILITIES WERE SHUT OFF BY GT1 WITH THE EXCEPTION OF THE WATER AS THE VALVE WAS FROZEN. THE ORIGIN AND CAUSE OF THE FIRE WAS INVESTIGATED BY GI4. GE2 EXPLAINED THE PROPERTY RELEASE WITH THE HOME OWNER WHOM SIGNED AND WAS PROVIDED A COPY. GE2 COMPLETED.
