Narrative:

GE2 responded as part of a structure assignment to a report of a stove fire in an apartment unit on Maureen Dr. Upon arrival, GE2 reported a two story apartment building with light smoke showing and numerous residents evacuating. GE2 went into the investigative mode and found an apartment unit at the rear of the complex that was charged with light to moderate smoke. Fire could be seen in the kitchen while standing at the front door. GE2 established Maureen IC while GE2's firefighters were assigned Fire Attack and pulled the rear 200' 2.5" preconnect and a 100' hose pack to the apartment. The apartment flashed as they were setting up the attack line and created an environment too hot to enter initially. AE6 arrived on scene and was assigned Fire Attack Group Leader. AE4 was assigned Division 2 and AT6 along with GLF1 were assigned Vent Group. GB1 assumed IC and reassigned GE2 to Division 1.

The fire was quickly knocked down and contained to the unit of origin. Adjoining units were checked for extension and found to have smoke contamination. In all, 6 units were uninhabitable mostly due to smoke migration. 22 adults and 6 children were displaced. Red cross was on scene and handled the displaced residents.

Investigator Weiss determined that the fire's origin was the stove top, and the fire was caused by an electric burner being left on with a pan of oil on top of it that was used to fry chicken earlier in the evening.

The fire was thoroughly overhauled. The building owner's representative, Belinda Kay Mellot (714-474-3313) was provided a Property Release form. Hazards of the fire xcene were explained to her and residents. She had made arrangements with a board up company to secure the building.

Power was restored to unaffected units and the occupants of those units were allowed to return.
