## Fire/Structure

GE26 arrived on scene to find smoke showing from a three story apartment. GE26 investigated, and found fire in a common laundry room. GE26 pulled a preconnected hoseline, and initiated fire attack and confirmed there were no residents inside. A working structure fire was requested by GE26. GE26 and supporting crews evacuated the first floor of the building involved, and checked the floors above the fire floor to evacuate and confirm there was no fire extension. Crews used a mechanical fan to evacuate smoke from the first and second floors.

While attacking the initial fire, other fire crews on scene found two additional and separate fires in the apartment complex. Fire fighters confined and extinguished the additional fires. A GGFD fire investigator was requested.
