This Amendment No. 3 to Furnish all Labor, Materials, Equipment, and Traffic Control for Arborist Services, including Emergency Services, at Various Locations in the City of Garden Grove is made and entered into this 7th day of August 2019, by and between the CITY OF GARDEN GROVE, hereinafter referred to as "CITY", and West Coast Arborists, Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, Contractor and CITY entered into Contract No. 154933 effective July 1, 2016.

WHEREAS, Contractor and CITY desire to amend the Existing Contract as provided herein.

Now, therefore, it is mutually agreed, by and between the parties as follows:

Section 1: Term and Termination, shall be revised as follows:

The CITY hereby extends the performance period from July 1, 2019 to June 30, 2020.

Section 3: Compensation - shall be revised as follows:

The contract Price is hereby increased from \$1,070,000.00 to a new Firm Fixed Price of \$1,360,000.00. This is an increase of \$290,000.00 to cover the third option.

Except as expressly amended hereby, the Existing Contract remains in full force and effect as originally executed.


