Notice is hereby given that sealed bids to furnish material, equipment, and labor for Project No. 7840 "SEWER SYSTEM REHABILITATION PLAN PHASE 1 SEWER MAIN REPLACEMENT PROJECT 1," will be received at the City Clerk's Office, City Hall, 11222 Acacia Parkway, Garden Grove, CA 92840. Engineer's estimate on this project is around \$3,707,220 dollars.

The project consists of constructing new replacement sewer lines; and abandonment or removal and disposal of existing sewer lines. The improvements include approximately 5,440 feet of 8-inch diameter and 1,290 feet of 12-inch diameter extra strength Vitrified Clay Pipe (VCP), 27 new manholes, modifications to 4 existing manholes, and 124 sewer house connections. Project includes replacing sections of existing asbestos cement pipe water mains with PVC C-900 DR-14 pipe sections at several locations. Project also entails sections of full-depth pavement reconstruction and slurry sealing. The sewer lines will be constructed at various locations throughout the city and the work will be completed in three phases.

The entire project will also require maintaining the existing sewer flows during construction through temporary bypass operations, replacement of existing sewer manholes and their connected pipes, reconnection and/or reconstruction of sewer house connections, abandonment and/or removal of the existing sewer lines and manholes, replacement of existing water line sections for sewer crossings, temporary traffic control, pavement replacement and resurfacing, replacement of traffic loop detectors, replacement of traffic striping/markings and pavement markers and all other appurtenant work.

The plans, specifications and contract documents may be purchased from ARC for the price of one hundred nineteen dollars and sixty-three cents (\$119.63).
