RE: Public Records Act Request- Economic Statements

Dear Clerk of the Council:

Pursuant to the California Public Records Act, Government Code Sections 6250, et seq., we request that you make available to us, within ten (10) days, for our review and copy the public records in the possession, custody, or control of the City of Garden Grove as described below. It is our desire to secure these records with as little burden as possible on you and other City staff; accordingly, please do not hesitate to contact us if there are alternative ways of securing the requested information in a more streamlined fashion.

Definitions Used in this Request:

Regarding the following requests, we have provided the following definitions to specify as clearly as possible the nature of each request:

“The City” refers to the City of Garden Grove and includes all of its officers, agents, and departments, including without limitation, the Garden Grove City Council and Mayor, as well as all Garden Grove City agencies, commissions, and committees.

“Records” and “Documents” refers to the following: All “writings” as defined in Section 250 of the California Evidence Code, namely “handwriting, typewriting, printing, Photostating, photographing, photocopying, transmitting by electronic mail or facsimile, and every other means of recording any tangible thing, any form of communication or representation, including letters, words, pictures, sounds, or symbols, or combinations thereof, and any record thereby created, regardless of the manner in which the record has been stored.”

“SEI” refers to Statement of Economic Interest, Form 700 also known as a Conflict of Interest Statement, a public document which public officials and certain designated city employees, including consultants and certain appointed board and commission members use to disclose certain financial interests.

Requests:

1. All Records and Documents that pertain to the Garden Grove City Council Members’ Statement of Economic Interest or “SEI” as follows:
 - a. Mayor Steve Jones’ SEI statements between November 2007 to present
 - b. Mayor Pro Tem Kim Nguyen’s SEI statements between November 2016 to present.

- c. Councilmember George S. Brietigam III's SEI statements between November 2018 to present
- d. Councilmember John R. O'Neill's SEI statements between November 2016 to present.
- e. Councilmember Diedre Thu-Ha Nguyen's SEI statements between November 2016 to present.
- f. Councilmember Patrick Phat Bui's SEI statements between November 2016 to present.
- g. Councilmember Stephanie Klopfenstein's SEI statements between November 2016 to present.

Pursuant to the Public Records Act, please provide us with all of the following Records:

We have attempted to be as specific as we can to designate the public records as requested without the need to access the records themselves. If you find any of these requests insufficiently focused, we request that you provide the assistance required by Government Code Section 6253.1, including "assisting the member of the public to identify records and information that are responsive to the request or the purpose of the request."

If you believe any portion of the information we have requested is exempt from disclosure by express provision of the law, Government Code Section 6253(a) additionally requires that you segregate or delete the exempted material and release the remainder of the information. Please make the information requested available for our review before charging us for copies. Where the information is contained in electronic databases, we request you provide such information in electronic form, pursuant to Government Code Section 6253.9.
