This Amendment No. 1 to Furnish all Labor, Materials and Equipment to Provide Landscape Maintenance Services for the City of Garden Grove is made and entered into this 15<sup>th</sup> day of August 2019, by and between the **CITY OF GARDEN GROVE**, hereinafter referred to as "CITY", and **Parkwood Landscape Maintenance, Inc.**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Contractor and CITY entered into Contract No. **159385** effective **November 27, 2018**.

WHEREAS, Contractor and CITY desire to amend the Existing Contract as provided herein.

Now, therefore, it is mutually agreed, by and between the parties as follows:

Section 1: Term and Termination, shall be revised as follows:

The CITY hereby extends the performance period from July 1, 2019 through June 30, 2020.

Section 3: Compensation - shall be revised as follows:

The contract Price is hereby increased from \$153,264.00 to a new Firm Fixed Price of \$312,305.00. This is an increase of \$159,041.00 to cover the first option year.

Except as expressly amended hereby, the Existing Contract remains in full force and effect as originally executed.


