This Amendment No. 4 to Furnish all Labor, Materials and Equipment to Provide Landscape Maintenance Services for the City of Garden Grove is made and entered into this 2nd day of August 2022, by and between the **CITY OF GARDEN GROVE**, hereinafter referred to as "CITY", and **Parkwood Landscape Maintenance, Inc.**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Contractor and CITY entered into Contract No. **B159385** effective **November 27, 2018**.

WHEREAS, Contractor and CITY desire to amend the Existing Contract as provided herein.

Now, therefore, it is mutually agreed, by and between the parties as follows:

Section 1: Term and Termination, shall be revised as follows:

The CITY hereby extends the performance period through June 30, 2023.

Section 3: Compensation - shall be revised as follows:

The contract price is hereby increased by \$174,597.00 for the above term of the contract only to cover the final option year.

Except as expressly amended hereby, the Existing Contract remains in full force and effect as originally executed.
