AMENDMENT NO. 1

This Amendment No. 1 is made and entered into this 26th day of April, 2022, by and between the **CITY OF GARDEN GROVE**, hereinafter referred to as "CITY", and **SCOTT FAZEKAS & ASSOCIATES, INC.** hereinafter referred to as "CONTRACTOR".

WHEREAS, CONTRACTOR and CITY entered into Contract No.B220293, dated **September 28, 2021** for On-Call Building Plan Review Services, as needed (the "Existing Contract").

WHEREAS, CONTRACTOR and CITY desire to amend the Existing Contract as provided herein.

Now, therefore, it is mutually agreed, by and between the parties as follows:

Section 3.1., COMPENSATION - shall be amended as follows:

Contractor shall be compensated in accordance with the Rate and Services Structure set forth in Attachment "A" of the Existing Contract. The contract price is hereby increased by **\$250,000.00**, for a total not to exceed compensation amount of \$500,000.00 to cover increased services requested by CITY.

Except as expressly amended hereby, all of the terms and conditions in the Existing Contract remain in full force and effect as originally executed.
