Notice is hereby given that sealed bids for providing material, equipment, and labor for Project No. CP1310000 "LAMPSON AVENUE / SPRINGDALE STREET SEWER IMPROVEMENTS PROJECT" will be received by the Garden Grove City Clerk's Office. The Garden Grove City Hall lobby is temporarily closed for construction therefore, bids delivered in-person will be received at the temporary City services building lobby located at 12860 Euclid Street, Garden Grove, CA 92840; call the City Clerk's Office at 714-741-5040 upon arrival. If submitting by mail, send to City of Garden Grove, City Clerk's Office, 11222 Acacia Parkway, Garden Grove, CA 92840.

The project consists of constructing approximately 1,440 feet of 10-inch diameter SDR21 Polyvinyl Chloride (PVC) new sewer system in Lampson Avenue and Springdale Street from Springdale Street to Lamplighter Street. It includes the construction of; a) core-drill at a DISTRICT's existing sewer manhole on Springdale Street just north of Lenore Avenue for connection of the new sewer system in order to convey the DISTRICT sewage to the Orange County Sanitation District's Miller-Holder Trunk Sewer system; b) seven (7) new DISTRICT sewer manholes on Springdale Street and Lampson Avenue, and; c) removal and construction of one (1) existing DISTRICT sewer manhole at the intersection of Lampson Avenue and Lamplighter Street for reconnection to the existing DISTRICT's sewer system. This sewer project shall be completed within one hundred fifty (150) calendar days from notice to proceed. The project will also require (but not limited to): protecting existing utilities; coordination with utility owners, shoring, dewatering, maintaining the existing sewer flows during construction, removal of the conflicting sewer lines and manholes, traffic control, pavement resurfacing, slurry seal pavement as required, traffic restriping, replacement of traffic loop detectors and installation of raised pavement markers and appurtenant work. High groundwater is prevalent in the area of the work and will be encountered during the construction of the improvements included in this project. The Contractor shall include in their bid, provisions for dewatering. Engineer's estimate on this project is around \$2,074,000 dollars.

A pre-bid meeting is scheduled for 10:00 a.m. Wednesday, July 6, 2022. The purpose of the pre-bid meeting will be to discuss objectives and requirements of the work and other items deemed necessary pertaining to the project. The pre-bid meeting will be held via Zoom meeting. Contractors who are interested in submitting a bid shall register for the meeting by 10:00 a.m. Thursday, June 30, 2022, by sending an email to lijn@ggcity.org.
