Hello Greg,

Thank you for your email and the note from City Manager Lisa Kim, dated 12/20/21. I would like to clarify a statement included in that letter that TPL's initial offer is no longer valid. This is not a correct interpretation of our discussion on December 8th. What Alex and I stated at that time was that we want to return to Garden Grove in the subsequent weeks with the City of Santa Ana also at the table to continue negotiations. We intend to build off what we have submitted to the City of Garden Grove previously with a new public partner/acquiring agency at the table.

To that point, we continue to have positive discussions with Mayor Sarmiento and will be meeting with City Manager Kristine Ridge and Assemblymember Daly's office in the new year to help further structure our proposal. We will not have a proposal by January 10<sup>th</sup>, but look forward to responding to you in a more formal manner in the early part of February.
