INTRODUCTION The City may, from time to time, decide to install permanent outdoor monuments on City property to provide the City's commemoration of persons or events of note, or to otherwise convey the City's position on various topics (referred to as "Government Speech"). By placing monuments on City property, the City intends only to engage in government speech and does not intend to open a public forum for free speech activity. The purpose of this Policy is to establish criteria and guidelines for the consideration and installation of monuments outdoors in parks or plazas deemed by the City to be appropriate to serve as the site for a monument. In doing so, the City recognizes the following considerations: ✦ Monuments can convey a powerful connection between Garden Grove and its history, and in some instances its future. ✦ It is therefore important that the placement of monuments be limited to circumstances of the highest community-wide importance, both to maintain the significance of such monuments and to minimize conflicts with the active and variable use of public spaces. Notwithstanding the foregoing, the City may decide, in its sole discretion, to reject a proposal for a monument and/or may determine the appropriate site for any and all City monuments.

Additional Review Process if a Monument is Primarily an Original "Work of Art" The Community Services Director shall recommend and advise the City Manager, whether a proposed monument is primarily an original "work of art". A "work of art" is defined as a monument that is designed by and crafted by or under the supervision of a professional artist. A monument that is deemed primarily a "work of art" shall be considered "public art" and shall become part of the City's Art in Public Places inventory. For monuments determined to be primarily "public art," the Community Services Department shall:

NAMES - (Priority #1) A. The name should reflect a recognizable area, neighborhood, street, or school in the community. 1. The name should aid a person finding the park and should relate to the location name. 2. When parks are adjacent to schools, or are a part of the school property, the park does not necessarily take on the school name. In some cases, however, it may be to an advantage to continue with the same name in order to aid in its location. B. Avoid the use of assumed names. 1. A park should be named previous to acquisition or immediately thereafter in order to avoid being named after an assumed name, which may not meet the criteria for the permanent park name. 2. Continuing with assumed names often leads to difficulty in changing the name which more properly meets the criteria for the permanent name. C. Naming parks with horticultural type names. 1. Horticultural type names or features should be encouraged for park naming. Names such as Ferndale, Woodland, Forest, etc., often provide good names for park areas. 2. This type of name should be consistent with the horticultural appearance of the park so as to have some logical relationship to the

Dear Councilmembers:

The undersigned legal services organizations write to urge you to protect your most vulnerable residents and request that the County Board of Supervisors ask the Orange County Sheriff's Department suspend the pending 185 evictions that were set to start June 1, 2020 for the duration of the State of Emergency relating to COVID-19 and an additional thirty days following the termination of the State of Emergency. California remains in a state of emergency due to the COVID-19 pandemic, and the number have grown substantially, with more than two million cases nationwide. The County of Orange recently reported approximately 10,595 cumulative cases of COVID-19, 175 active cases, and 269 deaths from COVID-19.¹ Despite efforts to reopen and relax rules governing the face coverings in public, the increase in cases and deaths, should cause the City of Garden Grove pause, especially in light of those who are amid eviction and at risk of homelessness. The City must not countenance a result.

Our organization provides critical legal services to low-income communities, which includes, but is not limited to, tenant counseling and eviction defense and we each advocate for the rights of low-income tenants. We serve clients and communities to ensure equal access to the justice system for people who could not otherwise afford attorneys.

In previous correspondence with the Board of Supervisors, we explained that suspending the enforcement of eviction orders is not only critical for protecting public health, but that it is within the powers of the Board of Supervisors to do so.² Suspending the enforcement of eviction orders will ensure that families do not become homeless when they are legally required to shelter in place and will reduce the risk of exposure for your deputies. In Orange County, there are already close to 7,000 unsheltered individuals.³

On April 6, 2020, the Judicial Council adopted a rule that effectively stays all eviction proceedings and judicial foreclosure proceedings throughout the State of California and continues all eviction trials, for a period

extending after the end of the State of Emergency. The rule applies regardless of the reason for the eviction. On June 10, 2020, the Chief Justice of the California Supreme Court suspended a planned vote to repeal the emergency rule after August 3, 2020.⁴ Accordingly, the emergency rules related to evictions and judicial foreclosures are still in effect.

The Judicial Council's emergency rules and the heightening public crisis arising out of the COVID-19 pandemic protect Californians from eviction for newly filed and pending actions, but leaves unresolved the status of people against whom a court had already issued an eviction order. The fate of these households is in your hands, and they are just as in need of protection from the public health crisis as the households who will be protected by the Judicial Council's rule.

Accordingly, we urgently request that you agree to suspend enforcement of any and all pending eviction orders, unless they are directly related to a protective order (e.g., a TRO issued by a court related to domestic violence and/or elder dependent abuse), during the State of Emergency and at least ninety days thereafter.

It's come to my attention that Councilman Bui wishes to discuss sending a letter from the city of Garden Grove opposing the passage of ACA 5. As a citizen of Garden Grove, I strongly resent that, and urge the mayor and the council members to send no such letter.

In addressing the council, I'd like to set aside the issue of affirmative action, and instead focus on what exactly this letter would mean. ACA 5 has passed the assembly at this stage—and that's it. It still has to pass the state senate. And if it passes the state senate, what then? It simply goes onto the ballot in November so that the voters of California can decide if the language of Proposition 209 should be repealed.

In effect, this letter would, I guess, be intended for the state senate, to urge them not to allow the voters of California to decide whether or not to effectively repeal Proposition 209—a proposition that passed 24 years ago.

I can honestly think of nothing less important to the city of Garden Grove than drafting a letter that likely will have no influence on the state senate, and will do nothing but demonstrate to anyone who reads it that either (a) we don't want Californians to vote on key issues that affect Californians, or (b) we, as a city, have absolutely no understanding of how our state government operates. This doesn't seem like the best use of the city's time.

In essence, I am asking this: Don't embarrass our city. We already have an electrical box that reads "Know Blue Lives Matter" tarnishing the corner of Knott and Chapman. RE: Garden Grove Needs to Reallocate Funding from Police to Invest in Local Communities, and Support Affirmative Action

Dear Mayor Steve Jones and Councilmembers of Garden Grove,

VietRISE unequivocally supports the Garden Grove High School Black Student Union's call to reallocate \$30 million of Garden Grove's police budget to support local businesses, low income families, health services, housing and education. We urge the city to proactively enact policy to make Black communities and all marginalized communities in Garden Grove feel safer by defunding the police department's current funding allocation in the proposed 2020-2021 FY budget and reallocating it to other community services that will directly benefit and improve the lives of residents.

Our organization is committed to dismantling systems of white supremacy and ending the criminalization of immigrants. Local policing and law enforcement are often the first point of contact where immigrants are sent to the prison-to-deportation pipeline, and Black immigrants constitute 20% of those facing deportation despite making up only 7% of non-citizens in the U.S., according to the State of Black Immigrants report. Garden Grove police has its own history of harming residents, through racial profiling, aggressive and violent practices, and abuse of power through city-funded equipment and technology.

In order for our communities to feel safe and restore public trust in government, the city must take action to codify protections for the wellbeing of their residents. Currently, the city of Garden Grove faces a budget deficit while residents continue to experience health and economic hardship due to COVID-19. According to the GGHS BSU's petition,

"Each year, the city of Garden Grove continues to increase its spending on the police budget by millions, while decreasing the money directly spent on community services. Over a two-year period of increased funding, the Garden Grove police's use of force incidentally increased by an unacceptable 250%. The city has already projected a budget deficit of \$5.2 million for FY 2020-21. During this period of financial uncertainty, we cannot provide more funds to the police department when small businesses and families are vulnerable."

Defunding the police department and reinvesting money into community services is one of many steps that local elected officials should take to address systemic violence against Black communities. This is an opportunity for Garden Grove to be part of that change. We urge you to agendize the immediate revision of the Community Services and Community and Economic Development budget to absorb funds from the Police Department budget to reinvest in our communities through education, health, housing, and small business services for the 2020-2021 FY budget.

Lastly, on the topic of affirmative action: according to disaggregated data provided by Asian Americans Advancing Justice in their South East Asian American Journeys Report (2020), Vietnamese students and families would benefit greatly from affirmative action. 43% of Vietnamese residents in California have a high school diploma, 30% have a BA or higher, 20% are low-income and/or experiencing poverty, and 50% have limited-English proficiency, the highest in the state of CA. Furthermore, the passage of Proposition 209 in 1996 harmed women and communities of color the most for the past two decades. For example, Black and Latino students admitted to the University of California decreased between 12 and 60 percent since it passed, and women in California make on average 80 cents for every dollar a man is paid; for women of color and single moms, that amount decreases to 60 cents per dollar.

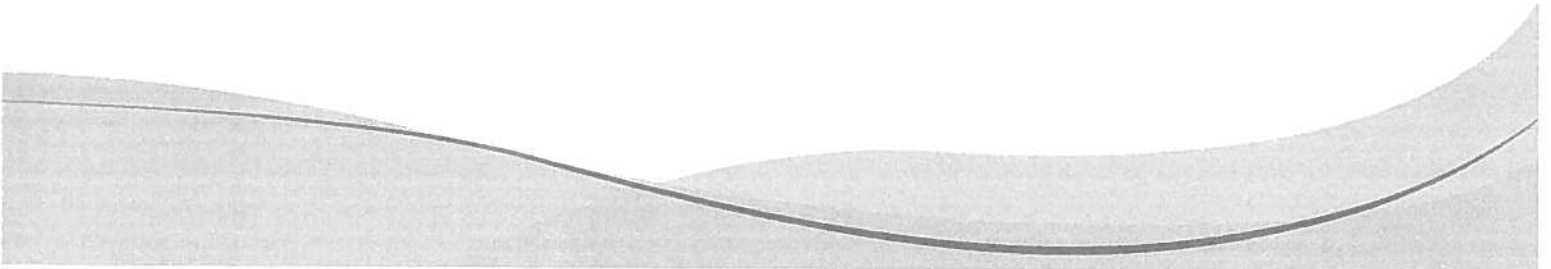

It has come to my attention that there is an effort to defund the Garden Grove Police Department. While well-intended, it may be based somewhat on several foundational misconceptions. Please allow me to clarify a few.

One misconception is that the school district and its funding and resources are intertwined with the City and Police Department-they are not, they are entirely separate. The Garden Grove Unified School District is a completely different and autonomous entity from the City/ Police Department (yes, there have been joint partnerships such as officers on campus, and programs that incorporated cost-sharing such as the DARE to empower children but neither have implications for the other). Additionally, whereas the city of Garden Grove currently serves its communities with a variety of CDBG, ESG, and other funds for housing, medical/dental programs, senior programs, youth programs, homelessness programs, etc., these monies are not allowed by law to go to the police department.

Another misconception is that GGPD does not team with mental health professionals - they do and have so for many years. They have highly trained and experienced Orange County mental health clinicians riding with patrol officers to more intimately serve residents with mental health challenges. After the initial response, it is common for the mental health clinician to follow-up numerous times with the clients and make sure they are receiving the resources that they were connected with during the initial response.

And, when the public needs help for a mental health related issue and would rather have a mental health clinician come to them without an officer accompanying them, an alternative already exists, they may call the county's CAT (Centralized Assessment Team) directly.

Additionally, in service to those with mental health challenges and homelessness challenges, for several years, the Garden Grove Police Department has had a Special Resource Team that is highly acclaimed.

Another misconception is of the amount of training they receive, the standards they adhere to, and the oversight that they are subject to - it is remarkable. Police officers are subject to a myriad of requirements and checks and balances to hold them accountable to the best policing practices:

First of all, GGPD is mandated by state law to comply with the California State oversight agency, POST (Peace Officers Standards and Training).

Beyond that, for decades, the Garden Grove Police Department has been accredited by CALEA (Commission on Accreditation of Law Enforcement Agencies) which is a nationally recognized organization confirming its members compliance to the highest standards with a vast number of requirements for police service. Most police departments do not choose to go to the expense and work to comply with these rigorous demands and earn this prestigious accreditation.

Officers receive hundreds of hours of training including that which addresses communication skills, community relations, sensitivity training, and critical incident handling. The academies

are six months long, 40 plus hours per week. After the academy, they receive over 80 hours of training specific to Garden Grove. They then begin their field training phases which consist of four 4-week blocks of training with a certified field training officer who is a veteran of the department and completed 80 hours of formalized study in being a training officer as well as periodic meetings/training and supervision from the department's Professional Standards Division as well as patrol supervisors and management. During these months riding with a Field Training Officer, officers are evaluated daily on their performance with the community as well as being given written and simulated performance tests. After successful completion of this, once on their own, the officer is evaluated weekly. For the remainder of their 18 month 'probationary' period, they may be relieved of duty for no stated reason and the officer has no legal recourse to contest the termination due to state law that was implemented to allow police departments to weed themselves of unacceptable officers and not fear a costly lawsuit. After that 18 months period, officers are given bi-annual evaluations of overall performance, and event-driven critiques of performance after every substantial call. There are general orders in place for the presence of supervisors and notification of watch commanders and command staff, as well as mandates for medical attention/paramedics/ambulance response. Continual training to refresh perishable skills and training to address new issues in all aspects of their job are also mandated by law.

Police reports have a review process including being reviewed by supervisors, records bureau personnel, and detectives. If there is an arrest involved for prosecution, the report is forwarded to and examined by the Orange County District Attorney's Office who is hyper-sensitive to adherence to laws such as search and seizure, as well as use of force. The District Attorney's Office also has a 24/7-365 response team that comes to the scene of incidents resulting in serious injury. The police department has its own "Use of Force Review Board" empaneled for any use of force including deployment of tasers, batons, pepper spray (they do not use tear gas), etc., as well as protocols for internal affairs investigations. Officers are trained regularly on the use of these devices by personnel who themselves endured weeks of arduous training to train others. An officer's work also has constant judicial oversight as cases come before the bench, and oversight is conducted by legislative bodies that are also constantly examining and refining codes and procedures.

Another misconception is the amount of service they provide - it is extraordinary:

The city of Garden Grove and it's a police department have fallen victim to the California state legislature's continued support of criminal activity via Propositions 47 and 57 where in criminal sentences are much lighter and penalties for substance abuse and it's related behavior are not punished. The potential for crime has never been greater with countless more violent felons including child molesters and rapists out and on the street due to legislation from Sacramento.

The Garden Grove Police Department has one of the lowest number of officers per capita ratio in the nation, a remarkably high number of calls for service handled per its number of officers, and an extraordinarily low percentage of complaints while serving a diverse, multicultural, multi-economic level suburban/urban population. 61% of GG residents are low income and this is the portion of the community that will disproportionately suffer the most if it's police department is defunded.

It should be noted that many of the demands of certain groups at this juncture are already being met with trained social workers accompanying officers to better serve the community and the GGPd teaming with community-based organizations such as the Orange County Youth and Family Services. Contrary to misconception, they do not currently rehire officers who have been fired for incidents of excessive force nor are they involved with militarization programs nor do they pay for military exercises. Additionally there is a nationwide

misconception about the use of chokehold and stranglehold as they are not authorized; that has been illegal for several years.

Are all of the officers perfect, of course not, no one is, we all make mistakes from time to time. For them, they know it could cost them their careers or their lives.

While the argument is well-intended, elimination of any substantial percentage of the police department would be devastating to the residents, businesses, and visitors of GG serving only to strip them of their only instrument of peace and safety.

This is not to say that increase and innovation in all areas of service are not to be explored and implemented with partnership with schools and community organizations, however taking a large percentage from the police department will surely add to the problems in our communities and take away from the sense of order and safety that our children and communities enjoy.

It should be noted that the Garden Grove Police Officers receive training on biased-based policing and racial profiling while in the academy, as it is required by the California Peace Officers Standards and Training (POST), and participate in re-training every five years under the California PC 13519.4(a). Several of our officers are POST certified facilitators on these topics.

Additionally, all Officers receive annual training on biased-based policing and racial profiling and bi-annual training in the areas of tactical communication (de-escalation), ethics, and arrest and control techniques as required by POST. City Police Officers are already required to take training through POST which covers topics similar to "implicit bias,"

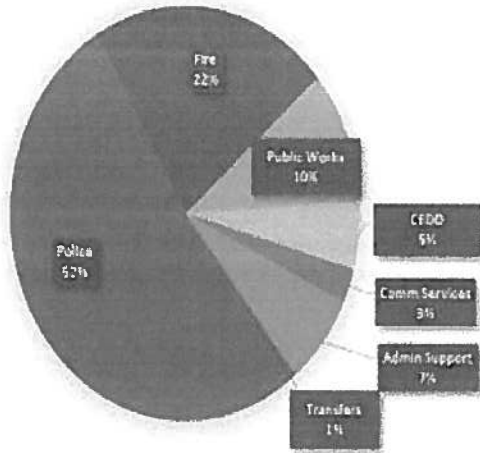
"This is important to me as a resident of Garden Grove because... during this period of financial uncertainty, we cannot provide more funds to the police department when small businesses and families are vulnerable."

If one does not like the notion of having "small businesses and families vulnerable", then one must agree that we need law enforcement and police department to do it.

Here are the questions that are on this particular link and my answers/opinions/comments are in green:

- Garden Grove's budget for the fiscal year 2020-2021 allocates \$67,738,400, which is roughly 51% of our General Fund, and it increased to 52% in the last Proposed Budget Amendment. Why? **Crime is up thanks to Gov. Newsom and his "sanctuary state" and release of criminals onto our streets policies.**
- Garden Grove's budget for fiscal year 2020-2021 made deductions to Temp/Seasonal Staffing Level and Recreation Programs (\$210K). Why? **Temporary/Seasonal Staffing is just that, Temporary and Seasonal.**
- Garden Grove actually raised the police budget by \$600,000 in the Proposed Budget Amendment on June 9, 2020. Why? **The answer to this question can be found in the minutes, staff report(s) and replay of the June 09, 2020 council meeting.**
- Garden Grove's budget for fiscal year 2020-2021 made reductions to Training & Conferences by 30% (\$58K). Why? **I would think for health, safety and fiscal reasons related to the Covid-19 issue, for starters.**

- Where are the programs to help keep our youth out of prison? **The best program to address this question is called the "mom & dad teach your children to obey the law and behave in public" program. Some folks out there should try it and best of all, it is free.**
- Where are the programs to prevent poverty and homelessness? **I'd suggest stay in school, get an education, learn a trade, get a job, avoid using illegal drugs and don't commit any crime(s).**
- How much have you invested into the prevention of crime? **I'd say approximately \$67.7 million, I found that figure in the chart below.**
- How many of you are funded by Police Unions/PACS? **If by "you", you mean council members, see the email below dated 6/19/20.**
