### **ALLEGATION OF PERJURY AND FALSIFYING PUBLIC RECORDS**

Per the city clerk's office on 10/30/2020, Steve Jones 2020 Nomination Paper information is the exact same his 2016 Nomination Paper information regarding his address:

**“11542 Montclair Drive, Candidate's residence address” which in not in WGG.**





**(California Penal Code 115. (a) Every person who knowingly procures or offers any false or forged instrument to be filed, registered, or recorded in any public office within this state, which instrument, if genuine, might be filed, registered, or recorded under any law of this state or of the United States, is guilty of a felony.)**

**(California Penal Code 118. (a) Every person who, having taken an oath that he or she will testify, declare, depose, or certify truly before any competent tribunal, officer, or person, in any of the cases in which the oath may by law of the State of California be administered, willfully and contrary to the oath, states as true any material matter which he or she knows to be false, and every person who testifies, declares, deposes, or certifies under penalty of perjury in any of the cases in which the testimony, declarations, depositions, or certification is permitted by law of the State of California under penalty of perjury and willfully states as true any material matter which he or she knows to be false, is guilty of perjury.)**

And here is what the County of Orange has to say about the homeowner tax exemption and their requirements for same:

**What is a Homeowners' Exemption?**

A Homeowners' Exemption could save you at least \$70 per year.

**If you own and occupy your principal place of residence on January 1, you may apply for a Homeowners' Exemption that will exempt \$7,000 of your home's assessed value from taxation.**

**If I move out and rent my house to someone else, am I still eligible for the exemption?**

**No. If you do not own and occupy your home as your principal place of residence, you must cancel your Homeowners' Exemption. You can cancel the exemption by writing to our office or using the termination form included with your property tax bill. Please let us know the date you moved and provide your new mailing address.**

(26 U.S. Code § 7206(B) - Fraud and false statements)

(California Penal Code 182. (a) If two or more persons conspire: (1) To commit any crime.)

## **ALLEGATION OF VOTER FRAUD**

It is our understanding that in the Orange County Registrar of Voters data base, Steve Jones' voter registration address is **11542 Montclair Court, Garden Grove, CA 92841**, which is not in WGG.



**(California Elections Code section 18100(a): Registering yourself or another knowing that you or that person is not entitled to register.)**

The above is very concerning because if the allegations turn out to be true, then this would not be the first time that Steve Jones has been accused of falsifying a public record/document as noted in a 1994 California Department of Real Estate record.

The Decision suspends or revokes one or more real estate licenses on grounds of conviction of a crime and knowingly making a false statement of fact required to be revealed in an application for license.

**(See attached H-1714SA Sep. 1994)**

While on the subject of real estate, it also appears that in 2005, Steve Jones participated in setting in motion his potential ability (by use of his position and perhaps his future positions) for immediate and/or future potential pecuniary gain. Many of us citizens in Garden Grove wonder if this is by design or pure luck and coincidence that the Olympia Capital Corporation happens to be

benefiting in the management of so many developed housing projects here in Garden Grove and in the surrounding areas.

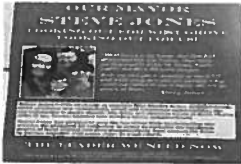

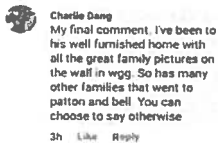
