REQUIREMENTS FOR INFLATABLE JUMP HOUSES ALLOWED AT CYC ONLY ATTACHMENT A

- A \$25 permit fee is required for any inflatable rental at the City of Garden Grove Courtyard Center (CYC). Inflatables are not allowed at the Community Meeting Center.
- Only vendors that have provided the proper liability insurance certificates may supply this equipment; these companies are available on the provided City-approved list on the back of this Appendix.
- Inflatable companies are responsible for renting or providing a generator for your party;
 no electricity outlets are available to power inflatables.
- Only one (1) small inflatable bounce house (18'x18'x18' max) is allowed per group.
- Inflatables are to be set up only by the rental company, in compliance with manufacturer specifications.
- Inflatables must be under adult supervision at all times. Supervising adults are responsible for insuring that use is in compliance with manufacturer's recommendations and reflects safe levels of operation.
- Inflatables must be free standing and weighted. Stakes are prohibited in City parks, unless approved in writing by the City as a special condition. Inflatable must not be tied or tethered to trees, tables, or other park amenities.
- No water slides permitted.
- The City of Garden Grove is not responsible for any damage to the inflatable.
- Certain parks require a specific location for inflatable bounce houses. Please refer to the approved list of vendors for parks and locations.

A signature indicates an agreement to uphold these regulations as well as an acknowledgement that a **failure to do so could result in a loss of security deposit or a citation.**
