## PUBLIC COMMUNICATIONS

Mr. Michael Hurley of 12221 Dunklee Drive approached the Commission and asked about contacting Code Enforcement for issues that occur on weekends such as yard sales. Ms. Allison Mills explained to Mr. Hurley that he can contact the Code Enforcement hotline or officer of the day, and that a code volunteer can document weekend code issues.

#### STAFF COMMUNICATIONS

#### Introduction of Code Officers

Ms. Allison Mills introduced the Code Enforcement Officers in attendance, and stated the years of code enforcement experience of each officer.

## Code Enforcement Presentation

Ms. Mills gave a power point presentation explaining the code enforcement abatement process, including the duties and areas of responsibilities of the city's code enforcement officers. Also included in the presentation was a detailed explanation of what constitutes residential and commercial violations that the code enforcement officers have the authority to process for abatement.

## Second Quarter Code Enforcement Report

Ms. Mills provided the Code Enforcement Quarterly Report that tracks complaints and activities.

## Review of CAPER

The CAPER report was provided to the Commission for the purpose of transmission to City Council. Ms. Allison Mills noted the addition of the Fair Housing section of the CAPER report provided to the Commission. This report shows the accomplishments and goals of the action plan with the HUD funds for the fiscal year July 1, 2004 through June 30, 2005.

Vice Chair Brietigam moved to transmit the CAPER report to City Council, seconded by Commissioner Dina Nguyen. The motion carried with the following vote:

### Update of Grants and Loans

Ms. Mills provided an update on the number of grants and loans being processed as follows: 21 senior grants approved and nine applications pending, five mobile home grants with eight applications pending, and 13 applications for home rehab loans. CDBG funds the senior home improvement grants and the mobile home improvement grants. Rehab loans are funded with set aside money.

Vice Chair Brietigam asked about the eligibility criteria for the senior home improvement grant. Ms. Mills explained that senior home improvement grants for owner occupied homes are for the truly needy. Also, a city building inspector inspects the property to verify that the repairs are necessary. The improvements are primarily for external repair, and only internal repairs are approved for serious safety issues.

Commissioner Dina Nguyen questioned whether the first time homebuyer loan can be used to purchase a mobile home, noting that with the high cost of housing, it is difficult for many to qualify for a single family home. Ms. Mills stated that she would get that information for her.

## Green Home – Energy Efficient Affordable Housing Seminar

Ms. Mills noted that Commissioner Diaz was the only commissioner who attended the seminar.
