PUBLIC HEARING:SITE PLAN NO. SP-459-11APPLICANT:PETER PARKLOCATION:NORTHWEST CORNER OF GARDEN GROVE BOULEVARD AND DALE STREET
AT 8471 GARDEN GROVE BOULEVARDDATE:FEBRUARY 17, 2011

REQUEST: To construct a two-story, 2,475 square foot office building, in conjunction with the reconfiguration of the existing parking lot, on a lot improved with an existing one-story, 2,068 square foot office building. The site is in the C-2 (Community Commercial) zone.

Staff report was read and recommended approval.

Commissioner Bonikowski asked if the bus stop would be moved. Staff responded that OCTA had reviewed and approved the project plans and had sent back a new bus pad location with new dimensions and that the property owner would be responsible for moving the signs.

Chair Beard asked if there were concerns or questions from nearby residents. Staff replied no; that the intended use is to be an office building; that there are currently eleven parking spaces; that the parking lot would be re-striped; and that three of the parking spaces would be more difficult to maneuver in than others.

Commissioner Pak made a suggestion that the three spaces could be reserved for employees.

Chair Beard opened the public hearing to receive testimony in favor of or in opposition to the request.

Mr. Peter Park, the applicant, approached the Commission.

Chair Beard asked the applicant if he had read and agreed with the conditions of approval. Mr. Park replied yes.

Vice Chair Bui questioned the closure of the entrance/exit gates after 6:00 p.m.

Mr. Park responded that the gates are closed for security purposes.

Commissioner Pak added that securing the property is a general practice in the Korean community, in order to deter people from parking in the lot.

Chair Beard asked the applicant if he had any tenants yet. The applicant replied no.

Commissioner Pak commented that the Garden Grove Mixed Use workshop on February 15, 2011, indicated that several zones would be changed to include residential, commercial, and mixed-use opportunities and that the applicant could consider maximizing his land space with the proposed zoning.

There being no further comments, the public portion of the hearing was closed.

Commissioner Ellsworth commented that the project would bring in more business and be better than a gas station.

Chair Beard agreed that the project would be a good development in the area; that the parking was acceptable; and the drive-way positions were good.

Commissioner Ellsworth moved to approve Site Plan No. SP-459-11, seconded by Commissioner Pak, pursuant to the facts and reasons contained in Resolution No. 5734-11. The motion carried with the following vote:
