- Request: To expand an existing multi-tenant commercial building located within integrated retail center from 35,262 square feet to 36,918 square feet, in conjunction with Conditional Use Permit to establish a 36,918 square foot fitness center (Chuze Fitness) to include an indoor pool, cardio and weight training areas, work out rooms, child day care for patrons using the center, cinema work out room, tanning rooms, hydro massage rooms, and men's and women's locker and shower rooms.
