b. Open Streets 2020 Presentation - Jennifer Goddard-Nye

A preview of the event was presented to the Commission. The tentative date (due to Caltrans Grant-City waiting to get right-of-ways paved) is October 24, 2020 between the hours of 2-6. A draft map was presented to the Commission showing the route and closure. The event is focusing on "Pop UP" theme. Saturdays are better attended than Sundays. More information will be forthcoming. The City will handle all street closures and marketing.

6. Matters from Commissioners:

Trash issues: Trash cans overflowing on Main Street - at night, trash cans are not full but by next morning, they're overflowing. Possibly one of the businesses on the street is putting their empty liquor bottles in these trash cans, as reported by an anonymous person. Staff will notify Code Enforcement. Ric Lerma will forward the pictures to staff. Other complaints of businesses on the west side, more PD enforcement needed.

7. Matters from Staff:

Harris & Associates rates are going up. The contract will go up from \$3500 per year to \$4000 per year. The rates have not increased for 10 years. They provide the Engineer's report and all the legalese that goes along with filing the necessary documents that allow Main Street to collect their assessment fees.

The Commission would like to entertain paying from their assessment the seasonal banners that go up on Main Street.
