  - APPLICANT: AARON SWERDLOW FOR FESTIVAL MANAGEMENT CORPORATION IN TRUST FOR GARDEN GROVE 100, LLC
  - LOCATION: SOUTHWEST CORNER OF GARDEN GROVE BOULEVARD AND EUCLID STREET AT 11162 GARDEN GROVE BOULEVARD
