APPLICANT: RACHAS, INC.

- LOCATION: SOUTHWEST CORNER OF BROOKHURST STREET AND CHAPMAN AVENUE AT 12141 BROOKHURST STREET
- REQUEST: Site Plan approval to expand an existing multi-tenant commercial building located within an integrated retail center from 35,262 square feet to 36,918 square feet, in conjunction with a request for Conditional Use Permit approval to establish a 36,918 square foot fitness center (Chuze Fitness) to include an indoor pool, cardio and weight training areas, work out rooms, child day care for patrons using the center, cinema work out room, tanning rooms, hydro massage rooms, and men's and women's locker and shower rooms. The site is in the NMU (Neighborhood Mixed Use) zone.

STAFF RECOMMENDATION: Approve Site Plan No. SP-474-13 and Conditional Use Permit No. CUP-365-13, subject to the recommended conditions of approval.

C.2. CONDITIONAL USE PERMIT NO. CUP-366-13

APPLICANT: KIMBERLY MCMAKEN

- LOCATION: NORTH SIDE OF GARDEN GROVE BOULEVARD, EAST OF HOOVER STREET AT 7717-7721 GARDEN GROVE BOULEVARD
- REQUEST: To operate a 4,080 square foot cosmetology school, Evon Beauty College, within an existing multi-tenant shopping center, with courses in cosmetology, electrology, and massage therapy. The hours of operation will be Monday through Saturday from 9:00 a.m. to 7:00 p.m. The site is in the C-2 (Community Commercial) zone.

STAFF RECOMMENDATION: Approve Conditional Use Permit No. CUP-366-13, subject to the recommended conditions of approval.
