 - C.1. <u>SITE PLAN NO. SP-476-13</u> VARIANCE NO. V-201-13

APPLICANT: VINNIE TRAN LOCATION: NORTHEAST CORNER OF WESTMINSTER AVENUE AND TAFT STREET AT 10741 WESTMINSTER AVENUE REQUEST: Site Plan approval to demolish an existing 2,000 square foot vacant building, located at 10741 Westminster Avenue, and to construct a new 4,237 square foot medical office building along with all site improvements as shown on the submitted plans. Also, a request for Variance approval to deviate from the minimum 10'-0" rear setback, along the northerly property line, to construct a new medical office building within the required setback area. The site is in the C-1 (Neighborhood Commercial) zone.

STAFF RECOMMENDATION: Approve Site Plan No. SP-476-13 and Variance No. V-201-13, subject to the recommended conditions of approval.

C.2. <u>SITE PLAN NO. SP-477-13</u> CONDITIONAL USE PERMIT NO. CUP-372-13

APPLICANT: R & M PACIFIC RIM

- LOCATION: NORTHWEST CORNER OF GARDEN GROVE BOULEVARD AND HARBOR BOULEVARD AT 12161 GARDEN GROVE BOULEVARD
- REQUEST: Site Plan and Conditional Use Permit approval to construct a new 980 square foot convenience store kiosk under an existing Shell Gas Station canopy. The existing 160 square foot convenience store kiosk will be demolished and replaced with the new kiosk at the same location. Also, a request for Conditional Use Permit approval to operate the new convenience store kiosk with an Alcoholic Beverage Control "Type 20" (Off-Sale, Beer and Wine) License. The site is in the C-1 (Neighborhood Commercial) zone.

STAFF RECOMMENDATION: Approve Site Plan No. SP-477-13 and Conditional Use Permit No. CUP-372-13, subject to the recommended conditions of approval.
