REQUEST: To operate a new 104,550 square foot retail/grocery store, Walmart, with a new original State Alcoholic Beverage Control (ABC) "Type 21" (Off-Sale, General) License. The site is in the NMU (Neighborhood Mixed Use) zone. This project is exempt pursuant to CEQA Section 15301 – Existing Facilities.
