LOCATION: NORTHWEST CORNER OF HARBOR BOULEVARD AND

CHAPMAN AVENUE AT 12361 CHAPMAN AVENUE

## REQUEST:

To revoke Conditional Use Permit No. CUP-589-02, which allowed a 10,828 square foot restaurant to operate under a State Alcoholic Beverage Control Type "47" (On-Sale General, Eating Place) License and to have live entertainment in the form of a disc jockey and dancing. The City proposes to revoke CUP-589-02 due to the closure of the business for more than 30 days. The site is in the Planned Unit Development No. PUD-104-82 zone.
