LOCATION: SOUTH SIDE OF TRASK AVENUE, BETWEEN MAGNOLIA

STREET AND GILBERT STREET, AT 9140 TRASK AVENUE,

SUITE 2

REQUEST: To amend Planned Unit Development No. PUD-107-96 to

allow a Children's Learning Center with Conditional Use Permit approval, in conjunction with a request for Conditional Use Permit approval to operate a new 2,180 square foot Children's Learning Center, Excelcius Academy. The site is in the Planned Unit Development

No. PUD-107-96 zone.

REQUEST: Site Plan and Conditional Use Permit approval to allow the

demolition of an existing 3,147 square foot religious building and to reconstruct and operate a 4,176 square foot religious building on an existing 39,000 square foot

lot in the R-1 (Single-Family Residential) zone.

ACTION: Other than the applicant, two people spoke in favor of

the request, no one spoke in opposition to the request, and 11 people expressed their concerns for the request. Resolution No. 5662 was approved by four ayes, with amendments to Condition No. 32, with Commissioner Beard voting no, with Chair Pierce absent, and with Commissioner Brietigam recused from the discussion. No further action unless appealed by

November 27, 2008.
