RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of my child being permitted to enter the City of Garden Grove's and/or the Garden Grove Unified School District's facilities ("Facilities") to engage in aquatic activities or for any other purpose, including, but not limited to observation, use of facilities or equipment or participation in any way, the undersigned, on behalf of himself or herself and his/her child and any personal representatives, heirs, and next of kin, hereby agrees as follows:

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the City of Garden Grove and the Garden Grove Unified School District, their departments, directors, officers, employees, and agents (hereinafter referred to as "Releasees") from any and all liability to the undersigned, and his/her child, his/her personal representatives, assigns, heirs, and next of kin for any loss or damages, and any claim or demands therefore, on account of property damage, personal injury, or death, whether caused by the negligence of the Releasees or otherwise, while the child of the undersigned is in, upon or about the Facilities for aquatic activities or any other purposes identified above. This release does not apply to the extent such claims are caused by the gross negligence or willful or wanton misconduct of the Releasees.

2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the child of the undersigned in, upon or about the Facilities for aquatic activities or in any way observing or using any facilities or equipment of the Releasees, whether caused by the negligence of the Releasees or otherwise, except to the extent such loss, liability, damage, or cost is caused by the gross negligence or willful or wanton misconduct of the Releasees.

3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to use of the Facilities for aquatic activities or any other purposes as identified above, whether foreseen or unforeseen and whether caused by the negligence of the Releasees or otherwise.

4. THE UNDERSIGNED further expressly agrees that the foregoing RELEASE, WAIVER, AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the laws of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED AGREES TO THE FOREGOING having inspected the Facilities and determined that the Facilities and all equipment thereon are safe and reasonably suited for aquatic activities or any other purposes identified above.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
