Traditionally, programs aiding the unhoused relied on federal and state funding. However, in recent years, this responsibility has shifted to County and City governments. They have been compelled to allocate resources, hire staff, construct facilities, and provide essential services to support the unhoused. Garden Grove, for instance, currently invests over \$1.8 million in services to the homeless and at risk population. In addition, Garden Grove as the lead agency, in collaboration with the Cities of Fountain Valley and Westminster and the County of Orange, is in the process of establishing a 100-bed navigation center. The acquisition, construction and anticipated operational costs for the center's first ten years of operation is estimated to exceed \$48 million.

Although cities have willingly borne this financial burden, AB 1782 seeks to empower municipalities like Garden Grove to leverage a higher portion of their Low and Moderate Income Housing Asset Fund (LMIHAF) for homelessness prevention and rapid rehousing services. The existing limit of \$250,000, set in 2012, pales in comparison to the current costs of providing these crucial services. The proposed adjustment to \$500,000, coupled with annual CPI adjustments, aligns more closely with present-day expenses.

Presently, Health and Safety Code Section 34176.1 permits housing successors to transfer up to one million dollars from the LMIHAF to another housing successor for regional homeless shelter development. AB 1782 aims to amend the code, allowing the receiving housing successor to contribute up to one million dollars annually from their LMIHAF. This change ensures that all partner cities have an equal opportunity to utilize LMIHAF funds for regional homeless shelters.

A request for Site Plan approval to construct a 2,000 square foot restaurant pad building with a drive-thru lane, along with associated site improvements. Also, a request for Variance approval to deviate from the minimum 180'-0" lot frontage and 50,000 square foot lot size requirements for the Harbor Corridor Specific Plan – Tourist Commercial "B" (HCSP-TCB) zone. The site is at 12542 Chapman Avenue. The existing 1,785 square foot building will be demolished to facilitate the proposed project. In conjunction with the request, the Planning Commission will also consider a determination that the project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15332 – In-Fill Development Project – of the State CEQA Guidelines.

TENTATIVE PARCEL MAP NO. PM-2020-174 (REINSTATEMENT-2024)
A request to reinstate the approval of Tentative Parcel Map No. PM-2020-174 to subdivide a 7.03-acre (306,411 square feet) property into two (2) parcels to create a new 0.45-acre (19,459 square feet) parcel for a drive-thru restaurant pad building at the Pavilion Plaza West shopping center. The City of Garden Grove Planning Commission previously approved Tentative Parcel Map No. PM 2020-174 on February 18, 2021 in conjunction with Site Plan No. SP-096-2021, Conditional Use Permit No. CUP 200-2021, and Variance, No. V-032-2021, which facilitated the construction of the Pavilion Plaza West shopping center. The site is at 9852 Chapman Avenue in the NMU (Neighborhood Mixed Use) zone. No changes to the previously approved project are proposed.

In conjunction with this request, the City of Garden Grove Planning Commission will also consider a determination that the potential environmental impacts of the project were analyzed in the Mitigated Negative Declaration for the project adopted by the Planning Commission on February 18, 2021 and that no further environmental review pursuant to the California Environmental Quality Act (CEQA) is required pursuant to Section 21166 of the Public Resources Code and Section 15162 of the CEQA Guidelines.

#### **OBJECTIVE**

To provide the City Council with a summary of the 2023 Holiday Drive.

#### BACKGROUND/DISCUSSION

The annual Holiday Drive, formerly known as the Adopt-a-Family program, celebrated 25 years of assisting families in Garden Grove. The Community Services Department, through the efforts of the Human Services Division, has coordinated this program since 2003.

The Holiday Drive assists families that are facing economic hardship during the holiday season by providing them with toys and gift cards. This past year, the program was expanded to serve senior participants of the H. Louis Lake Senior Center.

The Human Services Division successfully collected donations from various service organizations and businesses, including the following significant donations: \$2,600 from the Garden Grove Rotary Club; \$2,700 from McGarvin Intermediate National Junior Society; and two pallets of toys from local business, King Shocks. With these donations they were able to serve 274 families and 614 children, as well as 60 seniors from the community.

#### SUMMARY

The Community Services Department held a successful Holiday Drive this past year, and was able to serve 274 families, 614 children, and 60 senior participants.

Despite appeals from a substance abuse clinic planning to move from Santa Ana to Garden Grove, the city council voted 7-0 on Tuesday night to approve an ordinance to extend an earlier urgency ordinance imposing a moratorium on the approval of such businesses.

The urgency ordinance will extend the pause on new alcohol and drug treatment centers for an additional 10 months and 15 days. The purpose of the moratorium is to give the city time to study and complete appropriate zoning for such use and the impact on the community from such centers.

Representatives from Acadia Healthcare, a national chain of substance abuse centers, addressed the council to plead their case. Paul Simons said that his organization provided the "solution" to the fentanyl crisis which has grown dramatically in recent years.

The location chosen for the relocation is 8132 Garden Grove Blvd., a short distance east of Beach Boulevard, and close to where the city limits of Garden Grove, Stanton and Westminster converge. It is an area known to have problems with homeless encampments, crime and other issues.

Also on Tuesday night, the council approved a purchase order for the purchase of 15 patrol vehicles – sport utility – at the cost of \$813,766.

The next council meeting is scheduled for Tuesday, Feb. 13.

#### Dog rescued from house fire

A fire at a home in Garden Grove on Saturday night sent a resident to the hospital, while firefighters rescued the dog. According to the Orange County Fire Authority, the incident was in the 8800 block of Aberdeen Lane northwest of Magnolia Street and Chapman Avenue.

A 911 call at 7:38 p.m. sent OCFA crews to the scene, where flames were blowing out of the garage of the affected home. An adult resident of the home had suffered severe burns, a dog was running back into the home and the "fire quickly extended."

The burn victim was quickly treated and transported to a local hospital and firefighters rescued the dog from inside the home. It took 16 minutes to knock down the fire.

The cause of the fire is under investigation. Garden Grove police and Anaheim Fire and Rescue assisted in the operation.

#### Vietnamese Flower Street tradition replicated in Garden Grove for Lunar New Year

January 24

Historic Main Street in Garden Grove will come alive with song, dance and vibrant floral displays with the second annual Flower Street festival, a free two-day celebration that will help Little Saigon mark the start of the Lunar New Year.

"Flower Street on Historic Main" is modeled after the Nguyen Hue Flower Street festival in Vietnam, organizers say, a Lunar New Year tradition featuring cultural and entertainment events and elaborate floral designs that attracts more than 2 million visitors annually. The Flower Street celebration joins a vibrant tradition of Lunar New Year events in Orange County.







This year's Flower Street festivities include a retooled Lunar New Year's Eve countdown on Feb. 9 and day-long street festivals on Feb. 10 and 11 that aim to bring the Flower Street tradition to an American audience while showcasing the richness of Vietnamese culture.

Organizers reflected on last year's inaugural festival and previewed plans for this year's event during a recent press conference at the District 1 Deli on Main Street that featured Vietnamese food and drink, a mini fashion show and remarks by various stakeholders.

"Our efforts paid off," Phillip Ho, a member of this year's organizing committee, told the crowd about the 2023 festival. "We saw the families of Garden Grove and surrounding communities laughing and smiling and taking lots of pictures. We hope to bring the same energy and joy to Garden Grove with each additional event."

More than 15,000 people attended last year's festival, organizers said. They are hoping to attract even more this year.

During the festival, Main Street will be closed to traffic from Garden Grove Boulevard to Acacia Parkway so that participants can freely visit shops, take photos with floral displays sponsored by community groups and businesses, and participate in a variety of programming.

The first day of the festival will run from 11 a.m. to 7 p.m. on Feb. 10. Scheduled activities include an opening ceremony, traditional lion dance, performances and games. The second day will run from 11 a.m. to 8:30 p.m. on Feb. 11 and also features lion dances and a full day of activities and entertainment.

As 2024 is the Year of the Dragon, dragon statues fashioned from colorful flowers will be stationed near the Historic Main Street sign to welcome attendees, said Sophie Tran, this year's emcee who likened the festival to another popular American New Year's tradition.

"Imagine the Rose Parade, except you get to stay and take pictures with these beautiful arrangements," she said.

While the festival may provide aesthetically pleasing photo opps on the surface, organizers say it also serves a deeper purpose: to highlight the fullness of Vietnamese culture while uniting people across ethnicities and generations.

Orange County is home to the largest Vietnamese population outside Vietnam, Tran said, and publicly celebrating the start of the Lunar New Year is a fitting way to introduce residents of all backgrounds to Vietnamese traditions and culture.

Tran said that while local <u>Lunar New Year</u> events abound – annual celebrations are typically held in Westminster, Costa Mesa and Santa Ana for example – Flower Street on Historic Main is unique in that it intentionally showcases both traditional Vietnamese and modern Vietnamese American arts and culture.

In doing so, Tran said, organizers hope to unify multi-generational Vietnamese families and get them excited to ring in the Lunar New Year together, and to bring into the fold younger Vietnamese Americans who may feel disconnected from traditional Vietnamese culture because they don't speak Vietnamese or are growing up far away from their ancestors' homeland.

"Just because they don't understand the language does not mean that they are no longer members of our community," Tran said.

"The committee wants to put together events like this for the next generation to feel like they can travel the world and go to where their parents were born to celebrate Lunar New Year," she said, "but also to introduce our culture to other communities as well."

During the recent press conference, organizers highlighted some of the new additions to this year's festival that are designed to appeal to larger audiences and bridge the generation gap.

Little Saigon TV and the Vietnamese Creatives Collective are hosting for the first time a Lunar New Year's Eve countdown show, "Harmony of the Dragon," from 7 p.m. to midnight on Feb. 9 at the nearby Garden Amp outdoor amphitheater. The event will feature merchandise and food and will blend traditional and modern with a line-up that includes artistic performances, spoken word poetry, a DJ set, stand-up comics, and more. Kids and families are also encouraged to work together to decorate wagons with flowers and items from their gardens during a children's wagon decorating contest on Feb. 10.

And children and young adults will don floral-inspired áo dài – traditional Vietnamese dress – during a flower-themed fashion show on Feb. 11.

Flower Street on Historic Main is being organized by the Vietnamese Sport Association of Southern California in collaboration with Little Saigon TV, and with support from a network

of residents, businesses and groups, including the city of Garden Grove and the Garden Grove Downtown Business Association.

City Councilmember Stephanie Klopfenstein was among those who spoke about how the festival benefits the whole community.

"In Garden Grove we really celebrate our diversity," she said. "This is such a wonderful way to promote cultural harmony and all of us coming together. We are extremely excited to have this once again on Main Street."

"We hope," she added, "it becomes a tradition for many years to come."

## New gas tax allocation estimates suggest stable, but modest growth

Last week, Cal Cities released new local streets and roads revenue estimates, prepared by Cal Cities Fiscal Policy Advisor Michael Coleman. The allocations come from tax revenues collected at gas pumps and other sources. Cities and counties should use these estimates when budgeting for certain transportation projects.

The report is based on statewide tax revenue estimates released by the California Department of Finance with Gov. Gavin Newsom's January budget proposal. The county estimates were prepared in collaboration with the California State Association of Counties.

The twice-a-year report shows stable, but modest growth despite a slight decline in fuel consumption. Fuel consumption dropped sharply during the COVID-19 pandemic, but has since recovered to its prior, slightly declining trajectory. Fuel prices did increase recently. However, the price of fuel no longer has a direct effect on local streets and roads revenues. All rates are per gallon, regardless of price.

The estimate contains individual city and county calculations for the current fiscal year 2023-24 and budget year 2024-25. Overall allocations from the Highway Users Tax Account and the Road Maintenance and Rehabilitation Account are projected to climb 7.4% in the current fiscal year above the prior year. The report forecasts a growth of 4.1% over the current year for the 2024-25 budget year.

Individual agency amounts and growth rates will vary. The report includes specific city and county estimates, which are suitable for budgeting and long-range planning. The next update of these estimates will be in May 2024.

The revenue estimates, together with a detailed explanation of local streets and roads revenues and allocations are available online.



# Stopgap funding bill won't stop headaches for cities

Congress managed to reach another short-term budget solution last week and keep the federal government open until February. But the new stopgap funding bill could have significant negative consequences for local governments.

Federal grant programs that are instrumental for city budgets are facing both delays and cuts as a result of the deal. Funding amounts for grants to local governments will be determined about five months late. Many local governments rely on federal funding to provide services for underserved communities that boost housing and economic development projects.

Congress has until early March to pass the 12 annual appropriations bills. Congressional leaders did agree to spending levels; however, they have not yet agreed on how to split appropriations for the 2024 fiscal year. Once the federal appropriations bills are passed, the appropriations subcommittees chairs will have to negotiate allocations for agencies, departments, and programs within their jurisdictions.

Cal Cities' executive leadership team will head to Washington in mid-March to encourage federal lawmakers to safeguard local revenues and bolster local economic development. There's still no guarantee that Congress will reach an agreement on the 2024 federal budget. Speaker Mike Johnson, who holds a razor-thin majority, faced significant opposition from his own party to the deal. Johnson had to rely on Democrats to avert a federal shutdown — the same situation that led to his predecessor's ouster.

If lawmakers can't agree on a deal in March, they may pass another stopgap measure to avoid a government shutdown, which could trigger automatic 1% cuts to all federal programs. If this happens, domestic programs could face a \$41 billion cut.

California is also facing its own budget deficit, with possible impacts to key homelessness, housing affordability, and transportation programs statewide. Deficits or delays in the federal and state budgets are detrimental not just to local governments, but the underserved residents their programs serve.



## Remote public meetings bill gets a second shot

#### AB 817 (Pacheco) is co-sponsored by the League of California Cities

A bill that would make it easier for people to serve on local advisory bodies, boards, and commissions is set for an Assembly floor vote this Thursday. The narrowly tailored measure would give local non-decisionmaking legislative bodies the same rights as <a href="state-advisory bodies">state-advisory bodies</a> by allowing members to participate in online public meetings without posting their location and without allowing the public into the private location.

AB 817 (Pacheco) is co-sponsored by the League of California Cities, California Association of Recreation and Park Districts, California State Association of Counties, Rural County Representatives of California, Urban Counties of California, and California Association of Public Authorities for In-Home Supportive Services.

Asm. Blanca Pacheco introduced AB 817 last year, but the bill did not advance to the Senate. Since California's legislative sessions <u>last two years</u>, AB 817 has another shot — if it can pass the Assembly by the end of the month.

#### Recruitment and retention challenges

Local advisory bodies, boards, and commissions — which are often volunteer-run — face ongoing recruitment and retention challenges. <u>Time commitments</u>, the time and location of meetings, physical limitations, childcare requirements, and work obligations are frequently cited as the top barriers to participation.

The barriers can have an upstream effect on other legislative bodies. Local advisory bodies, appointed boards, and commissions are often pipelines to local, state, and federal leadership positions.

During the pandemic, public agencies throughout the U.S. could hold online public meetings with fewer restrictions, which anecdotally increased <a href="mailto:member">member</a> accessibility and <a href="mailto:resident participation">resident participation</a>. The increased flexibility created opportunities for public officials and concerned citizens alike who were previously unable to attend public meetings to participate, resulting in an increased diversity of input and thought on critical community proposals.

#### Diversifying and protecting local governance

AB 817 would build on the pandemic-era rules and successes by making it easier for advisory boards and commissions to meet remotely while protecting the safety of the participants.

Under current law, individuals must post their location and make it available to the public when meeting remotely. Although well-intended, this can create serious <u>safety concerns</u> for public officials. Several <u>local</u> and <u>national</u> studies have shown that harassment, threats, and even violence towards elected officials have increased in recent years — especially women and racial or ethnic minorities.

Asm. Pacheco recently agreed to amendments that would add a 2026 sunset date to the measure. She also committed to adding language that mirrors the teleconferencing rules currently applicable to state advisory bodies. This includes requiring an in-person location for public comment but not requiring an in-person quorum of members, as this would defeat the purpose of the bill.

An in-person quorum requirement would place a disproportionate burden on the types of people the bill is trying to help: seniors, disabled people, single parents, caretakers, economically marginalized groups, and those who live in rural areas or face prohibitive driving distances.

# Cal Cities-sponsored bill puts local officials in the driver's seat

SB 915 would allow local governments to regulate driverless vehicles like taxis

A bill backed by Cal Cities, labor advocates, and local government groups would allow cities and counties to pass rules for driverless vehicles — just like they can for taxicabs. Local officials in <u>San Francisco</u>, <u>Los Angeles</u>, and elsewhere have expressed opposition to the state's haphazard approval of <u>"self-driving"</u> robotaxis.

Over the last year, driverless vehicles have delayed or blocked emergency vehicles, interfered with active firefighting and crime scenes, and halted traffic. In one high-profile incident, a pedestrian was run over and <u>dragged by a Cruise robotaxi</u> after she was hit by another car. The state suspended Cruise's permit only after it became clear it had misled regulators about the severity of the event.

<u>SB 915 (Cortese)</u> would allow local governments to consider adequate safeguards that promote community safety, such as reasonable vehicle caps, data transparency rules, and interactions with emergency responders, as well as regulate maximum fare rates, ensure ADA accessibility, and perform annual inspections for health and safety. The measure is modeled after the existing statute that allows local governments to pass ordinances regulating taxicabs.

The robotaxi rollout process is currently dictated entirely by state agencies — without any input from impacted community members and regardless of local taxi rules. Local officials cannot even determine their impact on local traffic conditions. In San Francisco, driverless vehicles interfered with emergency responders over 70 times in 2023.

There's currently little that law enforcement and first responders can do when driverless cars block or interfere with emergency vehicles. Lawmakers are considering additional bills focused on enforcement actions.

SB 915 faces a steep, but climbable path forward. Last year, the Legislature voted overwhelmingly in favor of a bill that would limit self-driving trucks — despite threats and intense lobbying from major technology companies. The measure was ultimately vetoed by Gov. Gavin Newsom, who argued that the state was already doing enough. For more information, email Damon Conklin.
