RE: Fiscal Year 2024 Congressionally Directed Spending/Community Project Funding — CalOptima Health's Street Medicine Program

Dear Member of Congress:

I am pleased to support CalOptima Health's request for \$5 million of Congressionally Directed Spending/Community Project Funding to support the expansion of its street medicine pilot program into a permanent program. As the sole Medi-Cal managed care plan in Orange County, CalOptima Health currently serves nearly one million members, including more than 10,000 members that may be experiencing homelessness.

In December 2021, a collaboration of public agencies — the Orange County Interagency Council on Homeless Health Care (OCICHHC) — was formed for the purpose of creating a Street Medicine Program. Street medicine includes health and social services developed specifically to address the unique needs and circumstances of unsheltered individuals. The fundamental approach of street medicine is to engage people experiencing homelessness where they are and on their own terms to maximally reduce or eliminate barriers to care access and follow-through services. The ultimate goal is to link individuals to the appropriately assigned medical home in order to prevent inappropriate emergency room utilization as well as prevent progression of untreated health conditions that result in high mortality rates among those unhoused.

As the presumptive source of health coverage for nearly all individuals experiencing homelessness in Orange County, CalOptima Health is uniquely positioned to lead street medicine services in partnership with providers, government entities and community-based organizations. Therefore, on April 1, 2023, CalOptima Health is launching a street medicine pilot program in the City of Garden Grove and has contracted with a street medicine provider to work with current Clinical Field Teams, outreach workers, and mobile teams to address the needs of the unhoused population in a limited area of Orange County. Following the pilot program, CalOptima Health seeks to expand its services to a broader high-need area of Orange County as part of a permanent street medicine program.

OBJECTIVE

To provide information regarding the "Garden Grove Gems" home beautification program, to be held virtually beginning Monday, April 10, 2023.

BACKGROUND

The City of Garden Grove previously hosted a home beautification program, Garden Grove Pride, which was staged annually for 43 years. This longstanding special event celebrated the community's most attractive homes and recognized the outstanding curb appeal efforts of homeowners in Garden Grove. In 2017, the Garden Grove Pride program was placed on hiatus to reassess its effectiveness. In 2022, the Community Services Department introduced a new home beautification program, named Garden Grove Gems. The goal of the program was to provide community pride while reinforcing the importance of maintaining a well-kept home, thus enhancing the beauty of the Garden Grove.

DISCUSSION

The Community Services Department is staging its 2nd Annual Garden Grove Gems program in the spring of 2023. The Gems program will again be offered to the community virtually, as virtual programming has become more commonplace for families and allows for safer participation.

Garden Grove Gems will give homeowners and renters who reside within six Garden Grove districts an opportunity to nominate their homes and participate in the online voting competition. The communityat-large will be able to vote online for one home per district, with one winner and one runner-up being selected from each district. Winners and runner-ups will be invited to a small reception before a City Council meeting, and recognized during Community Spotlight this coming June.

SUMMARY

The Gems program will return for its second year, beginning with the home nomination period of April 10-28, 2023, followed by a voting period of May 8-21, 2023, with the results being announced the Week of May 29. The Garden Grove Gems program will be marketed through social media, park banners, and on the City's website where the public can access the link to nominate their home as well as cast their vote. OBJECTIVE

To inform the City Council about the city-wide special event Art in the Park taking place on Saturday, March 18, 2023, from 11:00 a.m. to 2:00 p.m. at Village Green Park.

BACKGROUND

The 'Art in the Park' event is part of the City's continuing efforts to brand and identify Garden Grove's iconic Downtown, while promoting the Re:Imagine Garden Grove mission of bringing more art to the community; the Garden Grove Unified School District (GGUSD) shares a similar goal, which is to continue to elevate its arts presence and distinction within Orange County, by showcasing the award-winning artistic talents of K-12th grade art students.

DISCUSSION

The City of Garden Grove, in collaboration with the GGUSD, will transform Village Green Park into an outdoor, interactive art festival for the 5th Annual Art in the Park. The community is invited to attend the free event on Saturday, March 18, 2023, from 11:00 a.m. to 2:00 p.m.

Event activities will include the "art car", an opportunity to paint on a classic car transformed into a blank art canvas; Recess Revolution, an unstructured free-play area; LEGO® Creation Station; ceramics demos; ukulele lessons led by GGUSD teachers and students from Rancho Alamitos High School and La Quinta High School; and Paint and Sip, an outdoor painting experience with a non-alcoholic or alcoholic bevérage provided.

The Paint and Sip activity is \$15 per individual and will be offered twice during the event. Times are 11:30 a.m. to 12:30 p.m. and 1:00 p.m. to 2:00 p.m. Registration is limited to 50 participants per session.

The Art in the Park event will also feature live performances from GGUSD students, as well as temporary art installations, including a 50-foot long by 6-foot tall "RE:IMAGINE" banner and oversized 8-foot tall easels, displaying GGUSD student artwork.

Lastly, GGUSD's annual First Impressions Student Art Exhibit, showcasing the artistic talents of GGUSD students, grades pre-K through 12th, will once again be located at the Garden Grove Courtyard Center, in Village Green Park. Opening day is Saturday, March 18, at 9:00 a.m. The exhibit will remain open from 8:00 a.m. to 8:00 p.m., Monday, March 20 through Thursday, March 23.

SUMMARY

The 5th annual Art in the Park in collaboration with GGUSD will take place on Saturday, March 18, 2023, from 11:00 a.m. to 2:00 p.m. at Village Green Park. This free event will showcase a variety of artistic works produced by local artists and students across the Garden Grove school district.



ACTION REGIONAL COUNCIL APPROVES DRAFT COMPREHENSIVE BUDGET FOR FISCAL YEAR 2024

The Regional Council has moved to approve SCAG's Draft Comprehensive Budget for Fiscal Year 2023-24, including the <u>Draft Overall Work Plan (OWP)</u>. The framework for developing the Draft Comprehensive Budget is SCAG's multi-year Strategic Plan, which focuses on SCAG's vision and priorities to improve the organization and its operations.

The Regional Council's vote also authorized the release of the Draft OWP for a 30-day period of public review from March 2 to April 3. Comments may be sent by email to nguyenk@scag.ca.gov or by completing the comment form.

At the close of the public comment period, the Final OWP will be submitted to the Regional Council for approval on May 4. The General Fund Budget and the Membership Assessment will be submitted to the General Assembly for approval, also in May.

ACTION

REGIONAL COUNCIL ADOPTS RESOLUTION AND CALL TO ACTION TO SUPPORT SOUTHERN CALIFORNIA'S CRITICAL LOGISTICS INDUSTRY

The Transportation Committee recommended on Feb. 2, that the Regional Council approve the <u>Goods Movement</u> Supply Chain Resolution; today, the resolution was adopted.

The SCAG region is home to the largest port complex in the country – the Ports of Los Angeles and Long Beach (together called the San Pedro Bay Ports) – and has an extensive intermodal freight network that supports the flow of goods throughout the nation. Goods movement significantly contributes to the region's economy and generates more than one-third of jobs in Southern California.

As part of the presentation, experts from the California Trucking Association and Pacific Merchant Shipping Association spoke about recent supply chain disruptions, the regulatory challenges ahead, loss of market share and uncertainty. For instance, the San Pedro Bay Ports had 26 consecutive months of growth from 2019, spurred by the pandemic, with only five months seeing growth below 10 percent; the last four months, however, have shown declines. Overall, container trade volumes through U.S. West Coast ports fell to some of their lowest levels in years.

Specifically, January 2023 container traffic at the major U.S. and Canadian ports on the Pacific Coast was uniformly down from pre-pandemic January 2019, while the opposite is true at U.S. East and Gulf Coast ports.

There was uniform agreement and support for the transition to zero emission technologies, with acknowledgement that significant challenges remain that require collective coordination and support at all levels of government. With heightened volatility and uncertainty, the focus on how to improve goods movement is at an all-time high. In response, SCAG has been working with partners and stakeholders to support a regional call-to-action including five core principles for addressing critical goods movement supply chain challenges and needs in the region. The adopted resolution codifies the five principles, including integration with Connect SoCal 2024 – Regional Transportation Plan/Sustainable Communities Strategy, and reaffirms SCAG's regional leadership role in addressing current and future goods movement supply chain challenges.

ACTION

REGIONAL COUNCIL APPROVES PROGRAMS TO ACCELERATE TRANSFORMATIVE HOUSING (PATH) APPLICATION

The Regional Council today approved the <u>REAP 2.0 PATH program application</u> and authorized its Calls for Applications. The PATH program, formerly named the Housing Supportive Infrastructure Program, is one of the three major funding areas in SCAG's <u>REAP 2.0 Program Development Framework</u>. The <u>program guidelines</u>, which the Regional Council adopted on Nov. 3, 2022, outline the program's components, requirements, eligibility and application process, and staff recommendation to set aside \$88.835 million of SCAG's REAP 2.0 funding to support the program.

The PATH program supports actions that accelerate infill development that facilitates housing supply, choice and affordability; affirmatively furthers fair housing; and reduces vehicle miles traveled. Funding opportunities in this program are designed to bring housing production to scale in transit-supported infill areas across the Southern California region to meet the 6th Cycle Regional Housing Needs Allocation.

Following state approval of SCAG's REAP 2.0 application, SCAG anticipates releasing Calls for Applications for the Notice of Funding Availability and Housing Infill on Public and Private Lands programs in April 2023. The Call for Applications for the Regional Utilities Supporting Housing program is anticipated to be released in Summer 2023. For more information on REAP 2.0, visit scag.ca.gov/reap2021.

ANNUAL STATE LEGISLATIVE AGENDA ESTABLISHED

Last week, under the strategic leadership of Jose Luis Solache, the Legislative/ Communications and Membership Committee discussed legislative priorities for the Sacramento Summit in April. SCAG's top four legislative priorities will focus on:

- 1. Protecting transportation budget priorities that the Governor proposed cutting back on in his January budget;
- 2. Communicating our region's housing progress, especially the good happening with our REAP funds;
- 3. Recognizing the important role that regions play in helping the state achieve our shared climate goals;

4. And asking the Legislature to establish a statewide task force to evaluate comprehensive modernization for the California Environmental Quality Act, or CEQA.

UPDATE ON REGIONAL ADVANCE MITIGATION PLANNING AND SOCAL GREENPRINT

The Regional Council approved the <u>Regional Advanced Mitigation Planning (RAMP) Policy Framework</u> in February. RAMP is a process to expedite project delivery by planning for environmental mitigation to reduce environmental impacts earlier in the planning process and at a wider scale.

This decision supports advanced mitigation in the region and directs the creation of the Greenprint Technical Advisory Committee (TAC) to ensure the future SoCal Greenprint tool is aligned with policy objectives identified in the framework. Recruitment for the TAC will begin in the next month, with letters to agencies and organizations asking for nominations, as well as outreach to SCAG's advisory groups to help spread the word.

The TAC will convene in Spring 2023 and will advise staff on the development of SoCal Greenprint – a tool to help stakeholders make early and informed decisions about infrastructure, growth and conservation, and to mitigate the environmental impacts of Connect SoCal, the Regional Transportation Plan/Sustainable Communities Strategy.

SCAG staff are currently initiating a competitive procurement process for a consultant to facilitate the TAC and complete the SoCal Greenprint tool.

SURVEY TO SUPPORT PERMIT STREAMLINING FOR BROADBAND INFRASTRUCTURE NOW OPEN

To support the expansion of broadband access across the region, SCAG and the San Diego Association of Governments are working towards creating a universal permit and model ordinance to expedite the permitting process and have developed a survey seeking input from local jurisdictions in developing a Permit Streamlining Manual to support the rapid deployment of broadband infrastructure.

The survey has two sections, "Planning" and "Public Works," to reflect different roles in permitting broadband infrastructure, and seeks to understand the existing laws, policies and resources affecting conditions in each jurisdiction.

GO HUMAN COMMUNITY HUBS GUIDELINES NOW AVAILABLE

The guidelines for the 2023 <u>Go Human Community Hubs Program</u> were released last month. The program offers funding opportunities for community organizations to implement local traffic safety and community engagement strategies that leverage community gatherings, resource sites and networks. The program will award up to \$40,000 to selected projects; interested applicants are invited to review the <u>Program Guidelines</u> in anticipation of the Spring 2023 Call for Applications. SCAG expects to host an informational webinar when the Call for Applications opens.

Staff noted the sound attenuation features for the outdoor playground area would include staggered playtime in 30-minute increments, six times per day, with a maximum capacity of 18 children at any time. Total playtime per day would be three hours between the hours of 10:00 a.m. and 4:30 p.m. The applicant also distributed letters to the six residential units that abut the playground to the east. One resident did not object to the project, the others were not home, nor did they express concerns. A copy of the letter was distributed to the Zoning Administrator.

Action:

The Zoning Administrator adopted Decision No. 1835-23 with amendments to the conditions of approval as follows.

Add two conditions:

61. In an effort to minimize noise from the outdoor playground, the Applicant shall install rubber flooring tiles, artificial turf, or other design features and/or flooring materials that provide adequate sound

attenuation. The materials shall be maintained and kept free of any tears, holes, and in a fadeless condition.

62. The Applicant shall install sound curtains/panels along the full length of the block wall located on the east side of the playground that provide adequate sound attenuation. The outdoor sound curtains/panels shall be maintained and kept free of any tears, holes, and in a fadeless condition.

Applicant: Smartlink (c/o AT&T Mobility)

The site is in the R-1 (Single-Family Residential) zone. Three letters of opposition were received from Kaye Monachelli, Linda Maher, and Roy and Pat Amelang. The letters and speakers cited concerns with the cell tower's proximity to the church, school, and residential backyards, along with concerns with the existing cell tower including maintenance, noise pollution from workers at night, the generator, and the tower itself (buzzing causing lack of sleep). General concerns included general safety, and health risk safety in regard to the effects of 5G RF radiation exposure causing mental health issues in adults and children; the tower possibly falling in an earthquake; the lowering of property values; that two existing facilities are already in the vicinity; and more research, studies, and tests are needed in regard to 5G technology.

Zoning Administrator Minutes

Action:

In light of the concerns, the Zoning Administrator remanded CUP-233-2023 to the Planning Commission hearing body, to a date uncertain, in order to allow the applicant to conduct and present further studies on past and current cell tower technology for the benefit of the residents. The Planning Commission meeting would be

duly noticed.

Eight Cal Cities-sponsored bills you need to know

Mar 8, 2023

The League of California Cities is proactively advancing cities' interests by working with lawmakers to introduce bills that target common issues facing cities. Cal Cities is currently sponsoring eight bills that collectively focus on public safety concerns, public meetings, council member pay, and fiscal sustainability.

Many of these bills have placeholder language and are awaiting amendments.

Repeat theft and emergency medical services

Retailers and police departments have reported an increase in repeated — sometimes high-profile — organized retail crime. AB 1708 (Muratsuchi) would reverse that trend by reforming Proposition 47 to increase accountability for serial theft and encourage responsive intervention programs that divert people away from both crime and prison.

Approved in 2014, Prop. 47 recategorized some nonviolent offenses, such as shoplifting, as misdemeanors. If signed into law, the changes proposed by AB 1708 would be placed on the 2024 statewide ballot for voter approval.

AB 1708 is co-sponsored by the California Police Chiefs Association and the California Retailers Association. The bill currently has placeholder language and is awaiting amendments.

Cal Cities is also sponsoring <u>AB 1168 (Bennett)</u>. Once amended, the measure would clarify the Legislature's intent regarding a local jurisdiction's right to deliver prehospital emergency medical services (EMS). AB 1168 would reconcile *City of Oxnard v. County of Ventura*, which ruled that Oxnard lost its authority to provide prehospital EMS after signing a joint powers authority agreement with the county.

AB 1168 is supported by the California Professional Firefighters Association and the California Fire Chiefs Association.

Brown Act and council member pay

Cal Cities is sponsoring two Ralph M. Brown Act bills and a measure that would reform council member pay. Two of the measures would reduce barriers to city councils and certain other legislative bodies.

AB 557 (Hart), would eliminate the sunset provisions in AB 361 (R. Rivas, 2021). The Rivas measure allows cities to meet remotely during proclaimed states of emergency under modified Brown Act requirements. The Hart bill would also provide greater flexibility for agencies that meet on a fixed date every month by extending the SB 361 renewal period to 45 days.

<u>AB 817 (Pacheco)</u> — pending amendments — would allow non-decision-making legislative bodies currently governed by the Brown Act, such as advisory bodies and commissions, to participate in two-way virtual teleconferencing without posting their physical location.

The teleconference flexibility granted to cities because of COVID-19 noticeably reduced barriers to participation. Residents who were usually not able to participate due to time, distance, or mandatory physical participation requirements were able to attend public meetings. AB 817 would maintain that access for certain legislative bodies, creating greater access to leadership opportunities and providing more diverse input on critical community proposals.

<u>SB 329 (Dodd)</u> would boost participation and diversity among city councils by allowing general law cities to adjust city council pay caps for inflation based on the California Consumer Price Index. Currently, in general law cities, city councils may vote to receive a salary, not to exceed limits based on population size provided in state law. This limit has not been increased since 1984, despite inflation rising over 300% during that time.

On-time and on-budget public projects

Cal Cities is sponsoring two measures that would protect and expand cities' ability to use design-build procurement processes. These processes allow a city to contract with a single entity to design and construct a project at a fixed price. Contractors are also given more flexibility over project design, materials, and construction methods. This encourages greater collaboration between cities, designers, and contractors, which reduces delays, mitigates risks early, and keeps costs low.

The progressive design-build process starts this collaboration during the earliest stages of project development and produces cost estimates at different phases of the decision process. This results in greater benefits, including fewer change orders.

Although utilization of the design-build process is becoming more common, cities can only employ it until Jan. 1, 2025. Moreover, California law restricts the progressive design-build process to water projects over \$5 million in total costs. Using both processes can help advance vital infrastructure projects on time and on budget. Persistent labor gaps, increased building material costs, and strict use-it-or-lose-it timelines for federal dollars mean that even a modest project delay can noticeably increase a project's cost. With the Bipartisan Infrastructure Law in particular, cities have a short period of time to access and use federal funding.

AB 400 (Rubio) would permanently allow local governments to use design-build processes. SB 706 (Caballero) would allow cities to use progressive design-build for all public projects over \$5 million.

Streamlined grant applications and technical assistance

Cal Cities is working with Assembly Member Brian Maienschein on a bill that would coordinate and align local government assistance resources from the state for various environmental grant programs. The bill would convene a statewide, cross-agency workgroup to help develop a coordinated management system. The bill will be in print shortly.

A uniform and streamlined application process would allow cities to effectively and equitably access funding opportunities. Most state grant programs have unique grant application processes and equally varied local assistance programs are scattered across state departments. Applying for grants is further complicated by a lack of staffing capacity and experience at the local level.

Likewise, centralizing local government assistance resources and developing a coordinated system to manage available funding would deliver the maximum number of projects as efficiently and equitably as possible.

How to get involved

The 2023 legislative season will kick off in earnest next week when policy committee meetings start. Cal Cities backs Senator Eggman's efforts to bring more changes to California's behavioral health care system

Cal Cities supports both proposed measures, SB 43 and SB 363.

Sen. Susan Eggman unveiled two bills last Wednesday that would further update California's behavioral health system: SB 43 and SB 363. The bills are supported by the League of California Cities, behavioral health advocates, and the Big City Mayors Coalition, which is sponsoring the measures.

SB 43 would update California's 1967 conservatorship law by expanding the definition of "gravely disabled" to include conditions that result in a substantial risk of serious harm to an individual's physical or mental health. The current law's high threshold makes it difficult to provide treatment for individuals unable to care for themselves.

SB 363 would establish a real-time, internet-based dashboard to collect, aggregate, and display information about available beds in psychiatric and substance abuse facilities. This easily accessible data would connect individuals to care more quickly and help cut down on extended emergency room stays.

Like many other health conditions, when mental illness and substance use are treated early and with appropriate supports and services, they are less disabling and result in fewer adverse outcomes.

Cal Cities is eager to again support efforts that would provide cities' most vulnerable residents with access to the behavioral health services they need. These proposals are consistent with Cal Cities 2023 Advocacy Priorities and budget asks, which seek to secure increased funding and resources to prevent homelessness and assist individuals experiencing homelessness.

Eggman, a clinical social worker, introduced similar measures last year. Her 2022 eight-bill legislative package was aimed at better coordinating existing programs to improve patient outcomes. Cal Cities supported all eight measures. Ultimately, only three were signed into law.
