#### **OBJECTIVE**

The purpose of this memorandum is to provide an overview of the City of Garden Grove's application for funding under the **2024 Homeownership Super Notice of Funding Availability (Super NOFA).** This funding opportunity will support the City's ongoing efforts to assist low-income first-time homebuyers through the First-Time Home Buyer Program. The City is seeking \$2 million in funding to continue providing critical down payment assistance, thereby promoting sustainable homeownership and affordability within Garden Grove.

#### **DISCUSSION**

A successful Super NOFA application will allow the City to continue implementation of its First-Time Homebuyer Program and enable us to assist approximately 16 new first-time homebuyers, continuing a long-standing commitment to increasing homeownership opportunities for low-income households. This program has successfully assisted low-income households in achieving homeownership since 1989 and remains a vital resource amid rising housing costs. The requested funding will provide mortgage assistance grants of up to \$110,000 per applicant, with the potential to leverage Permanent Local Housing Allocation (PLHA) funds for a combined total of up to \$160,000 per household. These funds will be allocated exclusively for single-family home purchases in Garden Grove, excluding mobile homes, and will be fully expended within 36 months.

Over the years, the City has effectively administered homebuyer assistance programs, issuing numerous loans and maintaining compliance with state and federal regulations. In Fiscal Year 2024-2025 alone, the City has issued seven homebuyer loans using Cal-Home funds. This demonstrates both the City's capacity to manage the program and the ongoing demand for homeownership assistance. Securing this funding will allow the City to continue providing critical financial support to low-income first-time homebuyers, promoting neighborhood stability and long-term affordability in Garden Grove.

Southern California Edison Company (SCE) hereby submits this Tier 1 Advice Letter to the California Public Utilities Commission (Commission or CPUC) that provides the requested information in Ordering Paragraph 1 of Decision (D.) 21-10-020.

#### <u>PURPOSE</u>

This Advice Letter provides information required by Ordering Paragraph (OP) 1 of D. 21-10-020 regarding SCE's restoration, rebuilding, and reconstruction activities related to the Eaton Fire, the Palisades Fire, the Hurst Fire, and the January 2025 Windstorms. The Governor declared a State of Emergency for the January 2025 Fires and Windstorms on January 7, 2025 and issued a series of Executive Orders beginning on January 8, 2025 with the latest being issued on February 14, 2025. The Hurst Fire was fully contained on January 16, 2025. The Palisades and the Eaton Fires were fully contained on January 31, 2025. Lastly, the January 2025 windstorms occurred multiple times throughout January 2025.

#### **BACKGROUND**

Ordering Paragraph 1 of D. 21-10-020 requires an electric Investor Owned Utility (IOU) to file a Tier 1 Advice Letter if (1) the Governor of California or the President of the United States issues a disaster declaration, and (2) there is damage to IOU's facility or a service outage. Ordering Paragraph 1 states:

"In the event of a disaster, declared either by the Governor of California or the President of the United States, that also damages their facilities or leads to a service outage, Investor-Owned Utilities (IOUs) shall file a Tier 1 Advice Letter within 15 business days from when they are allowed into

a disaster area to assess the damage to their facilities. IOUs shall file this Advice Letter with the Commission's Energy Division, with a copy sent to the Communications Division at <a href="mailto:TD\_PAL@cpuc.ca.gov">TD\_PAL@cpuc.ca.gov</a>. The Advice Letter also must be provided to the appropriate local government contained within the disaster area, including the chief executive or leader of the city, township or Tribal government. In the case of an unincorporated area, the communication must be established with the appropriate County. In the case of Tribal governments, the Advice Letter must be provided to any Tribe(s) that have Tribal lands or ancestral territory overlapping with any portion of the disaster area."

The Advice Letter shall include the following details:

- a. a report of what facilities or equipment was damaged;
- b. restoration and/or rebuild plans, including a description of what is being repaired, replaced or added, and maps of where the restoration will occur;
- c. the date the investor-owned utility received access to the damaged area;
- d. the timeline to make repairs;
- e. any changes to any energy/communication infrastructure required; and
- f. the contact information of the individual responsible for community engagement in these instances."

Below, SCE provides the requested information for the disaster declarations covered in this advice letter.

#### **Eaton Fire**

The Eaton Fire occurred in SCE service territory commencing on or about January 7, 2025 and was fully contained on January 31, 2025. On or about January 7, 2025 Governor Newsom issued a State of Emergency Proclamation for Los Angeles County, Riverside County, San Bernardino County, Orange County, and Ventura County, all of which are located in SCE service territory. Governor Newsom also issued a series of Executive Orders beginning on January 8, 2025 with the latest being issued on February 14, 2025. SCE began restoration activities on January 10, 2025 and as of February 14, 2025, restoration activities are still ongoing.

In addition to the facilities and equipment listed on the table above, a 4kV substation was also destroyed from the Eaton Fire.

#### B. Restoration or rebuild plans

SCE began the service restoration as soon as it was safe to conduct the work on January 10, 2025. SCE's current restoration and rebuild plans involve replacing equipment like for like in order to restore power to customers that are ready for restoration. In certain instances, SCE is updating to current equipment standards, such as transitioning any affected 4kV circuits to 16kV. Long term rebuild plans are currently being discussed which will move some facilities underground which were previously overhead and may result in upgraded facilities and other changes to infrastructure. Restoration efforts are ongoing as of February 14, 2025.

#### C. Date received access to damaged areas

SCE was under restricted access at the request of fire authorities. Access to the affected areas was limited by safety concerns, rugged terrain, inclement weather, and number of downed trees. SCE first received access to the affected areas on January 19, 2025 and completed damage assessments related to the storm on January 24, 2025.

#### D. Timeline to make repairs

SCE began service restoration efforts on January 10, 2025. The restoration effort is still ongoing as of February 14, 2025.

#### E. Changes to infrastructure

Service restoration was accomplished by replacing equipment on a like-for-like basis in order to restore power to customers that can safely be restored. In certain instances, SCE is updating to current standards, such as transitioning any affected 4kV circuits to 16kV. Long term rebuild plans are currently being discussed. Some of SCE's facilities that were previously overhead will be moved underground as a result of the rebuild effort. Long term rebuild plans may also result in upgrading facilities and other changes to infrastructure.

#### F. Contact information or community engagement

SCE engaged with the proper authories to accomplish the initial service restoration activitiy as noted above. SCE is currently planning a longer term rebuild effort. This may result in facilities being changed and/or updated from what they were previously. SCE will engage with community statekholders prior to the rebuild effort as contemplated by OP 2 of D. 21-10-020 prior to commencing the work. Based on the rebuild plans, SCE may submit a second Advice Letter as contemplated in OP 3.

#### Palisades Fire

The Palisades Fire occurred in SCE service territory commencing on or about January 7, 2025 and was fully contained on January 31, 2025. On or about January 7, 2025 Governor Newsom issued a State of Emergency Proclamation for Los Angeles County, Riverside County, San Bernardino County, Orange County, and Ventura County, all of which are located in SCE service territory. Governor Newsom also issued a series of Executive Orders beginning on January 8, 2025 with the latest being issued on February 14, 2025. SCE began restoration activities on January 10, 2025. As of the date of February 14, 2025, restoration activities are still ongoing.

#### B. Restoration or rebuild plans

SCE began the service restoration as soon as it was safe to conduct the work on January 10, 2025. SCE's current restoration and rebuild plans involve replacing equipment as needed in order to restore power to customers, in some cases temporary electric service was provided to customers that were ready for restoration. Temporary power is being provided by mobile generators in multiple areas throughout the burn scar. In certain instances, SCE is updating equipment to current standards, such as updating outdated structures, replacing damaged poles with poles that meet current loading standards, and bare conductor with new covered conductor. Long term rebuild plans are currently being discussed which will move some facilities underground which were previously overhead and may result in upgraded facilities and other changes to infrastructure. Restoration efforts are ongoing as of February 14, 2025.

#### C. Date received access to damaged areas

SCE first received access to the affected areas on January 10, 2025 and completed damage assessments related to the fire on February 4, 2025. SCE was under access restriction by the incident command center including Cal Fire and the EPA, and was also limited by rugged terrain and inclement weather.

#### D. Timeline to make repairs

SCE completed service restoration to approximately 525 customers from January 22, 2025 to February 11, 2025. At this time restoration efforts are still on going.

#### E. Changes to infrastructure

Service restoration was accomplished by replacing equipment on a like-for-like basis in the immediate near term. Long term rebuild plans are currently being discussed. Some of SCE's facilities that were previously overhead will be moved underground as a result of the rebuild effort. Long term rebuild plans may also result in upgrading facilities and other changes to infrastructure.

#### F. Contact information or community engagement

SCE engaged with the proper authories to accomplish the initial service restoration activitiy as noted above. SCE is currently planning a longer term rebuild effort. This may result in facilities being changed and/or updated from what they were previously. SCE will engage with community statekholders prior to the rebuild effort as contemplated by OP 2 of D. 21-10-020 prior to commencing the work. Based on the rebuild plans, SCE may submit a second Advice Letter as contemplated in OP 3.

#### **Hurst Fire**

The Hurst Fire occurred in SCE service territory commencing on or about January 7, 2025 and was fully contained on January 16, 2025. On or about January 7, 2025 Governor Newsom issued a State of Emergency Proclamation for Los Angeles County, Riverside County, San Bernardino County, Orange County, and Ventura County, all of which are located in SCE service territory. Governor Newsom also issued a series of Executive Orders beginning on January 8, 2025 with the latest being issued on February 14, 2025. SCE began restoration activities on January 7, 2025.

A. SCE's Facilities and Equipment that were Damaged as of February 14, 2025 SCE did not have damage to Distribution facilities and sustained only minor damage to Transmission and Telecom facilities. For Telecom, SCE utilized 12,500 feet of fiber wrap to replace 13 tower spans and three splices. For Transmission, SCE replaced three spans of wire totaling 18,000 feet.

#### B. Restoration or rebuild plans

SCE began the service restoration as soon as it was safe to conduct the work. Service restoration was accomplished by replacing equipment on a like-for-like basis.

#### C. Date received access to damaged areas

SCE was not under restricted access to the affected areas and sustained only minor damage to Telecom and Transmission facilities. However, access to affected areas were limited by the rugged terrain.

#### D. Timeline to make repairs

#### E. Changes to infrastructure

Service restoration was accomplished by replacing equipment on a like-for-like basis.

Governor Newsom also issued a series of Executive Orders beginning on January 8, 2025 with the latest being issued on February 14, 2025. SCE began restoration activities on January 7, 2025. As of the date of February 14, 2025, some restoration activities are still ongoing.

#### B. Restoration or rebuild plans

SCE began the service restoration as soon as it was safe to conduct the work. Service restoration was accomplished by replacing equipment on a like-for-like basis. Most restoration efforts were completed as of January 29, 2025. Some minor restoration efforts are still ongoing at the time of this Advice Letter.

#### C. Date received access to damaged areas

SCE was not under restricted access to the affected areas and began doing damage assessments on January 7, 2024. However, access to affected areas were limited by the rugged terrain, incliment weather, and downed trees.

#### D. Timeline to make repairs

SCE completed service restoration for approximately 29,000 customers from January 7, 2025 through January 29, 2025. Minimal restoration efforts are still ongoing at the time of this Advice Letter.

#### E. Changes to infrastructure

Service restoration was accomplished by replacing equipment on a like-for-like basis. Some equipment was brought up to the latest construction standards. Some poles were upgraded to support current loading standards and some transformers were upgraded to support current and future customer load.

#### F. Contact information or community engagement

This was a service restoration activity accomplished by replacement of equipment on a like-for-like basis, not a rebuild effort. Because this was a service restoration effort requiring immediate action, SCE did not engage with community statekholders prior to the restoration work as contemplated by OP 2 of D. 21-10-020 prior to commencing the work. Accordingly, SCE will not be submitting a second Advice Letter as contemplated in OP 3.





# LIMITED FUNDING AVAILABLE FOR NEW TECH ASSISTANCE LOAN PROGRAM FOR SMALL BUSINESSES

Limited funds are still available for the Garden Grove MicroBiz Program, which provides technical and financial assistance to local small businesses to improve and expand operations. Qualifying establishments can apply for a low-interest loan of up to \$50,000 for job creation. To apply, visit ggcity.org/business-resources.

The new MicroBiz Program is for businesses with five or less employees and provides a wide range of technical assistance. Services include: initial business assessments from experienced business advisors; business planning and counseling; financial management and budgeting; workforce development; sales and marketing; and technology.

Additionally, participating businesses can apply for a loan of up to \$50,000 if hiring low-income individuals. The loan is designed to help offset business operation expenses while the business undertakes hiring and expands operations. The City's loan offers competitive financing with a minimum interest rate of 3%, and a maximum interest rate that does not exceed 75% of the current prime rate.

To qualify, businesses must be located in Garden Grove; have less than five employees (including the business owner); possess valid operating licenses and permits; and be in good-standing with the City.

# **Developing the Big Strawberry**

In the modern world of city operation, fostering and managing development – stores, offices, housing, factories, etc – is crucial to balancing budgets, providing services and maintaining a good quality of life.

For a look at how Garden Grove stands, we sat down with City Manager Lisa Kim,; assistant city manager/economic development and housing director Ursula Luna Reynolds' and Niki Wetzel, community development director, for some updates.

This is an edited version of the conversation and some comments have been edited for length. First of several parts.

Question: What's the status of the three major hotels planned for Harbor Boulevard which still stand on empty lots?

Ursula: In general, interest rates are a huge factor for investors. It's not a great environment for borrowing and construction costs are getting higher and not just for commercial construction. We still see interest in building those hotels but they are multi-billion dollar investments.

How long do we hang on to them? They're almost ready to pull building permits. There's no better or higher use. I think we're willing to hold on.

#### What are some developments pending for Garden Grove?

Ursula: Our first Dutch Bros. coffee will open on Brookhurst Street by the end of March. Lisa: It has a huge cult following ...everybody's waiting for Dutch Bros. to open. Ursala: The Office Depot building has been demolished and the Costco gas station will be moved to that spot [facing Garden Grove Boulevard] and replaced with parking [at the former gas station site].

Lisa: Many residents visit the Costco two or three times a week. One of my colleagues drives to the Garden Grove Costco because the gas here is less expensive.

#### What's the status of retail and commercial development?

Lisa: Big retailers are not doing that well because of the Amazon effect. We're focusing on independent operators. The Thirsty Cow [Korean BBQ under construction in Eastgate Plaza at Chapman Avenue and Valley View] is 9,000 square feet. It will generate income equivalent to a Cheesecake Factory.

# Progress is reported on the city homelessness front

A report on Garden Grove's efforts to cope with the problems associated with homelessness won raves from the city council on Tuesday night.

In the presentation led by Asst. City Manager/Community Development Director Ursula-Luna Reynosa it was noted that the number of unhoused people counted in 2024 was a 39 percent decrease from 2022.

"The impact is dramatic," said Councilmember George Brietigam, going on to say that he believed that was the best record of any city he was familiar with.

In reporting to the council, various staff members reported on the functions and successes of the Navigation Center – a joint venture with the cities of Fountain Valley and Westminster.

Many of its residents have been connected with housing and others with employment. Sixteen of them have been hired to work this summer at Angel Stadium.

#### Other key points included:

- change in the demographics of the homeless toward younger people with fentanyl abuse issues;
- prospects for more permanent supportive housing and
- the effects of the city's anti-camping ordinance.
- new strategies to improve city efforts

Suggestions made by councilmembers included providing liaisons with the homeless who spoke Vietnamese, Spanish and other languages, as well as using the city's website to publicize programs available to the unhoused.

# Orange County Considers Overhauling Animal Shelter Operations

The Orange County Board of Supervisors is expected to discuss overhauling operations at OC Animal Care during Tuesday's meeting, including expanding viewing hours and reinstating catch and release services.

Supervisors Janet Nguyen and Vicente Sarmiento are calling for a discussion that includes four recommendations for potential changes at the county-run animal shelter in Tustin.

The first recommendation would direct leaders at OC Animal Care to prepare a plan for expanding viewing hours to allow more public access — something local activists have been calling for over the past few years.

Currently, the shelter only allows the public to walk through the dog kennel areas and cat rooms daily from 2 to 5 p.m. Shelter leaders added those hours for the first time since before the COVID-19 pandemic in January 2024.

A six-month pilot program launched last month expanded weekend visiting hours to 12 to 5 p.m. on Saturdays and Sundays.

Supervisors are slated to consider recommending the shelter plan to allow full public access to view adoptable animals during all operational hours -11 a.m. to 5 p.m. daily - in addition to one evening for visitors to see the animals until 7 p.m.

"These additional hours will provide more opportunities for potential adoptions, fostering, and community involvement," reads a memo included with the agenda.

The second recommendation would create a new community liaison aimed at engaging with residents and local animal rescue organizations.

The third recommendation would direct county counsel to revisit legal considerations for trap, neuter and return programs and review how surrounding jurisdictions operate these kinds of services.

Trap, neuter and return — often referred to as TNR or trap and release — is the practice of trapping feral or community cats living outside, spaying or neutering the animals to prevent reproduction and returning the cats back where they were found since they're unsocialized to people.

OC Animal Care used to offer trap, neuter and return services before the COVID-19 pandemic, but officials nixed the program over concerns that releasing cats back into the community could be considered animal abandonment, which is illegal.

Supervisors are recommending county counsel review how other jurisdictions operate catch and release and report back to the board within 30 days.

"In 2024, OCAC reported 12,196 live feline intakes. Of these, 437 of the adult cats and 1,465 kittens were euthanized," reads a memo included with the agenda. "By implementing a TNR program, Orange County can significantly reduce the intake of both adult cat and kittens, alleviating the strain on county resources."

The fourth recommendation would require shelter leaders to provide monthly statistics for intakes, outtakes, adoptions and euthanasia online.

OC Animal Care used to post monthly statistics but ended that service in 2021. Now, the shelter only offers quarterly statistics.

"In the absence of strong data reporting systems, many challenges emerge," reads a memo included with the agenda. "Gaps in data transparency create trust issues between shelters and the communities they serve."

Potential Overhaul Comes After Years of Criticism

Orange County residents and animal activists have been criticizing the shelter's operations <u>for years</u>.

Advocates have called out lacking viewing hours in addition to not offering trap, neuter and return services. Over 25,000 people have signed an <u>online petition</u> calling for the shelter to fully reopen to the public without restriction.

Michael Mavrovouniotis, an Irvine resident and former shelter volunteer, said the four recommendations are positive steps.

He also had a research paper <u>published today</u> in the Journal of Shelter Medicine and Community Animal Health that found adoption rates are consistently higher when visitors can view dogs in their kennels.

"It's great to see Supervisors Janet Nguyen and Vicente Sarmiento taking steps to improve the county animal shelter," Mavrovouniotis said. "These two Supervisors listened to the community, looked at the issues, and are working to gradually build an animal shelter that meets the high standards of OC."

"As a county, we should be leaders, not laggards."

6. As required under Section 107 of the California Building Code (CBC), the grading plan shall be based on a current survey of the site, including a boundary survey, topography on adjacent properties up to thirty-feet (30'-0") outside the boundary, and designed to preclude cross-lot drainage. Minimum grades shall be 0.50% for concrete flow lines and 1.25% for asphalt. The

grading plan shall also include water and sewer improvements. The grading plan shall include a coordinated utility plan showing all existing utility facilities, easements and proposed utility facilities. All on-site improvements shall be tied by horizontal dimensional control to the property boundary as established by survey. A minimum uninterrupted 20-foot wide throat access to the site is required from the street for the commercial projects and shall meet the requirements of the California Fire Code throughout the site. Vehicle maneuvering, as demonstrated by Auto Turn along private streets and access ways, shall be demonstrated on the grading plan. Street improvement plans shall conform to all format and design requirements of the City Standard Drawings & Specifications.

The applicant shall submit to the Planning Division and Engineering Department for review and approval grading and Street improvement plans prepared by a registered Civil Engineer, illustrating all site improvements proposed on the residential 1.73 acre parcel and the 1.29 acre parcel currently improved with a religious facility. All site improvements proposed on the 1.29 acre parcel improved with the religious facility shall be fully completed prior to the issuance of certificate of occupancy for **Units 21 through 26 of Building 1 of** the residential development proposed on the 1.73 acre parcel. In addition, a total of 59 parking spaces shall remain on the remaining 1.29 acre parcel improved with the religious facility.

9. Demolition of the existing ancillary building and parking lot improvements to construct the proposed residential project, and construction of the block wall between the two new parcels, may necessitate certain grading and drainage improvements and will require parking lot improvements and restriping on the new 1.29-acre parcel (Parcel 1) to ensure compliance with applicable City and State requirements. Following implementation of the proposed Project, the parking lot in Parcel 1 shall be improved to contain a minimum of 59 parking spaces. The applicant shall submit to the Planning Division and Engineering Department for review and approval grading and Street improvement plans prepared by a registered Civil Engineer, illustrating all site improvements proposed on the residential 1.73 acre parcel (Parcel 2) and the 1.29 acre parcel (Parcel 1) currently improved with a religious facility. All site improvements proposed on the 1.29 acre parcel improved with the religious facility (Parcel 1) shall be fully completed prior to the issuance of certificate of occupancy for Units 21 through 26 of Building 1 of the residential development proposed on the 1.73 acre parcel (Parcel 2).

11. Parcel 2 shall be developed as per approved plans, and shall not exceed a total of twenty-six (26) townhomes.

#### Here's how two recent wildfire executive orders

# could affect your city

Gov. Gavin Newsom issued a barrage of executive orders earlier this year in response to the devastating January wildfires in Southern California. Some will impact cities outside the region.

In early March, he signed an emergency proclamation ordering cuts to red tape for critical vegetation management projects for the rest of the calendar year.

The proclamation suspends all state laws and regulations under the California Natural Resources Agency and California Environmental Protection Agency for vegetation and tree removal projects, fuel breaks, prescribed fire, and other fuel reduction activities, such as removing dead, highly flammable vegetation. Notably, this order suspends the California Environmental Quality Act and the California Coastal Act.

It's the type of fast-tracking Cal Cities is advocating for in <u>AB 846 (Connolly)</u>. The bill would <u>create a clear way</u> for the California Department of Fish and Wildlife to process vegetation removal and fuel management projects in fire hazard severity zones near urban communities overseen by local governments.

Similar to the Governor's emergency order, AB 846 is a long-term solution that would ensure environmental laws are upheld while speeding up wildfire preparedness efforts. It's also the type of tape cutting that the Governor <u>axed in 2024</u> due to its potential costs to the state.

Cities are encouraged to take advantage of this proclamation to expedite fuel reduction projects and urge policymakers to adopt a more permanent solution that acknowledges the year-round threat now posed by wildfires.

#### 'Zone zero' rulemaking end-date in sight

Newsom also directed state officials to adopt long-delayed "Zone 0" draft regulations this year. Originally set to take effect in 2023, these regulations will bar brush, wooden fencing, mulch, and other flammable materials within 5 feet of homes in high-risk areas.

Any new developments would need to comply with the regulations immediately. Existing homes would likely have three years to comply.

State officials shared in a recent workshop that the draft regulations will be available on March 21 and the formal rulemaking will start in June. The rules could take effect as early as next year.

Questions remain over who will enforce these regulations and funding. Will local governments be the enforcing agency in their communities? Who will fund these new home hardening requirements and what incentives will be in place to encourage compliance?

The state plans to allocate \$50 million in state climate bond funding for defensible space efforts. Officials estimate the program will start later this year after the Governor and Legislature pass the state budget with the funding.

A <u>bill signed last year</u> clarified that Zone 0 rules will apply under all fire weather conditions, as well as new and existing structures. The Board of Forestry will need to integrate Zone 0 rules with Zone 1 rules (5-30 feet from structures) to create a seamless defensible space strategy. The goal is to reduce the likelihood of a flying ember from a wildfire <u>creating a chain conflagration</u> — the cause of most destroyed structures. State officials say actions like those proposed by Zone 0 can double the chances of a structure surviving a wildfire. Homes with heavy vegetation coverage within ten feet have 115% higher wildfire claim frequency and 272% higher loss ratio than homes with defensible space.

Cal Cities will continue to advocate on behalf of cities to ensure they and their residents are prepared for wildfires. The most effective wildfire preparedness programs are collective efforts from all levels of government, with hardening at the owner, community, and landscape scales.



# Cal Cities-sponsored bond agency issues over \$23

# million in affordable housing bonds

The California Statewide Communities Development Authority (CSCDA) issued \$23,185,979 in tax-exempt multifamily affordable housing bonds for Costa Mesa.

The funds will be used to acquire and redevelop Mesa Vista Apartments. The 87 housing units will be rent restricted for very low-income and extremely low-income individuals, including those experiencing homelessness. Units will be restricted to households earning less than 30% and 50% of the area median income.

CSCDA worked with Costa Mesa and others to provide the housing bonds. The financing for the apartments requires the affordability of units to be maintained for 55 years.

### Did state subventions cause your city to exceed its

### local Gann limit?

Cities that exceed their appropriation limit for fiscal year 2025-26 must report so by Nov. 1, 2026

Due to changes in the 2023-24 State Budget, Cal Cities must provide a list of state subventions for cities each year to include in their local appropriations limits. This is a relatively new process but identifying your state subventions should be a familiar exercise. Here's what you need to know for fiscal year 2025-26.

#### What is the Gann Limit?

The Gann Limit is a result of Proposition 13 (1978) and Proposition 4 (1979), which limit the growth of government spending. It creates a cap on local government revenue that city officials can appropriate in any given fiscal year.

There is also an appropriation limit for state expenditures. The state must spend any revenue that exceeds a certain limit — adjusted for inflation and population — on K-12 education and colleges or rebates back to taxpayers.

#### What was the previous requirement?

Local agencies were previously required to identify and report any new state subventions — unrestricted money received by a local agency from the state — that would cause them to exceed local appropriations limits. The Department of Finance would count those excess amounts at the state level. City officials would count state subventions within their local appropriations limit if they did not cause the city to go over its local limit.

What is the current guidance?

The Department of Finance now calculates the individual subvention amounts for each state subvention for each city. The subvention information identifies the total dollar value of all subventions that should be included within a city's appropriations limit for the 2025-26 fiscal year.

If any portion of those values causes a city to exceed its appropriations limit, it must identify the specific, excess amount attributable to these subventions, and report that information to the Department of Finance. The state will instead include these excess amounts in its appropriations limit.

The deadline to report this information is Nov. 1, 2026. The Department of Finance will send updated subvention information for future fiscal years to Cal Cities no later than Feb. 1 of each year.

#### Where to find out information specific to your city

Cal Cities has created a resource page to house the spreadsheet provided by the Department of Finance. More details about the dollar value attributable to each subvention are in the "City Programs" tab of the spreadsheet.

Cities that will not exceed their appropriation limit for fiscal year 2025-26 do not need to report to the Department of Finance. No action is required if your city is not identified in the spreadsheet. Cities may submit their information via email to Susan Wekanda and Matt Westbrook at the Department of Finance.

Are you passionate about local control? Do you have a keen understanding of the complex issues facing California's cities and how they are responding? Consider serving on the 2025-26 League of California Cities Board of Directors. Board members play a key role in shaping both state policy and the actions of Cal Cities.

Cal Cities is accepting applications from city officials for one of six at-large board positions and second vice president. Applications are due by 11:59 p.m. on Wednesday, April 23. Below are answers to common questions about board member duties, application requirements, and the application process. For questions or assistance, please contact Zach Seals at zseals@calcities.org or (916) 658-8204.

#### What are the positions on the Cal Cities Board of Directors?

The Board of Directors includes officers (president, first vice president, second vice president, and immediate past president); 12 directors-at-large; one director elected by each of the 16 divisions; one director elected by each of the 10 departments; one director elected from each of the five caucuses; and one director designated by each of the 10 largest cities in California.

Cal Cities is currently seeking candidates for six at-large positions and second vice president. Officials from northern California are encouraged to apply for second vice president.

Who is eligible to serve on the Cal Cities Board?

To serve on the Cal Cities Board, you must be officially in city service in a member city. Second vice president candidates must currently serve or served previously on the Board of Directors.

How long are the terms of office?

At-large board members serve a two-year term and may run for reelection. The two-year term for all newly elected 2025-26 board members begins immediately upon the adjournment of the Annual Conference and Expo in October 2025.

Cal Cities officers serve a one-year term, beginning immediately on the adjournment of the annual conference. Officers customarily rotate through each of the officer positions for a total four-year commitment.

When are board meetings?

The Board of Directors typically meets every quarter at locations throughout the state. Officers and directors are expected to attend *all* meetings. A preliminary list of meeting dates is below.

- **December 2025**: This meeting is generally held in conjunction with League Leaders. During the event, leadership from departments, policy committees, divisions, caucuses, and the Board meet to discuss Cal Cities' advocacy priorities for the coming year.
- **February 2026**: This meeting is generally held during February at a location selected by the Cal Cities president.
- April 2026: This meeting is held immediately following the City Leaders Summit. This is a
  special opportunity for local officials to promote the importance of local issues to the
  Legislature and the Administration.
- June/July 2026: This meeting is generally held in late June or July.
- **September 2026**: This meeting is held in conjunction with the Annual Conference and Expo.

Cal Cities will communicate the meeting dates, times, and locations when finalized.

#### How are travel expenses handled?

In general, Cal Cities pays actual and necessary travel expenses incurred by directors attending the regular two-day board meetings. Cal Cities *does not* pay the expenses or the registration for Cal Cities' conferences or institutes — including the Annual Conference and Expo — on the theory that as a city official, each director is already attending the event at the expense of the director's city.

Expenses incurred by Cal Cities on behalf of the director, along with direct reimbursements, are reportable to the Fair Political Practices Commission (FPPC) on the director's Statement of Economic Interest (Form 700). Cal Cities will supply directors with the information necessary to submit the required information to the FPPC.

#### If I apply, how are the at-large board members and the second vice president selected?

After the application period closes on April 23, the Cal Cities' nominating committee will review all applications and select up to 12 finalists to interview for the six open at-large positions.\* The committee will interview all candidates for the second vice president position.

The nominating committee will invite at-large finalists, as well as candidates for second vice president, for an interview before the Cal Cities summer board meeting). Cal Cities staff will contact at-large finalists and second vice president applicants with their interview details. Staff will also contact those not selected as finalists.

At the Board meeting directly after the nominating committee meeting, the Board will vote to accept — in full or part — or reject the nominating committee's recommendations. If the recommendations are accepted, the Board shall consider final action (approval) on the recommended candidates at the Annual Conference and Expo (Oct. 8-10, in Long Beach).

If the Board accepts in part or rejects the recommendations, the nominating committee shall make additional recommendations. The Board can consider these recommendations at the same meeting or in a subsequent special meeting called by the president, no less than 30 days before the annual conference. The nominating committee will announce its final recommendations at the opening general session of the annual conference (Oct. 8).

What are the roles and responsibilities of the Cal Cities Board of Directors?

In accordance with the bylaws of the League of California Cities and the policies of the Board, directors have the following collective and individual responsibilities:

#### General governance responsibilities

- Determine and support the organization's vision, mission, and core beliefs.
- Select and support the chief executive.
- Ensure adequate revenues and approve a budget for effective management of the revenues.
- Assist the Board in carrying out its fiduciary responsibilities, such as reviewing the annual financial statements and the budget.
- Participate in grassroots activities in support of Cal Cities' strategic priorities.
- Support Cal Cities ballot measure fundraising activities for CitiPAC.
- Determine, monitor, and strengthen the organization's programs and services.
- Review agenda and supporting materials prior to board meetings.
- Attend all Board and general membership meetings, including periodic meetings by conference call, and notify the executive director of any planned or emergency absence and the reason for it. (Board members are only allowed three consecutive absences.)
- Serve on the nominating or other committees and offer to take on special assignments.

#### Ethical responsibilities

- Ensure legal and ethical integrity and maintain accountability.
- Use your Cal Cities position responsibly.
- Perform Board duties in good faith and with such care as necessary to promote the best interests of Cal Cities.
- Become familiar with and follow conflict of interest legal requirements and policies to promote confidence in the Cal Cities' decision-making.
- Disclose potential conflicts of interest prior to voting on any matter before the Board.

#### Communication responsibilities

- Facilitate two-way communication between Cal Cities and city officials within your sphere
  of influence (your city, neighboring cities, division, department, caucus, policy committee,
  etc.).
- Assume responsibility for interpreting Board policy to the membership. Ensure Cal Cities speaks with "one voice" once the Board has made a decision. Division and department representatives should report back regularly and directly to their members.
- Ensure that board members are aware of the views of city officials throughout the state.
- Attend all appropriate division, department, or general membership meetings.
- Seek out city officials who have the potential to strengthen Cal Cities and encourage their participation in their division, on the Cal Cities Board, etc.

#### Roles and responsibilities of Cal Cities second vice president

- Carries out the duties of the president and first vice president when they are unavailable.
- Serves as a member of the Cal Cities Executive Committee.
- Participates in weekly Executive Committee calls.
- Helps to achieve the organization's annual strategic priorities.
- Represents the Cal Cities leadership team at various events.
- Participates in Cal Cities meetings and conferences in Sacramento and around the state.
- As a member of the Cal Cities Executive Committee, attend and represent Cal Cities at the National League of Cities' (NLC) national conferences:
  - The City Summit is NLC's annual conference and is held in a different city and state each year. The 2025 City Summit conference will be in Salt Lake City, Utah, from Nov. 20-22.
  - The Congressional City Conference is NLC's legislative conference held in March each year in Washington, D.C. It is an opportunity for city officials to promote the

importance of local priority issues to Congress and the Administration. The 2026 Congressional City Conference will be held March 16-18.

- Presides over the Resolutions Committee at the Annual Conference and Expo and presents the report of the Resolutions Committee to the General Assembly at the annual conference.
- Serves as Chair for the Cal Cities Audit Committee and as a member of the Board Finance Committee:
  - The Cal Cities Audit Committee is charged with the responsibility to:
    - Select Cal Cities' independent auditor.
    - Oversee the audit contract and interact directly with the audit team.
    - Identify any audit issues and, along with the independent auditor, report these to the board.
    - Coordinate with staff to ensure the adequacy of accounting and internal control systems.
  - The Board Finance Committee is charged with the responsibility to:
    - Collaborate with Cal Cities staff on the preparation of Cal Cities' budget for Board consideration.
    - Assist with financial matters such as reviewing the mid-year financial report and other internal financial issues as they arise.
