### Garden Grove students created a study aid app — and they'll present it to Congress next month

The app was inspired by their own peers, the students said, who struggled with focus while studying

Three Garden Grove High School students will get to showcase an app they developed, a tool to help students study efficiently, to Congress next month.

Jessica Nguyen, Henry Vu and Jasmine Chau, all juniors, developed the MnewNote app which combines study techniques with a timer as a way to balance study time with breaks to maximize productivity and reduce mental burnout. They'll present it to Congress at the annual #HouseOfCode festival in April.

The app, the students said, has eight different features, including mnemonic generators and a game to stimulate focus and aid in retention.

They wanted to create a study app because they saw students in their school, particularly peers in their grade, struggling with focus, Chau said.

"The thing that deters people from studying is that it's tedious. People don't know where to start," said Nguyen. "This app provides a whole area for people to get motivation and figure out where to start."

Since students have to juggle different materials for various classes, Vu said, the app can help them manage study resources and be efficient.

The MnewNote app is not publicly available yet. Chau said they will consider publishing it in the future.

But it did recently win the 2022 Congressional App Challenge in Rep. Lou Correa's 46th district. Chau said the win was a shock and unexpected; Vu and Nguyen said they are "ecstatic."

"We are really excited to show some of the features we have on our app, to hopefully inspire Congress to invest more in these kinds of competitions to motivate students to pursue computer science," Vu said. "It's a very exciting opportunity for us."

The three students are in an AP computer science principles class, offered for the first time at Garden Grove High. To develop the app, the students had to learn to code and create graphics. And they also learned how to work together.

"They each embody the next generation of STEM leadership — and I'm so proud of each of them. There is no limit to what they will accomplish," Correa, D-Anaheim, said.

The annual Congressional App Challenge is held in participating districts for middle and high school students. The goal is to encourage students to learn to code and pursue careers in computer science.

The next round of competitions will launch in June, and eligible students can <u>pre-register</u> <u>online</u>.

# OC transportation projects on schedule despite rain, officials say

Despite recent rainstorms, Orange County transportation officials said major delays are being avoided with some of their biggest projects, such the widening of the 405 Freeway and the construction of the OC Streetcar.

With most of the Orange County Transportation Authority's projects, potential delays caused by weather are built into the schedule and the current rainy spell, while it might cause delays to the day-to-day schedule, has yet to affect the overall timelines, spokesman Eric Carpenter said. Work is continuing where possible on the 405 improvement project, he said. Lanes being added between the 73 and 605 freeways are still scheduled to be opened to drivers later this year and the overall project timeline has not changed, he said.

The \$2.09 billion widening project is turning the five-lane freeway into seven lanes for 16 miles – opening another general-purpose lane in each direction and introducing tolled express lanes. Eighteen bridges are also being upgraded as part of the project, which launched in 2018. Crews are also working around the recent storms to get Orange County's first modern-day streetcar running by next year, although some work including some rail installation has been delayed because of the rain and pooling water. The \$509 million streetcar line will run 4 miles between the Santa Ana train station and Garden Grove with 10 stops each direction.

Work on the <u>55 Freeway improvement project</u> had been scheduled only on weekdays, but anticipating the rain, crews have continued working during dry weekends to keep the schedule moving forward, Carpenter said. The \$475 million project will add a second carpool lane and a new regular lane in both directions.

The recent storms have had the most effect on emergency <u>track stabilization</u> work in San Clemente, as crew members hurry to dry out the work area between rain events, officials said. Crews have been working to install a second row of ground anchors to secure the hillside next to the coastal track. This has been difficult to complete because it is in such a low-lying area. The work in that area is currently scheduled to finish in mid-April. Passenger service has been affected since movement in the track was detected in September.

# Anti-local housing bill heads to Senate Governance and Finance

A potential expansion to <u>SB 35 (Chapter 366, Statutes of 2017)</u> — strongly opposed by the League of California Cities — passed out of the Senate Housing Committee on Tuesday. The new bill, <u>SB 423 (Wiener)</u>, is now headed to the Senate Governance and Finance Committee.

SB 423 would expand SB 35 to nearly all cities, including those in the coastal zone. It would also allow the state to approve housing developments on property it owns or leases and prohibit a city from enforcing its inclusionary housing ordinance if the income limits are higher than those in SB 35.

SB 35 forces cities to approve certain multifamily housing developments without public input or environmental review. The law includes several notable <u>requirements and</u> <u>exemptions</u>. SB 423 would eliminate the 2017 law's sunset date, which would further disincentivize lawmakers from revisiting its impacts.

Cal Cities will issue a new action alert for SB 423 in the coming weeks.

### Why Cal Cities opposes SB 423

Overarching laws like SB 423 undermine local efforts to spur housing construction. No other set of laws requires cities to spend millions of dollars developing complex, multiyear plans with their residents, which are then ultimately overridden by the state every year.

While it may be frustrating for some developers to address concerns about traffic, parking, and other development impacts, those directly affected by such projects have a right to be heard. Public engagement often leads to better projects. Removing public input will only further increase distrust and slow construction down even further.

The state will never produce the number of homes needed with a state-driven, by-right housing approval process. What is really needed is a sustainable state investment that matches the scale of this long-term crisis. Targeted, ongoing funding, like the <u>annual \$3</u> <u>billion investment Cal Cities is calling for</u>, is the only way to get Californians off the streets and keep them in their homes.



### State Bills in Brief: March 22-29

A weekly primer on the bills and committee hearings that have a direct impact on cities Policy committees are back in full swing and so is the League of California Cities' weekly "upcoming legislative meetings on bills of interest to cities" story — but with a fresh coat of paint. Each week, Cal Cities breaks down the bills, policy committees, and legislative deadlines that city leaders need to know about.

This week's two biggest bills are about housing and behavioral health care, two of Cal Cities' <u>top legislative priorities</u>. Cal Cities is also engaging with legislators on measures related to transportation infrastructure, disaster relief, and recycling. But before you dive into those measures, here's a quick explanation of each section.

The first section, "Bills to act on" is about the measures with the biggest potential impact on cities. These are the bills that city leaders need to be hyper-focused on. If your city can only act on a few bills, consider making these bills a priority. Next is the "Other bills with major impacts" section. These bills may have less of an impact, but they are still extremely important to many, or even all, cities.

Last, is the "Bills to follow" section, which may not show up each week. These bills are being closely monitored for any potential changes, but will likely have a small, limited impact on cities — if at all. Anything can change though, which means these measures could become bills to act on!

#### Bills to act on

Affordable housing and homelessness are top of mind for lawmakers, cities, and residents this year. Although legislators introduced some cooperative housing bills this session, most of them are the typical, one-size-fits-all approach. However, cities and lawmakers are much more aligned on ways to reduce and prevent homelessness.

#### SB 35 expansion advances out of committee

• **SB 35 sounds familiar.** The 2017 legislation is one of the highest-profile housing laws in recent memory. SB 35 forces cities to approve certain multifamily housing

sites. The law's <u>many requirements and exemptions</u> are detailed on page six of a 2018 Cal Cities publication.

- Just how bad is this expansion? <u>SB 423 (Wiener)</u> would expand SB 35 provisions to nearly all cities, allow the state to approve housing developments on its own property, and eliminate SB 35's sunset date. *Cal Cities opposes SB 423*.
- When is the advocacy opportunity? The bill will be scheduled for a hearing in Senate Governance and Finance in the next few weeks. A list of all scheduled hearings is available below.

Lawmakers mull more changes to the behavioral health care system

- What are the changes? <u>SB 43</u> and <u>SB 363</u> both by Sen. Eggman would make it easier to provide <u>behavioral health care</u>. SB 43 would update the definition of "gravely disabled" and SB 363 would create a real-time dashboard of available beds in psychiatric and substance abuse facilities respectively. *Cal Cities supports both measures.*
- This also sounds familiar. Sen. Eggman introduced similar measures last year as part of an <u>eight-bill legislative package</u>. Ultimately, only three were signed into law.
- When are the hearings? SB 363 will be heard in the Senate Health Committee on March 22. SB 43 will be heard on March 29 in the Senate Health Committee. Both meetings start at 1:30 p.m.

### Other bills with major impacts

This year's legislative priorities are becoming increasingly clear. These three bills have risen to the top in recent weeks, all with potentially positive outcomes for cities.

### Cal Cities-sponsored bill makes it easier to build public projects on time and on budget

- **How?** <u>SB 706 (Caballero)</u> would allow cities to use the progressive design-build process for all public projects over \$5 million. The process reduces delays, mitigates risks early, and keeps costs low.
- **Progressive what?** Often referred to as PDB, the process encourages greater collaboration between cities, designers, and contractors at the earliest stages of project development. Current law restricts the process to water projects over \$5 million in cost.
- What time is the hearing? The bill will be heard on March 29 in the Senate Governance and Finance Committee, which starts at 9:30 a.m.

### More trash talk at the Capitol

- What changes are being proposed? <u>AB 863 (Aguiar-Curry)</u> would increase penalties associated with the violating state's <u>carpet stewardship program</u>, a waste diversion and recycling program. <u>SB 615 (Allen)</u>, among other things, would require all electric vehicle traction batteries to be recovered and reused, repurposed, remanufactured, or recycled at the end of their useful life.
- What is Cal Cities' position? Cal Cities supports AB 863 and supports SB 615 in concept. Notably, SB 615 would require manufacturers, dealers, and dismantlers to be responsible for end-of-life management.
- When are the hearings scheduled? AB 863 is set for March 27 in the Assembly Natural Resources Committee at 2:30 p.m. SB 615 will be heard in the Senate Environmental Quality Committee on March 29 at 9 a.m.

### Bills to follow

The exact details of various pieces of legislation are still being hammered out. Cal Cities does not yet have a position on the bills below but will likely issue one later in the year.

### Three climate bonds to watch

- What are the bills? <u>SB 867 (Allen)</u>, <u>SB 638 (Eggman)</u>, and <u>AB 1567 (E. Garcia)</u>.
- What do they do? These three measures collectively propose \$20 billion in bonds for safe drinking water, wildfire prevention, drought preparation, flood protection, and extreme heat mitigation.
- When are the hearings? SB 867 and SB 638 will be heard on March 28 in the Senate Natural Resources and Water Committee, sometime after 9:30 a.m. AB 1567 is scheduled for April 18 in the Assembly Water, Parks, and Wildlife Committee.

### Container redemption program could be expanded

- What new items are included? <u>SB 353 (Dodd)</u> would expand the California Beverage Container Recycling and Litter Reduction Act to include any size container of 100% fruit juice. The bill also makes some changes to how payments are processed.
- Why it matters. The state-funded program cannot keep up with tumultuous scrap prices.
- What time is the hearing? SB 353 will be heard on March 28 during the Senate Natural Resources and Water Committee. The hearing starts at 9:30 a.m.

### Potential solar energy permitting mandate on the horizon

- What changes are being discussed? Current law prescribes and limits permit fees for residential and commercial solar energy systems, which expire on Jan. 1, 2025. <u>AB 1132 (Freidman)</u> would extend that repeal date to Jan. 1, 2034.
- When is the hearing? The bill will be heard on March 29 in the Assembly Local Government Committee, which starts at 1:30 p.m.

### Bill mandates region-wide seal level rise plan for San Francisco Bay cities

- What does it do? In addition to mandating a local coastal program, <u>SB 272</u> (Laird) would require cities that receive approval for sea level rise planning and adaptation to be prioritized for related funding for the implementation of projects in their approved sea level rise adaptation plan.
- What day is the hearing? SB 272 will be heard on March 28 in Senate Natural Resources and Water, which starts at 9:30 a.m.

### Guide to Local Recovery Update: March 22

The U.S. Department of Transportation announced the opening of an electric vehicle charging and alternative-fueling infrastructure grant program and the Local Infrastructure Hub is hosting a series of infrastructure webinars. Also, the National League of Cities is seeking feedback on how to simplify the federal grant process.

#### New EV charging program and alternative-fueling grant program

The U.S. Department of Transportation is accepting applications for a new \$2.5 billion electric vehicle (EV) charging and alternative-fueling grant program: the <u>Charging and</u> <u>Fueling Infrastructure Discretionary Grant Program</u>.

Established by the Bipartisan Infrastructure Law, the program will support projects in urban and rural communities, particularly in underserved and disadvantaged communities, as well as those in designated <u>Alternative Fuel Corridors</u>. Projects in low-and moderate-income communities that disproportionately experience the consequences of climate change and other pollutants are a <u>key focus of the program</u>. The new program builds on the state-operated <u>National Electric Vehicle Infrastructure</u> (NEVI) Formula Program. The Federal Highway Administration recently <u>published</u> the final rule establishing minimum standards and requirements for NEVI-funded projects. <u>Applications</u> for the charging and fueling infrastructure program are due by May 30, 2023.

Local Infrastructure Hub recovery webinars

The Local Infrastructure Hub — a partnership between several local government associations — announced a slate of <u>recovery webinars</u> focused on electric vehicles (EV), energy conservation, and street safety.

On March 30, attendees will learn about <u>upcoming EV grant opportunities</u> and the best strategies for securing funding. <u>April 4</u> will focus on the <u>Energy Efficiency and</u> <u>Conservation Block Grant Program</u>, which over 200 cities in California are eligible for.

Do you have ideas about how to make the federal grant process easier?

The National League of Cities is seeking feedback on how the federal grants and awards process can be simplified and made easier for municipalities. The <u>survey</u> takes approximately five minutes to complete.
