

CITY COUNCIL APPROVES PROJECT AGREEMENT FOR NEW POLICE FACILITY, CIVIC CENTER IMPROVEMENTS

At the Tuesday, March 26, 2024 regular Garden Grove City Council meeting, the city council approved a project agreement with Edgemoor Infrastructure & Real Estate for the design and construction of a new public safety facility for the Garden Grove Police Department, a new parking structure, and a redesigned Civic Center Park. Known as the Garden Grove Civic Center Revitalization Project, the project is estimated to cost \$152 million that includes funding from a 1% sales tax (Measure O).

"This state-of-the-art public safety facility and redesigned Civic Center Park are long overdue, and they will allow the City to continue to meet the community's public safety and quality-of-life needs well into the future," said Garden Grove Mayor Steve Jones.

"The new public safety facility will replace the current 67-year-old building, which was built when the city had fewer than 45,000 people and 22 officers. Today, Garden Grove is home to 172,000 residents and has 183 officers and 84 civilian staff. A modern police headquarters will consolidate staff to better serve the community more effectively and efficiently," said Garden Grove Police Chief Amir El-Farra.

Encompassing approximately 2.75 acres, the new three-story public safety facility will include a 103,000 square-foot building and a four-level parking structure. The existing police station will remain operational during the construction period with no interruption to services.

The redesigned Civic Center Park will encompass approximately 2.7 acres and include open green space, a memorial grove, a walking trail, and an event lawn.

"Edgemoor has valued our close collaboration with the City of Garden Grove to achieve this milestone on the project," said Edgemoor Managing Director Brian Dugan. "Our team is excited to continue working with the City to deliver this transformative new facility that creates a safe and welcoming environment for both public safety personnel and the Garden Grove community."

The agreement with Edgemoor Infrastructure & Real Estate reflects an innovative public-private partnership (P3), which streamlines the development process.

FREE COMPOST GIVEAWAY TO GARDEN GROVE RESIDENTS

On Saturday, April 13, 2024, from 8:00 a.m. to 10:30 a.m., the Garden Grove Sanitary District and Republic Services will host the annual Compost Giveaway, offering residents up to 60 gallons of nutrient-rich compost for free. The event will be held at the Garden Grove Municipal Service Center, located at 13802 Newhope Street. The event is open to Garden Grove residents only. Proof of residency is required.

The distribution will be held in the center's parking lot on a first-come, first-serve basis. Vehicles must enter from A Better Way, accessible from Anabel Street, north of the Garden Grove Municipal Service Center. Due to the popularity of the free event, residents should expect long lines.

Residents must bring their own containers or buckets and are limited to 60 gallons per vehicle. Bags are not permitted.

The annual Compost Giveaway is one way the Garden Grove Sanitary District and Republic Services thank the community for participating in the state-mandated Organics Recycling program, enabling residents and businesses to recycle all food waste, food-soiled paper, and yard waste in their organics cart.

Which of the retail theft bills do city leaders need to know about?

Lawmakers have introduced a whopping 30 bills on retail theft this year. Cal Cities is <u>front and center</u> on this issue, having testified in <u>committee hearings</u> on most of the measures. Cal Cities is also working with a <u>broad coalition</u> to ensure their success. So far, the legislation broadly falls into four categories: organized retail theft, cross-jurisdictional issues, repeat offenders, enhanced penalties, and online resellers. But the biggest measure by far is <u>AB 2943 (Rivas and Zbur)</u>, the main vehicle for comprehensive reform.

The current version of AB 2943 proposes several changes, including creating a new crime for retail theft, extending the sunset date on the organized retail theft statute, allowing for collaborative courts and diversion programs, and permitting police to arrest shoplifters without witnessing the crime.

Crucially, the bill would not make any changes to Proposition 47, which changed some nonviolent offenses to misdemeanors. Cal Cities has worked closely with the author to address concerns raised by city officials and is expecting amendments in the coming days. Cal Cities will issue a formal position after the Board votes on the issue in mid-April.

AB 2943 is just one of the many measures Cal Cities has provided feedback on. The others — listed below — are all supported by Cal Cities.

Organized retail theft and cross-jurisdictional issues

<u>Commercial burglary</u> is at its highest rate since 2008, especially in the state's largest counties. But retail theft shot to the forefront of public consciousness last year after <u>videos of smash-and-grab robberies</u> went viral. One retail theft ring <u>reportedly stole</u> \$8 million in cosmetics in 21 different counties.

Yet, current state law makes it difficult to prosecute these crimes across jurisdictions and appropriately punish offenders. Lawmakers have introduced several bills aimed at reducing organized retail theft, including:

- AB 1802 (Jones-Sawyer) Crimes: Organized Theft Cal Cities Position: Support
- AB 1972 (Alanis) Organized Retail Theft: Cargo

Cal Cities is also supporting two measures that would remove some cross-jurisdictional hurdles. <u>AB 1779 (Irwin)</u> would allow prosecutors to file charges for offenses committed in different counties. <u>AB 1794 (McCarty)</u> would allow prosecutors to aggregate multiple thefts with several victims.

Enhanced penalties and enforcement

Identifying and treating the causes of crime — such as employment or disinvestment — often produces the best outcomes for people and businesses alike. However, accountability is also important, especially when dealing with repeated theft. As such, lawmakers have introduced several measures that would increase penalties for different retail theft-related actions. SB 1242 (Min) would create higher penalties for people who commit arson to attempt retail theft. SB 1416 (Newman) would enhance sentencing for professional organized retail theft, particularly large-scale resale. AB 1960 (Soria) would impose stiffer penalties for property loss or damage that occurred during a felony. Other key bills include:

- AB 1990 (Carrillo) Criminal Procedure: Arrests: Shoplifting Cal Cities Position: Support
- AB 2438 (Petrie-Norris) Property Crimes: Enhancements Cal Cities Position: Support
- AB 2814 (Low) Crimes: Unlawful Entry: Intent to Commit Package Theft Cal Cities Position: Support

Legislators introduced several sentencing bills targeted specifically at repeat theft. Both <u>AB 1772 (Ramos)</u> and <u>SB 923 (Archuleta)</u> would reinstitute penalties for repeat theft eliminated by Prop. 47. If passed, the bills would go to voters for approval. Cal Cities is also closely following and supporting two other measures focused on misdemeanor retail theft: <u>AB 1787 (Villapudua)</u> and <u>AB 3109 (Muratsuchi)</u>.

Online resellers and fencing stolen property

One major hurdle to reducing retail theft is how easy it is to sell stolen items through online marketplaces. There are a few measures that would help to address this problem, including:

- AB 1845 (Alanis) Crimes: Grant Program for Identifying, Apprehending and Prosecuting Resale of Stolen Property Cal Cities Position: Support
- SB 1144 (Skinner) Marketplaces: Online Marketplaces
 Cal Cities Position: Support
- <u>SB 1381 (McGuire)</u> Property Crimes: Regional Property Crimes Task Force Cal Cities Position: Support
- SB 1416 (Newman) Sentencing Enhancements: Sale, Exchange, or Return of Stolen Property

Cal Cities Position: Support

The bills propose several ways to reduce the resale of stolen property and fencing locations. These range from providing funding and task forces to identify and crack down on fencing operations, to enacting stricter sentences for people convicted of selling stolen property.

What's next

Many bills are now winding their way through policy committees and to appropriations. Legislators in both houses have until April 26 to get any bills with notable fiscal impacts through appropriations. Some bills were recently modified using the gut-and-amend process, which allows lawmakers to replace the wording of a bill with something entirely new.

Policy committee hearings are great opportunities for city officials to voice their support or opposition to a particular bill. Starting next week, Cal Cities will break down the biggest bills scheduled for hearings each week in its State Bills in Brief series.



Well-intended 'granny flat' bill leaves cities holding the bag

SB 1164 is one of several revenue measures to watch this year

Cal Cities is opposing a measure that would exempt new accessory dwelling units (ADU) from property tax assessment for 15 years if the owner makes a "good faith effort" to ensure the unit will be used as residential housing. With the number of "granny flats" surging, this bill could have a significant negative impact on local government revenues.

According to the bill's author, Sen. Josh Newman, the goal of SB 1164 is to incentivize ADU production. The author's office argued in a February fact sheet that an increase in property tax is a "substantial disincentive" to the construction of new ADUs, but this does not seem to be backed up by the numbers.

Over the last few years, permits for ADUs have increased year over year. The same goes for completed units. In fact, demand for ADUs is high, with permitted projects more than double the number of units built.

Many cities use these taxes to deliver critical public services, such as police, fire protection, and education. Creating a new property tax assessment exemption will deprive cities of the revenues they need to provide and expand communitywide services.

While the measure is well-intended, cities cannot afford any erosion of local tax revenues. SB 1164 is one of a handful of revenue-related measures to watch this year. Other bills include:

- AB 2854 (Irwin) Bradley-Burns Uniform Local Sales and Use Tax Law Cal Cities Position: Pending Board Action

- SB 1494 (Glazer) Local Agencies: Sales and Use Tax: Retailers Cal Cities Position: Oppose

Cal Cities moves recovery housing reform

Cal Cities is leading the charge on four bills this session that would ensure drug and alcohol recovery facilities follow state regulations and provide high-quality treatment. The measures would address longstanding challenges facing many cities by creating more oversight and transparency that protects residents and holds bad actors accountable.

While Cal Cities has sponsored <u>similar measures</u> in the past, the Legislature and Governor have yet to pass comprehensive legislation that addresses these concerns.

The challenge

Residential <u>recovery housing</u> can provide a safe place for people to receive support and ultimately integrate back into their communities. Studies show that when done correctly, residential treatment <u>can improve patient outcomes</u> and increase completion rates. When done wrong, the opposite can happen. Patients can relapse, become homeless, and in extreme cases, die. Too many facilities in one area can also undercut one of the chief appeals of residential treatment programs: rehabilitation and support services in a therapeutic environment that is part of a community.

The Orange County Register documented many of these issues in a 2017 series titled Rehab Riviera and in the years since. The five biggest counties in Southern California — most notably Orange County — have nearly eight times as many facilities as the five biggest counties in Northern California.

Many residents have expressed concerns about the ability of the state to respond to such claims. According to *The OC Register*, there are just under 20 inspectors for the nearly 2,000 rehab centers in California. As the number of facilities continues to rise, the state faces a major hurdle in monitoring and regulating these facilities.

Four possible reforms

Recovery housing can play a key role in supporting vulnerable residents and safer communities. However, the state must also address the need for more oversight, accountability, and transparency. Compliance with state licensing laws is essential to safeguarding every person's well-being and care — both inside and outside recovery homes.

Cal Cities' sponsored measures would address these concerns while upholding the purpose and integrity of neighborhood care programs. A measure introduced by Asm. Laurie Davies and co-sponsored by Cal Cities, <u>AB 2081</u>, would require licensed treatment facilities to publicly disclose any violations on their website. <u>AB 2574 (Valencia)</u> would codify a 2019 case law that determined that unlicensed recovery homes operating as part of a licensed treatment facility located elsewhere may be considered unlawful business use within a residential zone. <u>SB 913 (Umberg)</u> would allow cities to collaborate with the state to investigate and enforce existing licensing laws. Under <u>AB 2121 (Dixon)</u>, the state would also need to notify cities when it approves a license within their jurisdiction and implement distance requirements consistent with those for other group homes.

What's next?

Legislators are out of town for spring recess. They return to Sacramento on April 1, marking the start of the legislative cycle in earnest.

Policy committees will also resume in April. These meetings are great opportunities for city officials to voice their support for Cal Cities' recovery housing package. Stay tuned for opportunities to take action and help advance these bills through the legislative cycle.
