OBJECTIVE

The purpose of this memorandum is to convey information related to the relaunch of the Foods of Garden Grove (FoGG) program (Phase 3).

BACKGROUND

In June 2021, the City introduced the Foods of Garden Grove (FoGG) program to support local food and beverage businesses impacted by the COVID-19 pandemic and to promote economic recovery in the industry. During Phase 1, the program provided direct business outreach support for 75 local small businesses. In January 2022, the City implemented Phase 2 which added an additional 75 restaurants to the program and invited a partnership with the Garden Grove School District (GGUSD) students to encourage community support through social media challenges. Over its two-year duration, the FoGG program successfully displayed the City's vibrant culinary scene, highlighting 150 eateries through photos, videos, and a foodie map.

In April 2024, the City announced its relaunch of the FoGG Phase 3 program including the on-boarding of a new marketing consultant, The Culimary CMO LLC, to further assist in expanding the list of enticing eateries, promote small business retention and assistance, and present all that Garden Grove has to offer. In addition, the consultant is working with the City to develop a new YouTube Channel and revive the City's Tik Tok account which will further our social network. Through the program, the City will continue to feature local eateries on the City website and on various social media platforms, showcasing ethnically diverse food options and crafted drinks to attract residents and visitors alike.

DISCUSSION

Starting mid-May, the City revived the FoGG Instagram account by consistently posting videos and photos to garner attention from social media users.







Eligible candidates must be United States citizens, at least 18 years of age by Election Day, and a registered voter. Mayoral candidates must live in Garden Grove and Council Member candidates must reside within the designated district boundary.

ONLINE SURVEY ADDED FOR INPUT ON HOUSING, COMMUNITY DEVELOPMENT FUNDING ALLOCATIONS

The City of Garden Grove is seeking the community's input in determining how federal funds will be used in housing, community development, and infrastructure projects. An online community needs survey addressing topics such as housing, small business programs, public transit, and quality of life, can now be accessed through the City's website at ggcity.org/neighborhood-improvement. The survey is available in English, Spanish, and Vietnamese.

The City will also host a second community workshop on Thursday, June 20, 2024, at 6:00 p.m., in the Buena Clinton Family Resource Center, 12661 Sunswept Avenue. The public is encouraged to complete the survey and attend the workshop.

The City receives approximately \$2.6 million annually from the U.S. Department of Housing and Urban Development's (HUD) Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) and Emergency Solutions Grant (ESG) programs. The allocations allow the City to provide community resources to address a wide range of unique community development needs, like financial assistance to improve homes and neighborhoods, providing decent housing, and homeless services. Feedback will be used for the City's 2025 -2030 Consolidated Plan for future HUD funding.
