**SOUTHERN CALIFORNIA GAS COMPANY NOTICE OF REQUEST TO INCREASE
RATES FOR ANGELES LINK PHASE 1 ACTIVITIES APPLICATION NO. A.25-06-011**

WHY AM I RECEIVING THIS NOTICE?

On June 12, 2025, Southern California Gas Company (SoCalGas®), filed an application with the California Public Utilities Commission (CPUC) to recover costs recorded in its Angeles Link Memorandum Account (ALMA) (A.25-06-011). The application is requesting a total increase in revenue requirement of \$24.7 million.

If the CPUC approves this application, SoCalGas will recover costs in gas rates over a 1-year period beginning after approval of the application. This will impact your monthly bill.

WHY IS SOCIALGAS REQUESTING THIS RATE INCREASE?

Angeles Link is envisioned as a pipeline system dedicated to public use for the transport of clean renewable hydrogen. The final objective is to develop a system that will transport clean renewable hydrogen from regional third-party production and storage sites to end users in Central and Southern California, including the LA Basin (inclusive of the Ports of Los Angeles and Long Beach). In December 2022, the CPUC authorized SoCalGas to record costs in the ALMA up to \$26 million associated with conducting preliminary engineering, design, and environmental feasibility studies to evaluate a variety of topics, including supply, demand, end uses, pipeline configurations and storage solutions, and to analyze alternatives. This application requests recovery of actual costs associated with those activities.

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SoCalGas' application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Why am I receiving this notice?

On June 17, 2024, Southern California Gas Company (SoCalGas®) filed an application (A.24-06-005) with the California Public Utilities Commission (CPUC). The application is requesting approval of its management of savings incurred during the purchase of natural gas for its customers.

Natural gas purchases are reviewed through a mechanism referred to as the Gas Cost Incentive Mechanism (GCIM). The CPUC authorized the GCIM as a means of encouraging utilities to seek the best rates available for natural gas. Under the GCIM, a target price is set and if the utility secures a better rate, the savings are shared with customers and shareholders. If a higher rate is paid, the utility must absorb a portion of the higher rate. SoCalGas shares the savings with its “Core” customers, that is, customers who rely on the utility for all their natural gas needs, including both gas transportation and gas commodity service.

Why is SoCalGas requesting compensation?

In the latest GCIM year, SoCalGas purchased natural gas at \$74.3 million below the target price during the program period of April 1, 2023, to March 31, 2024. Using the CPUC’s formula, SoCalGas has calculated a \$13.9 million allocation for its shareholders. This means that these purchases provided customers a benefit of \$60.4 million in lower gas costs. In this application, SoCalGas requests that the CPUC approve SoCalGas’ shareholder allocation of \$13.9 million.

How could this affect my monthly gas bill?

A typical residential customer’s average monthly bill for 37 therms of gas has already increased by 0.14 cents/month, from \$66.62 to \$66.75. A typical residential customer’s monthly summer bill for 23 therms of gas has already increased by 0.09 cents/month, from \$43.63 to \$43.72. The impact on each customer and customer class has varied depending on individual usage. **If the CPUC approves SoCalGas’ request, there will be no additional change in customer rates from this application. If the CPUC approves a different allocation for SoCalGas shareholders, the difference will be credited or charged to customers through a rate change in future months.**

How does the rest of this process work?

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SoCalGas’ application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review SoCalGas' application, including the Public Advocates Office, which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. Homelessness plan unveiled

Garden Grove can point to some signal successes in recent years in dealing with the homelessness crisis.

The city has – in cooperation with Fountain Valley and Westminster – opened and is operating the Central Cities Navigation Center and the most recent annual count has shown a 39 percent decrease in Garden Grove’s population of unhoused persons.

At Tuesday’s meeting of the city council, the Five-Year Homelessness Strategy was unveiled for July 2025 to June 2030.

Four “central goals” outlined included:

- Enhancement of Communication and Community Engagement;
- Enhancement of the Service Delivery System;
- Leveraging partnerships, funding and resources;
- Improving the quality of life.

“Each goal,” according to the staff report, “is supported by specific objectives” ... prioritizing “measurable results.”

The fact that she made history – the first directly-elected female mayor in Garden Grove – compliments the fact that she’s a fourth generation resident who makes a bridge between the old days past and a possible future.

I can’t be sure exactly which policies she’ll pursue, but she’s off to a good-enough start to imagine that most voters will be doing some applauding before her term(s) is/are up.

TEMPORARY CLOSURES AT GARDEN GROVE MEDAL OF HONOR BIKE AND PEDESTRIAN TRAIL

Beginning Thursday, June 19 through Friday, June 20, 2025, the Garden Grove Medal of Honor Bike and Pedestrian Trail will undergo essential slurry-seal maintenance to enhance trail safety and ride quality. The work will result in temporary closures along the paved path.

Construction will take place over two days:

- June 19 – Between Nelson Street and Stanford Avenue and the adjoining stretch from Stanford Avenue to Nutwood Street
- June 20 – Between Nutwood Street and Lampson Avenue and the adjoining stretch from Lampson Avenue to Brookhurst Street.

CITY REMINDS COMMUNITY OF \$1,000 FINE FOR ILLEGAL FIREWORKS

The City of Garden Grove is raising awareness against illegal firework use and the enforcement of the city's zero tolerance policy in the form of a \$1,000 fine.

"On July 4, additional Garden Grove police sergeants, officers, and administrative staff will be dedicated to firework enforcement throughout the city to apprehend and cite individuals who are caught using or possessing illegal fireworks," said Garden Grove Police Chief Amir El-Farra.

Individuals caught misusing or tampering with legal fireworks will also be subject to the \$1,000 administrative fine. Multiple fines will be issued for repeat violators.

In accordance with the Garden Grove Municipal Code firework regulations, discharge of safe and sane fireworks bearing the California State Fire Marshal seal is permissible on July 4, from 10:00 a.m. to 10:00 p.m., on private property only.

To report illegal fireworks, call the Garden Grove Police Department's non-emergency number at (714) 741-5704. Be prepared to provide the address where the illegal fireworks were lit and a description of the individual(s) involved.

Call 9-1-1 for emergencies only.

Chief El-Farra also advises the community to never launch or throw any dangerous projectiles, including fireworks, at others.

The truck routing plan shall include measures, such as signage and pavement markings, queuing analysis, and enforcement, for preventing truck queuing, circling, stopping, and parking on public streets. The facility operator shall be responsible for enforcement of the truck routing plan. A revised truck routing plan shall be submitted to the planning director or equivalent position prior to a business license being issued by the city, county, or city and county for any new tenant of the property. The Community Development Director shall have discretion to determine if changes to the truck routing plan are necessary, including, but not limited to, any additional measures to alleviate truck routing and parking issues that may arise during the life of the facility.

Bill Talk: Budget blues and other legislative debates

A weekly update from Cal Cities, sorting through the state bill buzz

Lawmakers on Friday [approved a state budget](#), but the monetary machinations are far from over. The Legislature will inevitably pass changes to the budget act later this year, especially [if the federal administration pulls funding from the state](#). “The Legislature’s budget blueprint makes progress on several city priorities,” [Cal Cities Executive Director and CEO Carolyn Coleman said](#). “But there’s more work to be done.”

Underscoring that fact, the Big City Mayors coalition, alongside Cal Cities, urged the Legislature to set aside \$1 billion in annual funding for the Homeless Housing, Assistance, and Prevention program before the vote. “Lives depend on it,” the Big City Mayors group said. “Progress depends on it.”

Leaders in smaller cities have a similar message. “Cities cannot address the burden of homelessness alone,” said San Luis Obispo Mayor Erica A. Stewart, whose [city spends 3.5 million in General Fund dollars annually to reduce homelessness](#). “While we remain deeply committed to supporting our community, the lack of ongoing state funding continues to hinder our efforts and makes sustainable progress impossible.”

Similarly, Republican lawmakers [reaffirmed their priorities](#) after the budget vote, which include more money for Proposition 36 and wildfire prevention. “We’re doing \$100 million just this year [to implement Prop. 36],” said Sen. Kelly Seyarto [during a budget hearing](#). “What about the years to come? You can’t plan if you don’t have more funding.”

Negotiations over the state’s Cap-and-Trade Program are also heating up. Last week, lawmakers signaled in their [budget deal](#) that their preferred approach for negotiations is through the legislative process — most likely [SB 840 \(Limón\)](#) and [AB 1207 \(Irwin\)](#). [Cities will play a key role](#) in ensuring future funding goes to projects with proven results.

Of course, the budget is far from the only thing going on at the Capitol. Here are six other legislative proposals that city leaders need to know about.

[Sea level rise, disaster aid, and fire severity zones in the hot seat](#)

[AB 996 \(Pellerin\)](#) and [AB 846 \(Connolly\)](#) — both sponsored by Cal Cities — are set for hearings in the Senate Committee on Natural Resources and Water on June 24.

AB 996 would help coastal and bay cities develop mandated sea level rise plans by creating a voluntary early consultation process with the Coastal Commission to help ensure their plans are approved. The bill states that existing sea level rise assessments or plans may meet any or all the required components of the plan. AB 846 would provide cities with a voluntary, streamlined

path to secure permits from the Department of Fish and Wildlife for vegetation management. Both proactive measures have received bipartisan support and no opposition.

The Senate Governmental Organization Committee will hear another sponsored measure, [AB 262 \(Caloza\)](#), soon. The bill would help ensure Californians can receive state disaster aid if federal assistance is unavailable. AB 262 would create a parallel structure to how federal assistance is administered, which is currently lacking in state law. The proposal passed out of the Assembly 63-11, with some lawmakers voicing concern about its fiscal impact should the Trump Administration rescind some or all federal funding to California.

[SB 629 \(Durazo\)](#) would require cities to designate a very high fire hazard severity zone and adopt local ordinances for each wildfire burn area that meet specific state criteria, as well as establish enforcement programs for fire protection standards. Cal Cities has expressed concerns about the measure, as it does not align with the current fire hazard mapping process. Cal Cities is urging the author to adopt changes that would require the State Fire Marshal to make this designation, not cities. Similarly, the state should assess the overall cost before implementing such programs, which fire chiefs anticipate will be high. The bill passed out of the Senate, 29-3. The bill has not yet been set for a hearing, but cities in high-risk areas should submit a concerns letter to their legislators.

[Well-intended wildlife bill could raise costs for basic road work](#)

The Senate Transportation Committee will take up [AB 902 \(Schultz\)](#) on June 24. The measure would require cities to identify, develop strategies, and analyze ways to increase wildlife connectivity and restore degraded habitat and open space when undertaking transportation projects.

This new rule would kick in even for smaller projects, such as restriping and adding bike lanes. Cal Cities opposes the bill unless the author adopts [changes that address feasibility and funding issues](#). Cities have until July 2 to send a letter to the committee voicing their concerns.

Lawmakers in the Assembly Local Government Committee will hear [SB 346 \(Durazo\)](#) on July 2. Sponsored by Cal Cities, the bill would require short-term rental platforms, at the request of a city, to provide the address of short-term rentals listed for rent on the platform and provide cities with audit authority over transient occupancy taxes collected by the platforms.

The measure passed out of the Senate with unanimous bipartisan support late last month. Cal Cities is urging lawmakers to ensure cities of all sizes have a baseline level of information to enforce the rules for short-term rentals that their residents asked them to put in place.

Now it needs their support

Negotiations over the state's Cap-and-Trade Program are heating up. The program is set to expire in 2030, and city voices are valuable to securing future funding for climate-safe infrastructure investments at the local level.

"Cap-and-Trade funding is helping us build resilient and sustainable cities that we need for the future of this great state," said Carolyn Coleman, Cal Cities executive director and CEO, in a recent [Capitol Weekly op-ed](#). "Reauthorizing the program is also critical to accelerating the production of affordable housing and helping local governments meet the state's housing goals."

Cal Cities and other [local government, transportation, and labor partners](#) in late May urged state leaders to [prioritize climate-safe infrastructure improvements](#) during negotiations. Last week, lawmakers signaled in their [budget deal](#) that their preferred approach for negotiations is through the legislative process — most likely [SB 840 \(Limón\)](#) and [AB 1207 \(Irwin\)](#). Although state leaders will hammer out the details through the end of the legislative session, support from cities now will help ensure those investments are preserved.

How can city leaders help ensure the program helps their communities?

Cities can elevate their voices by submitting a letter of support to their legislative representatives and the lawmakers leading these discussions: Sen. Monique Limón and Asm. Jacqui Irwin. Cities can use a customizable [sample letter](#) to share how this much-needed funding could help them reach state housing production and climate goals.

Cities should emphasize the need to invest in proven projects that reduce the greatest amount of greenhouse gas emissions, make Californians safer and more resilient, and support middle-class jobs. Future investments and projects from the program should maximize emission reductions, enhance climate-safe infrastructure, bolster sustainability and resilience, and speed up progress toward climate commitments.

The Cal Cities-led coalition is calling for the Cap-and-Trade Program to invest in the following priorities:

- Local Clean Transportation Infrastructure
- Climate Adaptation Programs, Sea Level Rise, and Organic Waste Infrastructure
- Land Use/Infill Development for Affordable Housing and Sustainable Communities
- State and Regional Clean Transit Infrastructure

- State Wildfire Resilience Infrastructure

How does the Cap-and-Trade Program impact cities?

High-emitting businesses, which represent roughly three-quarters of the state's emissions, are required by the state to reduce greenhouse gases. However, they can buy a limited number of credits each year — the “cap” — from the California Air Resources Board (CARB) to cover their emissions. The process creates a market price for the credits, with auction proceeds going toward the state's Greenhouse Gas Reduction Fund.

The fund has generated roughly \$30 billion over the last ten years, often distributed to cities and others as grants for transit, rail, transportation, air quality, affordable housing, safe drinking water, and organic waste programs.

State budget deal slashes homelessness funding, threatening thousands of shelter beds and housing units

The Legislature's [budget proposal](#) this year falls noticeably short on one of the state's biggest challenges: homelessness. [And city leaders throughout the state are sounding the alarm.](#)

"Cities of all sizes are investing their own dollars to support our unhoused residents and connect them with the services they deserve, but without a strong investment from the state, their efforts are unsustainable," said Cal Cities President and Rancho Cucamonga Mayor Pro Tem Lynne B. Kennedy.

Cal Cities and its allies have long urged state leaders to invest a minimum of \$1 billion in ongoing funding for the Homeless Housing, Assistance, and Prevention (HHAP) grant program. But the legislative budget deal doesn't just provide another one-time allocation. Lawmakers want to cut the program's funding — the primary source of homelessness funding for many communities — by half.

That's if legislators follow through on their promises. The deal includes nonbinding intent language that would direct \$500 million to the HHAP program for Fiscal Year 2026-27. This means no new funding for homelessness this year — and no guarantee of funding.

Why it matters

The implications of these cuts are potentially devastating, with California's largest cities projecting the loss of 3,250 shelter beds, reduced outreach services for over 12,500 individuals, and stalled development for over 2,250 housing units as a direct consequence.

HHAP investments have shown promising results. The number of homeless Californians increased by just over 3% in 2024 — a much lower rate than the nation overall and lower than 40 other states. Continued investments have helped slow the growth of California's homelessness crisis. And while there is still a long way to go with more than 180,000 people still experiencing homelessness in the state, now is not the time to yank funding.

The budget deal also reduces a 2025-26 appropriation to the Encampment Resolution Fund by \$100 million. This comes as Gov. Gavin Newsom calls on local governments to do more to address encampments on public property, even releasing a model encampment ordinance for cities and warning that state funding could be withheld if cities refuse to act.

[A press release sent by Cal Cities](#) on Wednesday outlines the ways cities throughout the state are addressing homelessness — with and without HHAP funding. “All people have value. Regardless of income, our residents should be able to afford groceries, pay their light bills, and above all else, have a place to call home,” said Eureka Mayor Kim Bergel. “California cities of all sizes are committed to reducing homelessness and providing services, but our efforts alone are not enough.”

What's next?

Lawmakers sent the budget to the Governor's desk on Friday. He has until June 27 to sign, veto, or “blue pencil” (line-item veto) the bill. But this year's budget negotiations are not over. There will inevitably be “budget bill juniors” (budget bills to amend previous budget acts) and budget trailer bills that reflect their agreements. Cal Cities is working closely with legislative leaders, the Governor's Office, and coalition partners to advocate for full restoration of HHAP funding and push for a long-term funding commitment.



State budget deal threatens to upend years of progress on homelessness, warn city officials

Sacramento — City officials from throughout the state are sounding the alarm over the lack of certainty regarding homelessness funding in the 2025-26 State Budget. As legislative leadership and the Governor negotiate a final budget deal, city leaders are calling for an immediate and ongoing investment of \$1 billion in the state's flagship Homeless Housing, Assistance, and Prevention (HHAP) grant program.

"Cities of all sizes are investing their own dollars to support our unhoused residents and connect them with the services they deserve, but without a strong investment from the state, their efforts are unsustainable," said **League of California Cities President and Rancho Cucamonga Mayor Pro Tem Lynne B. Kennedy**. "If the state fails to invest in homelessness funding, homelessness programs statewide will be upended, and the lives of thousands of unhoused residents will be endangered. Our cities are doing the work. Our residents expect the state to step up and invest to the scale of this crisis."

The current legislative budget deal includes zero funding for homelessness in the 2025-26 budget and only an intent to fund HHAP — a key source of state funding for many communities — to only half its normal levels in 2026-27. Any reduction in funding may lead to interruptions in the vital services cities provide to unhoused residents. City leaders throughout the state are expressing their alarm over the absence of funding.

"While I am encouraged by the Legislature's intent to fund HHAP in 2026-2027, doing so at half of the amount of previous rounds jeopardizes the progress we've made on addressing the homelessness crisis," said **Riverside Mayor Patricia Lock Dawson**. "If Round 7 is cut in half, Riverside would lose more than 100 shelter beds, 35 housing units, and vital rental assistance and support services for nearly 100 households. That means people could be forced onto the streets almost overnight, threatening to undo years of progress."

[Federal](#) and [state](#) reports demonstrate that targeted and sustained funding leads to decreases in homelessness. With a permanent, ongoing source of funding, cities of all sizes could develop long-term solutions that help the most vulnerable residents. Long-term, reliable funding would result in greater regional collaboration and more informed policymaking, allowing cities to build momentum and drive progress.

"Cities cannot address the burden of homelessness alone," said **San Luis Obispo Mayor Erica A. Stewart**. "Here in San Luis Obispo, we have doubled our local contribution in recent years to over \$3.5 million annually from our general fund to reduce homelessness. While we remain deeply committed to supporting our community, the lack of ongoing state funding continues to hinder our efforts and makes sustainable progress impossible."

Cal Cities' [homelessness survey data](#) highlights the scale of this challenge: 85% of cities have launched programs to address homelessness, yet 68% report that the number of individuals entering homelessness exceeds their ability to achieve a net reduction. The uncertainty of state

support and growing financial strain threaten the sustainability of local efforts. In fact, 93% of cities expressed concern about maintaining current services over the long term.

“The City of Long Beach has leveraged state HHAP dollars efficiently, and we are seeing real results that are saving lives,” said **Long Beach Mayor Rex Richardson**. “These funds helped expand our shelter and services capacity, which contributed to a decrease in chronic homelessness. Now is not the time to take the foot off the pedal on our statewide homelessness response. We should double down on our efforts to expand housing and services to help more people permanently exit homelessness.”

Cal Cities is calling on the Governor and legislative leadership to find a permanent home in the budget for funding to prevent and reduce homelessness. The lack of homelessness funding in the current budget proposal poses an existential threat to homelessness programs statewide and endangers the thousands of unhoused residents who depend on these services.

“All people have value. Regardless of income, our residents should be able to afford groceries, pay their light bills, and above all else, have a place to call home,” said **Eureka Mayor Kim Bergel**. “California cities of all sizes are committed to reducing homelessness and providing services, but our efforts alone are not enough. We need the state to invest in ongoing funding to ensure every Californian can afford a roof over their head and access the services they deserve.”

The cities below are a small sampling of those throughout the state that are making significant progress in supporting and reducing the number of unhoused individuals in their communities. Their work provides valuable insight into how cities are responding and underscores the need for a strong partnership from the state.

Bellflower has used over \$9 million of its own money for shelter, housing, outreach services, and encampment clean-ups — including on state- and county-owned properties — and outreach efforts to fill the gaps left by larger agencies. Bellflower has not been able to access HHAP dollars but leveraged its own funding and a county grant to open the New Hope Shelter, a 50-bed shelter that connects residents with services and housing.

Modesto has invested over 3.8 million in General Fund dollars over the last two years in permanent housing, shelter, job training, outreach, behavioral health, and addressing encampments. Most recently, the city used its own funding, with contributions from the state’s Homekey program, continuum of care, and private funding, to build [Jenny’s Place](#), a 54-unit permanent housing project that cost \$23 million.

Napa combined General Fund dollars with county, state, and federal funding — including state HHAP and encampment grants — to increase housing and services and ultimately, [reduce homelessness by 26% over three years](#). The city’s partnership with the county allowed them to pool resources and more effectively utilize available funding. Nearly 90% of all residents who exited homelessness are still housed.

Salinas, home to 50% of Monterey County’s homeless population, has leveraged \$76 million in one-time grant funds to address homelessness, including building permanent supportive housing, emergency shelter, and a navigation center. Without more support, the city may need to cut many of its outreach and service programs, including the navigation center, as early as this year.

Victorville used over 4.6 million city dollars to supplement grant-funded interim housing, outreach, encampment cleanups, and the [170-bed Wellness Center](#), a first for the region. The city employs nine full-time workers to support these operations. But with no permanent, dedicated revenue source to sustain these programs, staff must continuously pursue new funding opportunities or risk tapping deeper into the General Fund.

Infrastructure gap funding bill moves to Assembly Appropriations

A bill that would make it easier for cities to fund essential infrastructure projects, [SB 74 \(Seyarto\)](#), passed out of Assembly Local Government on consent. The Cal Cities-supported bill would bridge funding gaps by offering grants that support roads, bridges, water, and other vital infrastructure projects.

Many cities struggle to fund essential projects due to financial constraints, making it difficult to meet the demands of residents and businesses. In recent years, the funding gap has worsened as construction costs have escalated. Cities now face longer timelines associated with permitting and environmental requirements, such as the California Environmental Quality Act.

“Unfunded state mandates continue to stretch our limited resources, forcing us to shift funds away from infrastructure in order to meet regulatory requirements,” Oakley Mayor Shannon Shaw told Cal Cities. “This only further delays projects that are crucial to public safety, mobility, and community well-being. SB 74 helps to bridge those funding gaps.”

Oakley is working on several projects to meet the needs of its growing population, including widening roads, building railroad overcrossings, developing parks, and constructing libraries. An overall funding gap of approximately 15% is being driven by delays caused by change orders, a lack of subcontractors, and building material shortages.

The need for more funding is pronounced in other cities throughout the state. Chino began planning a new fire station in 2022 with an estimated cost of \$13.2 million. That number has now risen to \$20.7 million, primarily due to construction costs jumping from \$750 to \$1,250 per square foot for critical infrastructure projects.

An ambitious 68-acre project known as the Clearwater East Specific Plan in Paramount has also run into delays resulting in unforeseeable costly overruns.

These are the types of projects that ensure a healthy, resilient, and connected future for Californians — but only if the necessary resources are available to complete them.

By supporting SB 74, the state would affirm its commitment to strengthening communities like Oakley and ensuring cities have the resources to deliver on critical projects and essential improvements our residents need and deserve.

The bill now heads to the Assembly Appropriations Committee. City officials are encouraged to submit letters of support.



Bill Talk: The ‘calm’ before the bill hearing rush

If things have felt “slow” on the legislative front, don’t worry: Sacramento is heating back up in more ways than one. On Tuesday, state lawmakers announced over a [dozen budget trailer bills](#) amending an earlier [budget blueprint](#). A full analysis from Cal Cities will arrive next week once the deal is officially inked, but here’s what you need to know today: There is no new money for homelessness for fiscal year 2025-26.

“Investing no new money this year and only half as much for next year will stop progress in its tracks, said Cal Cities and the California State Association of Counties [in a joint statement](#). More tents will pop up alongside highways, train tracks, and rivers, and more families will struggle.”

The announcement comes as legislators prepare to get their bills through the last round of non-fiscal committee hearings before July 18. Some measures, like housing bill [SB 79 \(Wiener\)](#), will need to survive back-to-back-to-back hearings (you read that right) to make it to a floor vote.

Some are already scheduled for hearings in late June/early July. One of the most effective ways to make your voice heard is to submit a letter through the [legislative portal](#). Key housing bill gets triple-referred

Lawmakers referred [AB 650 \(Papan\)](#) to the [Senate Housing Committee](#), where it will be heard on July 1. The Cal-Cities sponsored bill would allow cities to begin the housing element review process six months earlier than existing law and provide further clarity in the housing element review process. The Department of Housing and Community Development would need to provide specific text and analysis in its feedback to help cities bring their housing elements in line with state law. Cities should submit a letter of support for the measure, especially if their senator is on the Senate Housing Committee.

[SB 79 \(Wiener\)](#), which scraped out of the Senate by a vote of 21-13, is headed to three Assembly committees: [Housing and Community Development](#), [Local Government](#),

and [Natural Resources](#). This measure would force cities to approve by-right tall, dense residential housing [near specific transit stops](#) without public engagement, environmental review, or consideration for state-certified housing elements.

Given the tight deadline (July 18), the committees will likely hear SB 79 back-to-back in early July. The first hearing is set for July 2 in the Assembly Housing Committee. Cal Cities strongly encourages members to express opposition to SB 79, especially if their assembly member sits on any of the three committees.

Short-term rental bill is set for hearing

Legislators sent [SB 346 \(Durazo\)](#) to the Assembly Local Government Committee and Assembly Judiciary Committee. The Local Government Committee will hear the Cal Cities-sponsored bill on July 2. The measure would require short-term rental platforms, at the request of a city, to provide the address of short-term rentals listed for rent on the platform. It also provides cities with audit authority over transient occupancy taxes collected by the platforms.

Cities should submit a letter of support for the measure and contact their assembly member if they serve on either of these two committees.

Fire hazard zone bill receives hearing date

The Assembly Emergency Management Committee will review [SB 629 \(Durazo\)](#) on June 30. The bill would require cities to designate a very high fire hazard severity zone and adopt local ordinances for each wildfire burn area that meet specific state criteria, as well as establish enforcement programs for fire protection standards. Cal Cities has expressed concerns about the measure, as it could take significant resources to make very high fire hazard designations outside of the current fire hazard mapping process. Cal Cities is urging the author to adopt changes that would require the State Fire Marshal to make this designation, not cities. Similarly, the state should assess the overall cost before implementing such programs, which fire chiefs anticipate will be high. The bill passed out of the Senate, 29-3. Cities in high-risk areas should submit a letter voicing their concerns.

Metal theft prevention and zero-emission flexibility measures advance

One of Cal Cities' co-sponsored bills, [AB 476 \(Gonzalez\)](#), is set for a July 7 hearing in the Senate Business, Professions and Economic Development Committee. The bill would enhance enforcement measures against precious metal theft, such as stolen copper wiring. Metal theft has become a widespread and costly issue, impacting critical infrastructure components such as streetlights, fire hydrants, manhole covers, and electric vehicle charging stations.

The Senate Environmental Quality Committee will review [AB 620 \(Jackson\)](#) and [AB 911 \(Carrillo, Juan\)](#) on July 2. Both bills would make it easier for cities to comply with the Advanced Clean Fleet rule. AB 620 would allow rented vehicles to count towards compliance. AB 911 exempts telecommunications vehicles because it deems them as critical to community infrastructure.

If AB 620 and AB 911 look familiar, you are correct: The Governor vetoed both bills last year. But with the Trump Administration repealing much of the state's zero-emission mandates, the landscape has dramatically changed in terms of availability and prices for zero-emission vehicles. Cal Cities supports both bills.

What comes next for the Zone Zero fire rule?

The Zone Zero Regulatory Advisory Committee announced last week that it is taking more time to address concerns with the [draft Zone Zero regulation](#). The proposed rule focuses on making the space immediately around homes (zero to five feet) more fire-resistant.

Cal Cities has been monitoring the proceedings to determine Zone Zero's impact on cities and overall wildfire preparedness. Cities with concerns about the regulation should email [Legislative Advocate Jolena Voorhis](#).

The regulation was set to take effect on Jan. 1, 2023, but was delayed. Gov. Gavin Newsom ordered the Board of Forestry and Fire Protection to finalize the rule by the end of 2025 as part of a [March emergency proclamation](#).

Members of the public have raised concerns over the rule's potted plant limits and the total removal of brush and vegetation. Many worried that the regulation would effectively bar smaller and urban yards from having any vegetation and the unintended consequences this could have on the local environment.

During the June workshop, the advisory committee identified several trends, including concerns over tree and vegetation loss, a one-size-fits-all approach, the scientific information used to set the regulations, and the financial impact on homeowners. The committee emphasized that fire research shows that these types of changes increase the survivability of homes and communities from embers, which [are largely responsible for wildfire spread](#) in urban areas.

The committee determined they could not present a set of final recommendations and would need more time to do so. However, they still plan to present recommendations for finalization by the end of 2025.



Is your city using the executive order to fast-track critical wildfire preparedness projects?

Cities can submit an exemption request in 2025

Cities throughout the state can speed up their fuel reduction projects under [a March emergency order](#) made in response to the extreme firestorms that hit the Greater Los Angeles region. Known as the [Statewide Fuels Reduction Environmental Protection Plan](#) — or EPP — it expedites permitting for wildfire fuel reduction projects such as vegetation and tree removal, fuel breaks, prescribed fires, and other projects that reduce debris or brush through 2025.

The emergency order suspends the California Environmental Quality Act, the California Coastal Act, the California Endangered Species Act, and other state environmental permits. However, it contains several stipulations to minimize environmental impacts. Gov. Gavin Newsom characterized this suspension as cutting bureaucratic red tape that often slows down necessary vegetative management projects critical to preventing wildfires.

The proclamation also directs state agencies to submit recommendations for increasing the pace and scale of prescribed burns.

Lastly, the order instructs state officials to improve and expand the [California Vegetation Treatment Program](#) (CalVTP) to promote rapid environmental review for large wildfire risk reduction treatment. One such recommendation could be to expand the CalVTP to areas managed by local governments, not just state-owned lands.

How can my city take advantage of this order?

Eligible entities, such as public agencies, fire safe councils, utilities, tribes, and non-governmental organizations, can request a suspension of California's environmental laws by attesting the project will follow the EPP and that suspensions are conditioned on the project's compliance with EPP.

Projects must adhere to [Best Management Practices](#) to minimize impacts on water quality, air quality, tribal cultural resources, and other sensitive resources so as to balance the waiver of existing environmental permits. There are several requirements that must be met to secure the expedited permitting and suspension of state regulations:

1. The primary goal for vegetation removal must be for at least one of the following:
 - Removing hazardous, dead, and/or dying trees.
 - Creating strategic fuel breaks.
 - Strengthening community defensible space.
 - Building safer ingress/egress and/or reducing roadside ignitions.
 - Conducting cultural burning and/or prescribed fire treatments for fuel reduction.
 - Maintaining previously established fuel breaks.
2. The project request must be submitted in 2025.
3. Certified/licensed responsible parties will perform or supervise the work.
4. The work follows Best Management Practices and measures identified in the EPP.

Projects that are eligible for streamlining include those identified in Cal Fire Unit Fire Plans, Community Wildfire Preparedness Plans, and Utility Wildfire Mitigation Plans.

[The California Wildfire and Forest Resilience Task Force website](#) hosts the project request form, the suspension process, eligibility requirements, and technical resources. The simple two-step process includes submitting a request form and uploading geospatial information. The state will notify applicants within 30 days of completing the request form if their project is eligible.

Cal Cities encourages cities to use the executive order to help protect their communities from wildfires and to perform essential vegetation management work ahead of the fire season. Sacramento — League of California Cities Executive Director and CEO **Carolyn Coleman** and California State Association of Counties CEO **Graham Knaus** issued the following statement on the newly announced state budget deal. Initial budget summaries from the Legislature do not include funding for the Homeless Housing, Assistance and Prevention program (HHAP) in FY 2025-26, and only appropriate \$500 million in FY 2026-27, down from \$1 billion in the current state budget.

“Investing no new money this year and only half as much for next year will stop progress in its tracks. More tents will pop up alongside highways, train tracks, and rivers, and more families will struggle.

To Governor Newsom and state lawmakers: We know firsthand how hard it is to craft a budget right now. We're asking you to work with us to ensure the state's homelessness crisis doesn't get even worse. Renewing the \$1 billion in HHAP funding would be less than a third of a percent of the state's budget. Surely, for what Californians have declared to be their [most pressing issue](#), that's not an unreasonable ask.”
