RE: <u>AB 1027 (Petrie-Norris) Fentanyl Trafficking: Social Media.</u> Notice of Support

Dear Assembly Member Petrie-Norris:

The City of Garden Grove writes in support of AB 1027, which aims to prevent fentanyl poisoning by enacting more stringent data collection and storage requirements for social media companies. This small step will help law enforcement in their fight to stop online fentanyl sales and seek to address the significant number of opioid-related deaths in California.

A recent study by the Centers for Disease Control and Protection named fentanyl the deadliest drug in the United States. Fentanyl is often disguised as other synthetic opioids or drugs, then sold on the street to users who are unaware that fentanyl is a key ingredient. Users who unknowingly ingest these substances believing they are taking a less powerful drug are much more susceptible to overdose or even death. In fact, the Drug Enforcement Administration (DEA) recently released a warning on the sharp increase in fake prescription drugs containing fentanyl.

Illegal drug sellers have capitalized on the easy communication and anonymity of social media sites to target pre-teens, teens and unhoused youth. For instance, some social media platforms have chat settings designed to erase chat history after just a few hours. This makes it incredibly difficult for law enforcement to track and prosecute online fentanyl traffickers.

There is a need – and critical opportunity – for social media companies to assume a larger role in combatting the online trafficking of illicit drugs that is occurring on their platforms.

AB 1027 will require social media companies to post in their policy statement and in their biannual report to the Attorney General a general description of their policy regarding accounts that have been actioned for drug related offenses and how long information related to those accounts is retained. The bill will also require will require a social media company to retain data on the actioned content for 90 days. Finally,

AB 1027 creates a clear and designated point of contact in the Attorney General's office to direct proactive reports from social media companies related specifically to drug activity where an imminent threat to life is identified by the platform.

For these reasons, the City of Garden Grove supports AB 1027.

CITY OF GARDEN GROVE COMPLIANCE REPORT - MAY 2023

Falck Mobile Health Corp. (dba Care Ambulance) compliance data for May 2023 shows a total of **1,095 responses**, with 1067 of those being "On-Time" - Code 2 responses at **98.09% and Code 3 at 96.37%**. Total aggregate compliance average of calls (both Code 2 & Code 3) was **97.44%**

Average Response Time for all calls in the Month of May was 7 Minutes and 40 seconds.

*The provided data is "raw data" and does not include any exemption request approvals into OCFA & following graph information indicates trends in service and not intended for exact measurements (+/- 1%)

One of the major factors in regard to our compliance rate, is the increase in "destination time" or "Ambulance Patient Offload Time" (APOT) for all 911 Units. This metric measures the amount of time crews spend at a hospital from the time they arrive with the patient, up until the time they become an available resource into the 911

system. This time is heavily dependent on Hospital Staff taking over responsibility of the patient. The Orange County EMS (OCEMS) standard is 30 minutes or less in all OC Hospitals. We are continually in contact and actively working w/ OCEMS and Hospitals to alleviate crew wait times throughout Orange County. The below graph indicates APOT for Hospitals with > 15 transports in the month May for Garden Grove Units. We continue to see improvements over the past several months.

Out of the 1095 responses to emergency 911 calls for service, 765 resulted in transports. This equates to approx. **70% of total emergency responses resulting in a patient transport**.



The graph below shows the On-time vs. late calls "by hour" is provided below and indicates total calls per hour in a 24-hour period (over the month of May) with green depicting total "on-time" calls & red as total "late" (top # above each bar indicates Total Amount of calls per hour.

Peak call-time (meaning most calls of day) falls at 1200 (Noon) and lowest being 4am.





Finally, the graph to the left, assists us internally with determining the range of response times (time it takes us from call to arriving on-scene). "Response Bins" are broken into 5 bars depicting total number of minutes it took Unit to respond for total # of responses. (Example: The majority of responses fell between 6 and 9 minutes, which equaled 455 responses).

WESTMINSTER – Vào trưa thứ Tư, 21 tháng 6, Đức Giám Mục Thomas Nguyễn Thái Thành, Giám Mục Phụ Tá Giáo Phận Orange và Linh Mục Thái Quốc Bảo, Quản Đốc (Rector) Nhà Thờ Chính Tòa Giáo Phận Orange, Trưởng Ban Tổ Chức Đại Hội Thánh Mẫu năm 2023 đã đến thăm báo Viễn Đông để phổ biến và trả lời các câu hỏi về Đại Hội Thánh Mẫu lần thứ hai, một sự kiện rất quan trọng của giáo dân Việt Nam hải ngoại sắp diễn ra tại Linh Đài Đức Mẹ La Vang trong khuôn viên Nhà Thờ Chính Tòa Chúa Kitô, Giáo Phận Orange.

Viễn Đông (VĐ): Xin Đức Cha cho biết chủ đề của Đại Hội năm nay?

Đức Cha Thành: Ngày 17 tháng 7, 2021 chúng ta cử hành Lễ Thánh Hiến Linh Đài Đức Mẹ La Vang với chủ đề "Đón Mẹ Về Nhà." Năm ngoái, Đại Hội Thánh Mẫu đầu tiên với chủ đề "Cùng Mẹ, Tạ Ơn Chúa," và năm nay chúng ta chọn chủ đề "Cùng Mẹ, Lên Đường."

VĐ: Ý nghĩa của chủ đề Cùng Mẹ, Lên Đường?

Đức Cha Thành: Đề tài này lấy trong Phúc Âm Thánh Luca, sau khi được Thiên Thần truyền tin, Đức Mẹ "Xin Vâng." Sau khi xin vâng, Chúa Giêsu đã có ở trong cung lòng Mẹ Maria, và Mẹ vội vã lên đường đi thăm bà Isave. Một cách nào đó, Mẹ đem Chúa

Giêsu đến với bà Isave. Hình ảnh đó cho thấy Đức Mẹ đã mang sứ mạng truyền giáo, đem Chúa đến với bà Isave, nên trong Phúc Âm, Thánh Luca cho biết, không chỉ bà Isave mà cả đến Thánh Gioan Baotixita còn trong lòng bà cũng nhảy mừng. Cụ thể như sau: 5 giờ 30 chiều Thứ Sáu: Trước Linh Đài Đức Mẹ La Vang, tuyên bố khai mạc Đại Hội Thánh Mẫu, sau đó có tiết mục Thánh Ca đặc biệt do Youth Choir & Angelo Band đến từ Việt Nam. Tiếp theo, LM Nguyễn Khắc Hy, P.S.S. sẽ thuyết giảng đề tài "Noi Gương Đức Mẹ Trên Con Đường Truyền Giáo." Cùng lúc đó tại phòng Gym của trường học, cha Greg Boyle, S.J sẽ thuyết giảng bằng tiếng Anh cho giới trẻ.

Câu chuyện của cô Lê Tín Hương chia sẻ rất ư là cảm động, tôi đã được nghe rồi là câu chuyện Đức Mẹ La Vang ban phép lạ cho bố của cô, hồi đó không phải là người Công giáo, nhưng qua phép lạ nó đánh động tâm hồn khiến cả gia đình cô đã đến gặp linh mục xin Rửa Tội và gia nhập đạo Công Giáo, và ngày hôm nay nhạc sĩ Lê Tín Hương cũng lên đường như Đức Mẹ để rao truyền Tin Mừng cho mọi người xung quanh, nên người Công Giáo cũng nên noi gương nhạc sĩ Lê Tín Hương, lên đường chia sẻ đức tin của chúng ta và qua sự liên hệ với Đức Mẹ La Vang mà Giáo Hội ngày nay mong muốn giáo dân phải lên đường, cần phải truyền giáo, cần phải đem Tin Mừng đến với mọi người.

VĐ: Trong việc tổ chức một Đại Hội lớn lao như vậy, đòi hỏi phải có một ngân khoản lớn để trang trải chi phí. Làm cách nào để có đủ tiền trang trải?

Cha Bảo: [Có] tổ chức xổ số, vé số đã gửi về từng gia đình. Năm nay cũng gửi đến ba nơi Los Angeles, San Diego và Riverside nhờ tiêu thụ. Rất mong quý ông bà, anh chị mua giúp và gửi cuống vé về Ban Tổ Chức. Thanh niên 27 tuổi này "tự động vô" nhà người phụ nữ trong khu 12500 đường Lorna (gần ngã tư Lampson với Dale) trưa Thứ Tư, Sở Cảnh Sát Garden Grove (GGPD) ra thông báo cho biết.

Khi nạn nhân cố bỏ chạy, nghi can chụp lấy cô, "dùng tay kẹp cổ nạn nhân và bắt đầu đâm cô tới tấp," GGPD cho hay.

Cuối cùng, nghi can thả nạn nhân ra rồi tẩu thoát. Nạn nhân bị nhiều vết dao đâm trên người và mặt, GGPD cho biết.

California Supreme Court poised to resolve

key voting rights case

Jul 12, 2023

The California Supreme Court is months away from resolving a multiyear legal saga over Santa Monica's election system. The case, *Pico Neighborhood Association v. City of Santa Monica*, centers on whether the city's at-large election system dilutes the voting power of Latino voters. The plaintiffs allege that the current system is a violation of the California Voting Rights Act (CVRA) and that the city should move to district-based elections.

The League of California Cities earlier filed an <u>amicus brief</u> in support of the city, urging the court to provide a clear standard for cities to follow. The court heard oral arguments at the end of June and is expected to issue an opinion by the end of September.

Case background

The CVRA prohibits local at-large election systems that prevent minority voters from electing candidates of their choice or influencing an election. In the Pico case, plaintiffs demonstrated that Latino voters could obtain 30% voting power in one district using district voting as opposed to 14% under the current system.

The trial court ruled in favor of the plaintiffs and ordered the city to switch to by-district elections. The court noted that although Latino voters generally prefer Latino candidates, only one Latino had been elected to the city council since 1946.

The city appealed, arguing the trial court misapplied the CVRA's legal standard. The Court of Appeal reversed the trial court's ruling, determining that vote dilution requires evidence that changing a voting system is likely to make a difference in election results. The court noted that 30% is not enough to elect someone to the city council using either election system.

The California Supreme Court granted a review of the case and ordered a briefing on what a plaintiff must prove to establish vote dilution. The plaintiffs argued that vote dilution is established by proof of racially polarized voting alone or in combination with historical, socioeconomic, and political factors. Therefore, one would only need to show that a different electoral system would give minority voters the ability to elect their preferred candidates or influence election outcomes.

The city argued a plaintiff must prove a legally significant pattern of racially polarized voting and demonstrate minority voters would have a greater opportunity to elect candidates of their choice under a different electoral system.

Cal Cities' arguments

Cal Cities and the California Special Districts Association (CSDA) filed an amicus brief observing that both election methods can provide for effective and democratic local governance that supports the CVRA. The brief provided several reasons why cities may prefer a particular election method.

The brief urged the court to provide a clear, administrable standard that allows cities to choose the election system that best fits their community without fear of unjustified litigation, noting that many cities have already switched to district elections out of fear of threatened litigation. The brief also highlighted the impact to cities if the court adopts the plaintiffs' standard for vote dilution, stating that smaller cities may have difficulty attracting candidates and achieving competitive races.

The Supreme Court now has 90 days to issue an opinion.

Derek P. Cole with Cole Huber LLC authored the Cal Cities and CSDA amicus brief.



Cal Cities-sponsored bill allowing first city council pay cap increase since 1984 signed into law

Jul 12, 2023

Gov. Gavin Newsom signed a bill into law that will allow general law cities to adjust council member salaries for inflation for the first time in almost four decades. The measure is one of several sponsored by the League of California Cities this session. SB 329 (Dodd) will allow city councils to adjust their pay to reflect inflation as measured by the California Consumer Price Index. Any increases would require a majority vote of the city councils.

Government officials, policy experts, and activists often cite low compensation as a barrier to elected office.

"My priority is always the same — to make life better for Californians," Sen. Bill Dodd said. "That's the goal of my latest bill, which will remove barriers to achieving more equitable representation in local government by making it easier for public servants to balance careers and personal obligations."

Currently, city councils in general law cities may vote to receive a limited salary, not to exceed caps based on population size provided in state law. They can also increase their salary annually. This limited mechanism does not always allow salaries to stay in line with inflation.

In previous decades, the Legislature updated these numbers for inflation. These amounts have not been adjusted since 1984 despite an over 300% increase in the cost of living.

Lengthy time commitments and limited pay discourage many residents from running for office, especially low-income residents, single parents, people of color, and young people. Some council members have even resigned before their terms expired because they could not devote time to council service and support their families. SB 329 is an acknowledgment of the important work of local governments, as well as the time and dedication that public service requires. The bill was also supported by the California branch of the NAACP.



Four lessons from Santa Rosa's waste-to-energy electric bus program Jul 12, 2023

#LocalWorks

Every time someone flushes a toilet in Santa Rosa,

they're indirectly powering one of the city's electric buses. Wastewater travels to the Laguna Treatment Plant, where it is then treated, recycled, and sent to a nearby geothermal energy plant. That plant powers the city's charging infrastructure.



Of course, not every city has access to the world's largest geothermal field. However, every transit agency in California will need to transition to a <u>zero-emission fleet</u> starting in 2024. Here's what Santa Rosa officials learned about electric buses while building on a decades-old commitment to climate action.

Find passionate people

Santa Rosa has long been a climate action leader. The city met its ambitious <u>2005 greenhouse</u> <u>gas reduction goals</u> and reaffirmed its commitment to further cuts with a <u>2020 Climate</u> <u>Emergency Resolution</u>. It is also one of the largest cities to ban the construction and expansion of gas stations.

Officials enacted many of these policies in response to health and safety concerns. The city was the site of the devasting Tubbs Fire in 2017 and local reservoirs dropped to all-time lows during the recent drought.

"Many of the folks here were impacted substantially by things like fire [and] power outages," said Peter Martin, the city's deputy director of water resources. "Having some of the most destructive fires occur right in the heart of Santa Rosa, really brings home [the fact] that many people here have been impacted by climate change firsthand."

Leverage small changes

One of the easiest ways a city can reduce emissions is by switching to renewable energy. In 2019, Santa Rosa piloted a <u>community choice aggregation</u> program using one of the biggest energy users: the Santa Rosa Water Department. Collecting, treating, and moving water is an energy-intensive process and can account for 30-40% of a local government's <u>total energy</u> <u>consumption</u>.

That number is closer to 50% for Santa Rosa. But it also treats water for nearby cities and unincorporated parts of Sonoma County, bringing the department's total energy consumption share to approximately 75%.

It took just three months to switch city operations to Sonoma Clean Power's <u>100% renewable</u> <u>energy program.</u> "It's much like flipping a switch, that we're able to have our energy become 100% green, as opposed to the time [and capital] it takes with ... renewable energy projects," said Tasha Wright, the water department sustainability coordinator.



The city sends recycled water instead of drinkable water to recharge the nearby geothermal beds, which provide a substantial portion of Sonoma Clean Power's renewable energy. The city also provides recycled water to farmers for irrigation and urban reuse customers in Santa Rosa and Rohnert Park.

During most years, the city reuses 100% of the recycled water produced at the Laguna Treatment Plant. In fact, the city has decreased overall water usage by 14% since 1990 despite a 57% increase in population.

Thanks in part to the geothermal plant, Santa Rosa is one of the few cities on track to beat the state's clean-energy goals. That energy keeps the city buses rolling and allows the city to thoughtfully pursue other clean energy projects.

Invest in grants and partnerships

At full operation, the city has 29 buses in its fleet. Four of those buses are now electric and the city has received funding for 17 more. Each bus costs \$1.2 million before vouchers or rebates. The city can currently charge up to 10 buses but plans to build more charging infrastructure.

The self-funded transit agency pulled together a mosaic of grants to fund the transition. "This is expensive," said Rachel Ede, the deputy director of transportation and public works. "Between developing the charging infrastructure and the additional costs of the vehicles, there is no one funding source that's going to get you there. For agencies and organizations that want to be very aggressive in the transition, it's going to take a real menu of funding options to get there. And probably multiple different applications."

The transportation sector is one of the <u>largest contributors to total greenhouse gas emissions</u>. Slashing tailpipe pollution — assuming supporting policies and infrastructure are in place — will dramatically lower emissions. And on the surface, an electric bus is the same as a diesel bus. It has wheels and it rolls. In theory, it's an easy switch.

But cities face three key challenges that consumers do not. For starters, the technology simply does not exist for most municipal vehicles. For the technology that does exist — like electric buses — there are few qualified service technicians.

"It basically makes the people who used to change the tires a full-blown electrician — it's completely different," said Fleet Superintendent Zach Brand. "We've been working on training our staff for a couple of years, and if you're not from the factory and getting factory training, you are struggling to find the right training, the right people, and the right tools to work on this stuff."



Sometimes, these problems can be quickly fixed. Officials had some concerns about the range of the buses, which they resolved by "purchasing the biggest batteries we could" according to Ede.

However, there are no agreed-upon standards for electric vehicles. Every vehicle is custommade, so everything is solved through trial and error. Consequently, advance planning and partnerships with local energy providers, manufacturers, and other agencies are critical to success. Taking a phased-in approach and leveraging lessons learned from other agencies is also important.

"It's worth the time and investment to get some technical assistance and do some feasibility planning and really lay out the steps both on the charging infrastructure side and vehicle procurement side to make sure that there is the overall capacity to deliver the program," Ede said.

An electrifying future

These challenges are not going away. Cities will likely face the same issues once the technology becomes available for other fleet vehicles, such as dump trucks. Santa Rosa will need more charging facilities, energy, and resiliency measures to fully electrify its fleet. The city will also need to make tough choices about who gets to charge first and when.

However, staff are excited about the transition. It's the right thing to do, residents want it, and the city is on track to exceed the state's climate goals thanks to the geothermal field. It would not be the first time Santa Rosa has led the way with its climate programs.

The only question is will they get the funding and support needed to succeed?

State Bills in Brief: July 12-14

A weekly primer on the bills and committee hearings that have a direct impact on cities Friday is the last day for lawmakers to get their bills through policy committees. Those that don't will have to try again next year. Although most measures made it through with little fanfare, there were a few, potentially blistering moments.

For a few hours, it seemed like SB 423 (Wiener) would die in the Assembly Natural Resources committee. The Cal Cities-opposed bill would expand SB 35 (Wiener, 2017) to all cities. The law forces certain cities to approve certain multifamily housing projects. Environmental groups, the California Coastal Commission, and Assembly Natural Resources Committee Chairperson Luz Rivas worried that the bill did not do enough to protect coastal developments from floods and fires.

Sen. Wiener agreed to revise the bill's language and the measure passed over the chair's objections — a rarity in California politics. The changes did not address Cal Cities' concerns.

SB 43 (Eggman), a measure that would update the definition of "gravely disabled" and make it easier to provide behavioral health care, passed out of the Assembly Judiciary Committee — arguably the bill's biggest hurdle so far. Cal Cities supports the bill. Sen. Eggman introduced a similar measure last year, which ultimately died in the same committee.

Another Cal Cities-supported measure by Sen. Eggman, SB 363, moved to the Assembly Appropriations Committee. The bill would create a real-time dashboard of available beds in psychiatric and substance abuse facilities respectively. SB 363 still faces an uphill battle; a similar measure died in Assembly Appropriations last year. Both bills are also supported by a range of organizations, including the Big Cities Mayors coalition and mental health care advocates.

Barring a second suspense file in September, this is the last State Bills in Brief for 2023. To stay updated on floor votes and any bills that make it to Gov. Gavin Newsom's desk, subscribe to *Cal Cities Advocate*. Cal Cities will also hold a July 19 briefing on the remaining priority bills and how city officials can ensure cities are heard loud and clear in the last four weeks of the legislative session.

Bills to act on

With the state budget officially signed, Cal Cities has turned its attention to other possible funding sources for affordable housing.

Cal Cities rallies behind a \$10 billion affordable housing bond

- A critical moment. AB 1657 (Wicks) would provide much-needed funding for affordable housing. The state's flagship Multifamily Housing Program was oversubscribed ten to one during the last round of funding. *Cal Cities supports the measure.*
- Now is the time to invest. With the slowing economy, stubbornly high inflation, and the heightened threat of an economic recession, Californians are at more risk than ever of losing their home.
- When is the hearing? The Senate Governance and Finance Committee will hear the bill on July 12.

AB 1484 would create a myriad of unintended and unpredictable consequences for temporary and regular employees

- What does the bill do? AB 1484 (Zbur) would create an overly broad definition of "temporary employee," introduce inconsistencies in the union bargaining process, and conflict with existing law for permanent employees. *Cal Cities opposes the measure.*
- Why do agencies need temporary employees? Temporary employees are just that: temporary! Cities frequently rely on nurses, election workers, lifeguards, and mosquito control technicians to meet seasonal or surge needs.
- When is the hearing? Lawmakers will hear AB 1484 on July 12 in the Labor, Public Employment, and Retirement Committee.

Other bills with major impacts

With just three days to spare, legislators heard measures related to affordable housing, public safety, and recycling on Wednesday.

More money for homelessness and affordable housing?

- Where is this money coming from? AB 531 (Irwin) is one of three bills that would collectively provide over \$25 billion in bonds for affordable housing and supportive services. *Cal Cities supports the measure in concept.*
- Why it matters. Long-term problems require long-term solutions. If voters approved all three bonds, the measures would provide twice the funding included in the 2022 State Budget for similar programs.
- When is the hearing? Legislators will debate the bill on July 12 in the Senate Governance and Finance Committee.

Proposed state housing construction agency could bypass state housing laws and local standards

- What is the bill number? AB 309 (Lee) would create a state agency that could construct and lease affordable housing. Although the intent is laudable, *Cal Cities opposes the measure unless it is amended.*
- What changes is Cal Cities seeking? Like many recent housing laws, the bill disregards the state's own mandated housing planning process and laws. Cal Cities is seeking amendments that would require the agency to follow all local zoning and objective development standards.

• When is the hearing? Lawmakers will hear the bill on July 12 in the Senate Governance and Finance Committee.

Cal Cities-sponsored measure would enshrine cities' right to deliver emergency medical services

- How is this even an issue? AB 1168 (Bennett) would reconcile *City of Oxnard v. County of Ventura*, which ruled that Oxnard lost its authority to provide prehospital EMS after signing a joint powers authority agreement (JPA) with the county.
- Why is local control important here? Signatories to JPA agreements should not lose their rights because they cooperated with other public agencies to provide better service to residents.
- When is the hearing? The Senate Governance Committee will hear the measure on July 12.

Bill seeks to reduce drug-related recidivism

- A voluntary program. AB 1360 (McCarty) would create a pilot program that would help people suffering from substance use disorders from cycling in and out of the criminal justice system with no clear path to treatment. *Cal Cities supports AB 1360.*
- Why it matters. According to the National Institute of Health and the National Institute for Drug Abuse, an estimated 65% of people in U.S. prisons and jails have an active substance use disorder (SUD). Another 20% did not meet the official criteria for a SUD but were under the influence of drugs or alcohol at the time of the crime.
- When is the hearing? Legislators will debate AB 1360 on July 12 in the Senate Health Committee.

AB 573 would increase flexibility for organic waste procurement

- What sort of flexibility is being proposed? It's narrow but important. AB 573 (Garcia) would allow some cities to send organic waste to out-of-state compost facilities to meet their SB 1383 (Lara, 2016) procurement requirements. *Cal Cities supports the measure.*
- Why do cities need this? Some cities, especially rural and border cities, must purchase and deliver compost hundreds of miles to comply with the law. This drives up both greenhouse gas emissions and ratepayer costs. The state needs 50-100 new facilities for SB 1383 to be successful, which are several years away from becoming a reality.
- When is the hearing? Lawmakers will hear AB 573 in the Senate Environmental Quality Committee on July 12.

AB 1526 clarifies how cities would be reimbursed under last year's single-use plastics law

- What does the law do? SB 54 (Allen, 2022) established a program for collecting, managing, and recycling single-use packaging and single-use plastic food service ware.
- Why do we need a second bill? Timing and scheduling constraints prevented agreed-upon language from making it into the final bill. AB 1526 (Committee on Natural Resources) clarifies the funding process and provides some flexibility around curbside collection. *Cal Cities supports AB 1526.*
- When is the hearing? The Senate Environmental Quality Committee will discuss the bill on July 12.

SCAG Receives \$237M in REAP 2.0 Funding, Allocates \$80M to Innovative Transportation Projects



The California Department of Housing and Community Development (HCD) <u>formally awarded SCAG \$237 million</u> in Regional Early Action Planning 2.0 grants earlier this week to accelerate progress toward state housing goals and climate commitments through a strengthened partnership between the state, its regions and local entities.

To kickstart the allocation of funds, SCAG launched the <u>County Transportation</u> <u>Commission Partnership Program</u> as the first Call for Applications within the REAP 2.0 grant program. This program provided a platform for the county transportation commissions in the SCAG region to submit proposals for innovative projects that align with the grant's objectives. The SCAG Regional Council on Thursday, July 6, approved the allocation of \$80 million to support 33 transportation and land-use projects across Southern California that advance sustainable communities.

The applications for the <u>Notice of Funding Available (NOFA) For Lasting</u> <u>Affordability</u> Call for Applications are **due Monday**, **July 31 at 5 p.m.** This is a competitive Call for Applications, with an estimated budget of \$45 million available through REAP 2.0. This program will award funding for projects in any of the following categories that meet the infill definition:

- Consulting assistance and funding to establish or enhance the impact of housing trust funds, community land trusts, catalyst funds or revolving funds, with the goal of aiding non-profit organizations in providing and maintaining affordable housing at a regional scale.
- Actions and projects can include developing or increasing organizational capacity for a trust or fund including developing or expanding existing loan products or funding tools to fund eligible activities outlined in the Programs to Accelerate Transformative Housing (PATH) program guidelines.

HCD's Prohousing Incentive Pilot Program: SCAG Jurisdiction Highlights



Three SCAG cities lead the region's prohousing efforts as they receive part of \$33 million in funds from HCD's Prohousing Incentive Pilot (PIP) Program along with 15 other jurisdictions: City of Riverside received \$2,440,000; City of Needles received \$445,000; and City of Los Angeles received \$4,900,000. PIP awardees will utilize these funds for activities such as promoting housing construction near transit, catalyzing local housing trust funds, down payment assistance for low- and moderate-income households, and much more.

Assistant City Manager and Development Services Director for the City of Needles, Patrick Martinez, stated, "The City of Needles is proud of its Prohousing Designation and would like to thank Colin Drukker of Placeworks and Gwendy Silver of SCANPH through <u>SCAG's REAP technical assistance program</u> for assisting with our Prohousing and PIP applications." Martinez stated that he looks forward to combining these funds with the city's streamlined permitting process, affordable land costs, low energy rates and economic development grant program to attract homebuilders and "build some housing for our residents."

Jurisdictions that achieved HCD's Prohousing Designation were eligible for the PIP Program as well as additional funding, points, and other scoring preferences when applying to competitive housing, community development, and infrastructure programs such as <u>Affordable Housing & Sustainable Communities (AHSC)</u>, <u>Infill Infrastructure Grant (IIG)</u>, <u>Transformative Climate Communities (TCC)</u>, <u>Solutions for Congested Corridors</u>, <u>Local Partnership Program</u>, and <u>Transit and Intercity Rail</u> <u>Capital Program (TIRCP)</u>. Additional SCAG jurisdictions working towards this exclusive designation include the cities of Adelanto, Inglewood, Long Beach, Moreno Valley, Placentia, Rancho Cucamonga and Santa Monica, and the County of Los Angeles.

<u>Housing supportive grant application technical assistance</u> offered through SCAG's REAP grant is still available for jurisdictions in need of additional support to apply for these programs and more. INFORMATION SCAG AWARDED \$237 MILLION FOR REAP 2.0

The Department of Housing and Community Development has officially approved SCAG's full funding application, <u>awarding SCAG with more than \$237 million in REAP 2.0 funds</u>.

The REAP 2.0 program is a flexible program to accelerate progress toward state housing goals and climate commitments through partnership between the state, its regions and local entities. ACTION REGIONAL COUNCIL ADOPTS UPDATED POLICY FRAMEWORK FOR CONNECT SOCAL 2024

The Regional Council today adopted an updated Policy Framework for Connect SoCal 2024 – the Regional Transportation Plan/Sustainable Communities Strategy – which advances regional priorities and confirms the direction for Connect SoCal 2024 in advance of a draft plan release in October 2023.

SCAG's Regional Council in June 2022 adopted a Policy Development Framework for Connect SoCal 2024, which outlined the draft vision and goals for the plan, identified key policy priorities and outlined the strategies for advancing those policies through the three Connect SoCal 2024 subcommittees that concluded in spring 2023.

The special Connect SoCal 2024 subcommittees dug deeper into three topics: Next Generation Infrastructure, Resilience and Conservation, and Racial Equity and Regional Planning. The updated Policy Framework reflects elements of direction and feedback received from the subcommittees over the past year.

ACTION REGIONAL COUNCIL APPROVES COUNTY TRANSPORTATION COMMISSION PROGRAM AWARD LIST

The Regional Council today approved funding recommendations for the County Transportation Commission (CTC) Partnership Program, an \$80 million competitive program developed in close partnership with CTCs in the SCAG region. The program is made possible by the recently approved REAP 2.0 funding. Through this program, SCAG will fund 33 transformative planning and implementation projects that expand access, increase mobility and bring jobs and housing closer together to achieve a more sustainable growth pattern across the region.

Project awards are split across three eligible projects categories:

- \$35 million invested in projects that increase transit ridership
- \$36 million invested in multimodal communities projects
- \$9 million invested in projects to shift travel behavior

NEWS FROM THE EXECUTIVE DIRECTOR

MULTIPLE CALLS FOR APPLICATIONS OPEN FOR PROGRAMS TO ACCELERATE TRANSFORMATIVE HOUSING

Calls for Applications are now open for two of three funding areas in the recently approved REAP 2.0 Programs to Accelerate Transformative Housing (PATH):

- The Housing Infill on Public and Private Lands (HIPP) Pilot Program is focused on the development of affordable housing at scale on available public and private land as well as development and implementation of corridor-wide or area-wide regulatory infill housing actions. The HIPP program applications are **due by July 10**.
- The Notice of Funding Available (NOFA) for Lasting Affordability provides support for innovative housing finance, trust funds, catalyst funds and new permanent funding sources. The NOFA for Lasting Affordability applications are **due by July 31**.

The Call for Applications for the third PATH funding area, Regional Utilities Supporting Housing, is expected to be released in late summer 2023. <u>Click here for more information on all PATH funding areas</u>.

SCAG RECEIVES APPROVAL OF CONFORMITY DETERMINATION

The Regional Council in June adopted Connect SoCal Amendment No. 3 and the 2023 Federal Transportation Improvement Program (FTIP) Consistency Amendment, including the associated conformity analysis. SCAG has since received accelerated federal final approval of the conformity determination.

With this approval, \$26 billion worth of important transportation projects in the Connect SoCal and FTIP Amendments can now move forward. Thank you to Caltrans, the Federal Highway Administration and the Federal Transit Administration for expedited review and approval of the conformity determination.

SCAG AWARDED LOCAL AGENCY TECHNICAL ASSISTANCE GRANT TO EXPAND BROADBAND

The California Public Utilities Commission approved SCAG's \$1 million Local Agency Technical Assistance Grant (LATA) on June 29. LATA grants support local agencies and tribes in their efforts to expand broadband service to unserved and underserved Californians.

The funding enables SCAG to advance up to three broadband projects in unserved or underserved areas. SCAG will collaborate with local jurisdictions that were unable to apply for funding or lacked the resources to engage a consultant or manage the project themselves.
