

OBJECTIVE

The purpose of this memorandum is to highlight activities of the Building & Safety Division for fiscal year 24/25.

BACKGROUND

The Building & Safety Division encompasses three units: Permit Services, Building Inspection Services, and Code Enforcement. With the close of the fiscal year, staff provides this memorandum to summarize annual division activity.

DISCUSSION

The Building and Safety Division had a busy year with each unit experiencing an increase in activity compared to the prior fiscal year. Provided below are details of FY 24/25 activities for each respective unit.

**NOTICE OF APPLICATION
SOUTHERN CALIFORNIA GAS REQUEST
TO INCREASE RATES FOR GAS LINE ALLOWANCE**

GAS LINE EXTENSION ALLOWANCE EXCEPTION APPLICATION 25-07-001

WHY AM I RECEIVING THIS NOTICE?

On July 1, 2025, Southern California Gas Company (SoCalGas®) filed its Gas Line Allowance Exception Application A.25-07-001 with the California Public Utilities Commission (CPUC) which will require a revision to rates for natural gas. The application is requesting a total rate increase in revenue requirement of \$911 thousand.

WHY IS SOCALGAS REQUESTING THIS RATE INCREASE?

In 2022, the CPUC issued a decision (D.22-09-026) eliminating gas line extension allowances, the 10-year refundable payment option, and the 50 percent discount payment option under gas line extension rules for all customer classes. In limited situations, customers may be eligible for gas line extension allowances for unique non-residential projects that meet all three criteria: (1) demonstrates reduction in greenhouse gas emission; (2) is consistent with California's climate goals; and (3) demonstrates that there is no feasible alternative to the use of natural gas, including electrification. On July 1, 2025, SoCalGas filed an application to the CPUC, on behalf of eligible customers, requesting the Commission provide gas line extension allowance to specific projects that meet the three criteria.

HOW COULD THIS AFFECT MY MONTHLY GAS RATES?

If SoCalGas's request is approved by the CPUC, SoCalGas's rates for gas service will increase. The average residential gas monthly bill using 36 therms per month would increase by approximately \$0.01 or 0.0% per month.

The table below does not necessarily reflect the changes that you may see on your bill. Changes in individual bills will also depend on how much electricity or gas each customer uses.

HOW DOES THE REST OF THIS PROCESS WORK?

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SoCalGas's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review SoCalGas's application, including the Public Advocates Office which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. On June 27, 2025, Southern California Gas Company (SoCalGas®) filed its bridge funding application for Program Year (PY) 2027 A.25-06-023 with the California Public Utilities Commission (CPUC) to extend the approved PY 2021-2026 California Alternate Rates for Energy (CARE) and Energy Savings Assistance (ESA) Program budgets for PY 2027.

WHY IS SOCALGAS REQUESTING THIS RATE INCREASE?

SoCalGas seeks approval to increase customer rates to fund the CARE and ESA Programs for year 2027. These programs assist qualified low-income customers with their energy bills and help customers use energy more efficiently. The CARE program offers eligible SoCalGas customers a 20 percent discount on their monthly natural gas bill. The ESA Program offers energy efficiency home improvement services that are professionally installed at no cost to the customer. SoCalGas seeks funding approval of \$20.7 million for 2027 to become effective on January 1, 2027.

HOW COULD THIS AFFECT MY MONTHLY GAS BILL?

If SoCalGas's rate request is approved by the CPUC, natural gas rates will increase. The Public Purpose Program (PPP) surcharge is a component of your natural gas rate which funds the CARE and ESA Program. In this application only the PPP Surcharge portion of your rate will increase. Natural gas rates will increase by \$20.7 million in 2027, compared to present rates. The average monthly residential bill of a residential non-CARE customer using 36 therms will increase from \$74.52 to \$74.69 in 2027. Compared to 2025 rates, this represents a 0.2% increase. The following tables show the change in the PPP surcharge for 2027 compared to present rates. Please note however, that CARE customers are not billed for costs associated with the CARE program.

Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review SoCalGas's application, including the Public Advocates Office which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. Major homelessness bills shelved for the year

Sen. Catherine Blakespear pressed pause on two key measures aimed at addressing homelessness this legislative session. The outcome is a mixed result for Cal Cities, which will work closely with the senator to address cities' concerns before the bills resurface next year for consideration.

SB 16 on hold amid stakeholder concerns and Cal Cities pushback

Blakespear parked [SB 16](#) after considerable pushback from Cal Cities and other homeless and affordable housing advocates. Over 50 organizations came out in opposition to SB 16 after Blakespear gutted and amended the bill to impose significant new requirements on the state's flagship homelessness grant program, the Homeless Housing, Assistance, and Prevention (HHAP) Grant Program.

SB 16 currently requires HHAP applicants to collaborate regionally on an interim housing plan to accommodate 60% of the region's homeless population by 2032. Applicants would also need to meet annual targets to continue to receive future funding. The bill included several other major changes to the program, including requiring applicants to adopt encampment ordinances and agree to city and county responsibilities.

Cal Cities opposed SB 16, which was introduced at the tail end of the legislative session and gave stakeholders little time to address these seismic changes. As written, the bill would create new long-term planning goals without reliable, long-term money to carry out these plans. In fact, [this year's state budget](#) cuts HHAP funding by half and will not fully allocate new funding until the 2026-27 fiscal year.

Over the fall, Cal Cities will work with the senator and the bill sponsors to address these concerns, while advocating for ongoing funding for the HHAP program.

Co-sponsored encampment coordination bill held due to proposed changes

Blakespear also turned another bill — this one co-sponsored by Cal Cities — into a two-year bill. In its original form, [SB 569](#) would increase communication between the California Department of Transportation and local governments to address encampments on state property.

Specifically, SB 569 would require Caltrans to establish a dedicated liaison to improve communication with local governments, set clear response timelines for encampment-related requests, and make it easier for cities and counties to take on delegated maintenance agreements.

Cal Cities co-sponsored the legislation following a 2024 executive order by Gov. Gavin Newsom that directed state agencies to adopt policies like Caltrans' to address homeless encampments. It also urged cities to adopt similar policies, warning that the state could withhold state funding if cities refuse to act.

Despite calling on local governments to act with urgency, the administration proposed last-minute changes that would have weakened the bill. Cities are committed to working with Caltrans but continue to face delays and communication barriers. In San Jose, for example, it [took the department two months](#) to address an encampment near a downtown highway.

"The way it's set up right now isn't working," said Jorge Chavez, mayor of Bell Gardens, who came to Sacramento to testify in support of the measure. "It's too long. Folks are frustrated."

Instead of accepting those changes, the author and sponsors chose to make it a two-year bill, hoping to work with Caltrans on a path forward next year.

Blakespear can bring both bills forward for consideration next year, the second half of California's two-year session.



Bill Talk: Major proposals paused, Cap-and-Trade talks begin (kind of)

A weekly update from Cal Cities, sorting through the state bill buzz

This Friday, July 18, lawmakers and Sacramento's cadre of staffers, lobbyists, and politicians will officially break for summer recess. The Legislature will reconvene on Aug. 18 to shepherd any remaining bills to appropriations, cross their fingers, and prepare for floor votes. As a reminder: [The vast majority of bills that make it to the floor pass](#). Gov. Gavin Newsom usually vetoes around one in five bills on average.

Speaking of appropriations: State officials have assigned high costs to Cal Cities' sponsored sober living and housing planning bills. The latest estimate for [AB 650 \(Papan\)](#) is at \$11.1 million annually. Cal Cities is monitoring how the state's [Medicaid-sized budget hole](#) could impact Cal Cities' remaining sponsored bills.

Sen. Catherine Blakespear also [pressed pause on two key measures aimed at addressing homelessness](#) this legislative session. The outcome is a mixed result for Cal Cities, which will work closely with the senator to address cities' concerns before the bills resurface next year for consideration.

[Homeless planning and encampment bills shelved for the year](#)

Sen. Catherine Blakespear parked [SB 16](#) for the year after opposition from Cal Cities and other homeless and affordable housing advocates. Over 50 organizations came out in opposition to SB 16 after Blakespear changed it to impose significant, new requirements to access the Homeless Housing, Assistance, and Prevention (HHAP) Grant Program. The senator decided to make SB 16 a two-year bill, meaning it could still move forward next year.

Cal Cities opposed SB 16 because it was introduced at the tail end of the legislative session and created new long-term planning goals without reliable, long-term HHAP money to carry out these plans.

Another Blakespear bill — this one co-sponsored by Cal Cities — is also now a two-year bill. [SB 569](#) would increase communication between the Department of Transportation and local governments to address encampments on state property. Caltrans suggested amendments that would undermine the intent of the proposal. Cal Cities is working with the committee and Caltrans to determine a path forward next year.

Key housing bills likely headed to appropriations

The Senate Appropriations Committee placed [AB 650 \(Papan\)](#) on the suspense file. Sponsored by Cal Cities, the bill would allow cities to begin the housing element review process six months earlier than existing law and provide further clarity in the housing element review process. The Department of Housing and Community Development would need to provide specific text and analysis in its feedback to help cities bring their housing elements in line with state law. This additional clarity would likely result in a reduction in long-term costs for both the state and local governments.

The Assembly Local Government is currently reviewing [SB 79 \(Wiener\)](#). Opposed by Cal Cities, the bill would force cities to approve by-right tall, dense residential housing near specific transit stops without public engagement, environmental review, or consideration for state-certified housing elements. The measure evolves daily, as several stakeholders are heavily engaged on the bill: Sen. Scott Wiener has adopted 10 rounds of amendments so far. Should the measure pass this week, it will head to the Assembly Appropriations Committee next.

Cap-and-Trade bills set for next week, but full debate still to come

Although the Legislature will hear two Cap-and-Trade bills, [AB 1207 \(Irwin\)](#) and [SB 840 \(Limón\)](#), this week, the proposals are expected to advance as simple accountability and reporting measures. The full Cap-and-Trade reauthorization negotiations will likely start when the Legislature returns from summer recess in mid-August. Cities can help bring valuable Cap-and-Trade dollars [back to their communities back to their communities](#) by submitting [a support letter](#) to their legislators.

Cal Cities-sponsored bill to boost enforcement of unlawful sober living homes

The Assembly Health Committee approved the Cal Cities-sponsored [SB 35 \(Umberg\)](#) on Tuesday. The measure would enhance the Department of Health Care Services' (DHCS) oversight of sober living homes that violate licensing laws. SB 35 would require DHCS to meet specific timelines for investigating allegations of unlicensed treatment services, enable counties to work with the department to conduct site visits to enforce licensure laws themselves, and require follow-up site visits to ensure unlawful activity has stopped.

Members encouraged to act on warehouse clean-up bills

Two bills that would revise the [controversial warehouse standards law](#) from last session had their final committee hearings this week. [The law](#) creates restrictions on new or expanding warehouses and requires all cities to update their circulation elements to account for these changes — including truck movement. Cities that fail to do so could face \$50,000 fines every six months from the Attorney General. The Senate Judiciary heard [AB 735 \(Carrillo\)](#) on July 15. [SB 415 \(Reyes\)](#) is awaiting a hearing in Assembly Local Government today.

Cal Cities secured important revisions to both bills earlier this session and is urging the authors to [adopt further changes](#). Cal Cities is asking lawmakers to let cities develop a plan or ordinance rather than a circulation element update, which would trigger additional general plan updates under the same timelines. Cal Cities is also urging

lawmakers to exempt cities from the circulation element update if they are not approving new or expanded logistics use projects and to address the now problematic expansion in fees that the Attorney General thrust onto local governments. Cities should submit letters to both committees in advance of the hearings expressing concerns about the continued need for clean-up legislation.

Cal Cities mural bill moves closer to the Governor's desk

A bill that would make it easier for cities to commission muralists, [SB 456 \(Ashby\)](#), is one step closer to the Governor's desk. Co-sponsored by Cal Cities, the measure would exempt muralists from state contractor license requirements when working on public and private art projects. This narrow exception would allow muralists and cities to restart stalled mural projects.

The bill passed unanimously out of the Assembly Business and Professions Committee last week and will be heard in Assembly Appropriations after the summer recess. If approved, the bill must pass off the Assembly floor before heading to the Governor's desk.

Why it matters

In 2023, the California Contractors State License Board began notifying cities that muralists must carry a contractor's license for projects over \$500. To qualify for a commercial license, muralists need to accumulate four years of specialized experience under a licensed contractor, pass the Law and Business examination, and pay licensing fees. City staff who knowingly hire unlicensed muralists can face fines.

Unsurprisingly, this forced cities to pause or outright [halt projects throughout the state](#). "These regulations have made it difficult to procure artists, as their body of work often does not align with the experience needed to obtain a C33 license," one city official told Cal Cities in March.

Earlier this year, [The Orange County Register](#) endorsed the measure as "common sense" and "worthwhile."

Muralists provide different services than a painting contractor, as their work is an artistic expression rather than changing the building's structural integrity. These requirements create unnecessary barriers to working on public art projects and expose city employees and artists to fines. By passing this bill, lawmakers would allow muralists to continue their work, beautify public spaces, and bring communities together across California cities.



Every voice matters! Appoint a voting delegate for the 2025 General Assembly

Every year, Cal Cities convenes a member-driven General Assembly to vote on policy resolutions that impact local control. The General Assembly, held this year in Long Beach on Oct. 10, is a meeting of all voting delegates — one from every [member city](#). Cities must appoint a voting delegate by Sept. 24.

[Who is a voting delegate, and what are they responsible for?](#)

A voting delegate is a council-appointed city official — elected or appointed — who represents their city at the General Assembly. Delegates play an important role during the General Assembly by voting on [resolutions](#), which if approved, become Cal Cities policy.

Voting delegates should attend the full conference through the General Assembly, which takes place on the Friday of the annual conference. However, delegates can [register](#) for just the Friday portion of the annual conference if they cannot attend the full conference.

[How does a voting delegate prepare for their role?](#)

Cal Cities wants to ensure each voting delegate understands their role. A voting delegate may want to prepare by [reviewing the Cal Cities resolutions process and General Assembly procedures](#).

Should Cal Cities receive a resolution by the Aug. 9 deadline, the resolution will be sent to member cities for council consideration. Discussing resolutions during a council meeting is a helpful way to prepare voting delegates for the General Assembly.

[How does my city appoint a voting delegate?](#)

Per Cal Cities' bylaws, every member city may designate a delegate and up to two alternates, by approval of the city council. The [voting delegate appointment packet](#) contains the necessary information cities need to appoint a delegate.

We honor that promise when the crew of Engine 21 delivers flowers to Captain Tom Wall's daughter on every anniversary of his 1993 line of duty death.

We honor that promise when we join the family of one of our fallen for an annual fishing trip in his memory, a tradition now in its 15th year for James' Jimmy O' Owen.

We honor that promise when one of our captains and his wife accompanied Ken Caley's widow, Karla, and the Caley family to Yosemite to spread Ken's ashes.

And on June 26th, we honored that promise with our Fallen Heroes Memorial, Organized and led by Chief Sheehan, Chief Medina, and the Ceremony, Awards, and Protocol Committee, the event undoubtedly had a lasting impact on all attendees. For me, it was the affirmation of the deep ties that bind us as OCFA Family and the sense that this connection begins with — and is constantly strengthened by — our collective work to protect life and property.

Standing atop the ridge on the Rancho Fire in Laguna Beach on Monday, I was awash in the stunning excellence with which we do that work.

Yes, we were in unified command with Laguna Beach Fire Department, but let's be clear: the OCFA stamp of excellence was at every level of this firefight — from 18,000 feet where the FIRIS platform (a program we created and piloted), mapped the fire in real time, to the depths of the canyon where our boots-on-the-ground firefighters battled the blaze in treacherous terrain.

Between those layers of OCFA excellence, the hellfighters of the Quick Reaction Force (another program we spearheaded), and our OCFA aircraft repeatedly hover-filled, often from a Helipad we opened just last year, ultimately dropping more than 100,000 gallons.

Moreover, weeks before the fire even started, OCFA chief officers honed their wildfire strategies by participating in an emergency tabletop exercise based on this exact scenario in this exact region.

As a result of all this OCFA innovation, training, and execution, you could hear the community's cheers as their homes were saved. Standing atop the ridge with many of those residents, it was clear that, like me, they knew they were witnessing a special response from a special agency.

As an old wildland guy, I follow the unwritten rule of never sharing it's your birthday with your fellow firefighters — good rarely comes from the admission. However, since I was "outed" by Chief Perkins in front of the entire Academy Cadre a few hours before the Rancho Fire started, I suppose it's safe to share that normally guarded information here.

Yes, Monday was my birthday, and while I enjoyed the good-natured ribbing and off-key singing from the Cadre, watching our personnel save lives and property that afternoon was truly the greatest gift of all.

For me, these are the incidents that strengthen our familial bonds beyond measure, and, as I shared at the memorial event, these are also the moments we breathe new life into the sacred oath our OCFA fallen heroes gave their lives to uphold.

As we approach peak fire season, let us continue to strengthen those familial ties by looking out for one another and building upon the public trust earned by those who came before us — especially those who made the ultimate sacrifice.

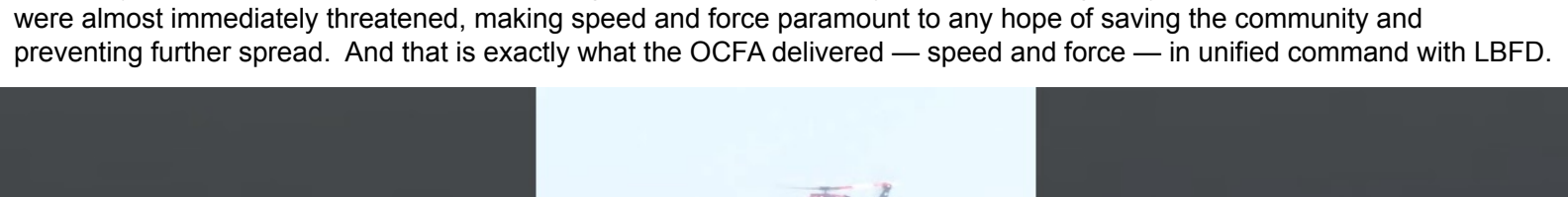

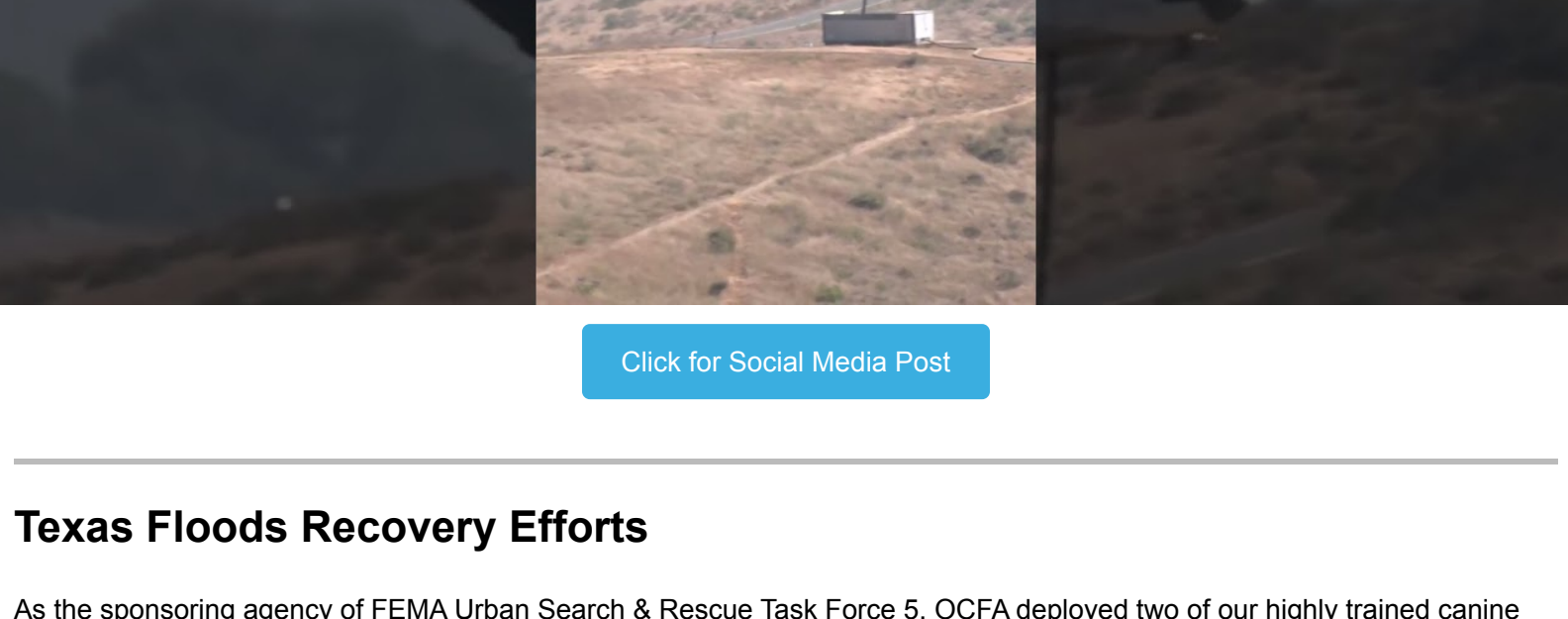

Rancho Fire

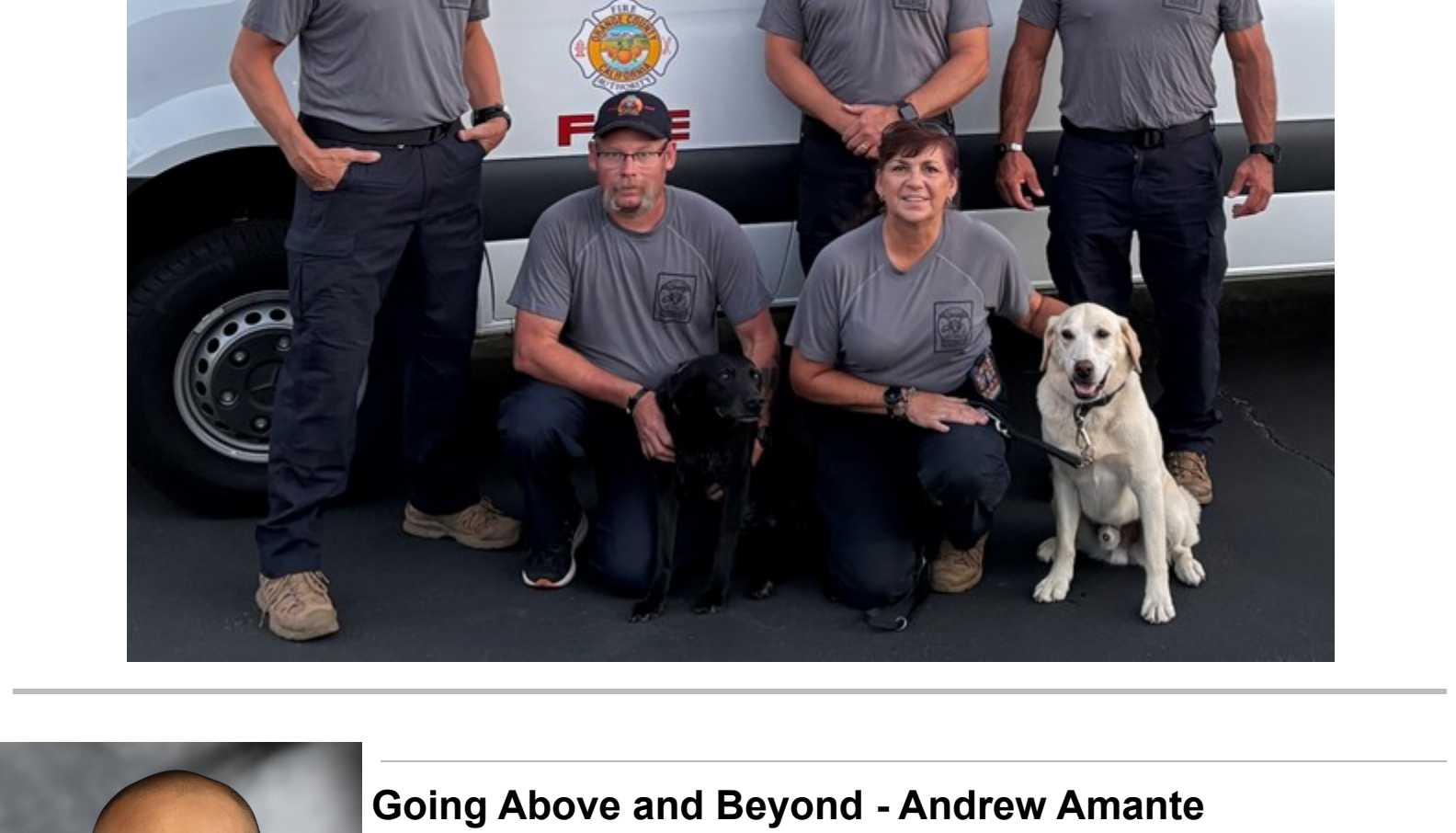

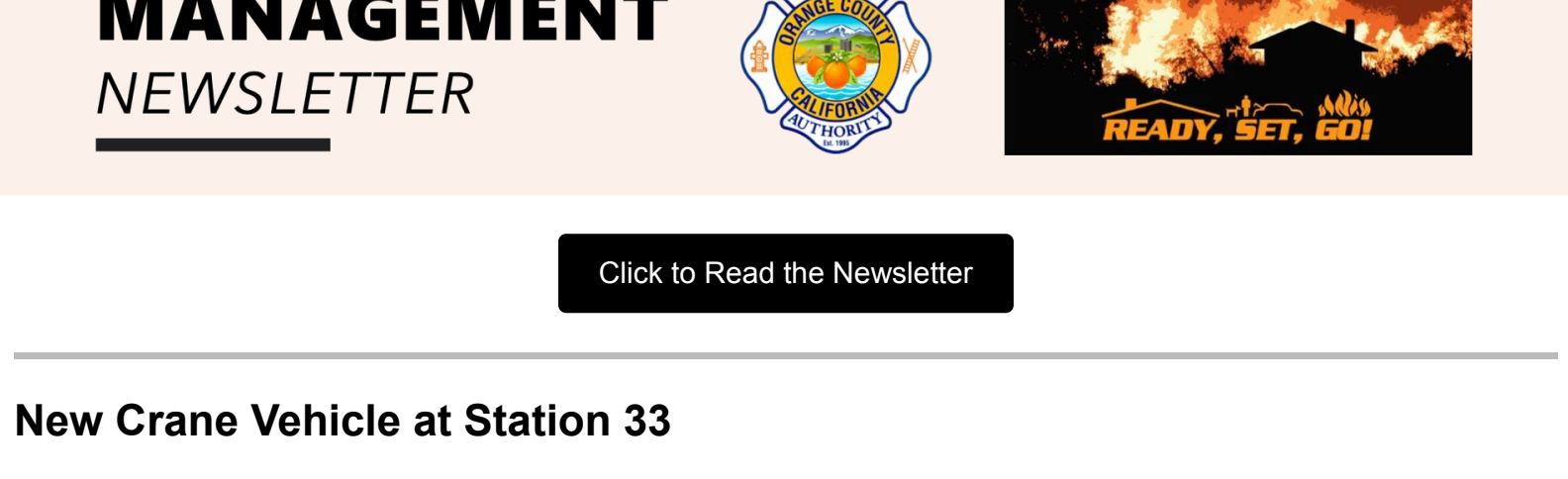
OCFA Technical Rescue Team Trench Rescue

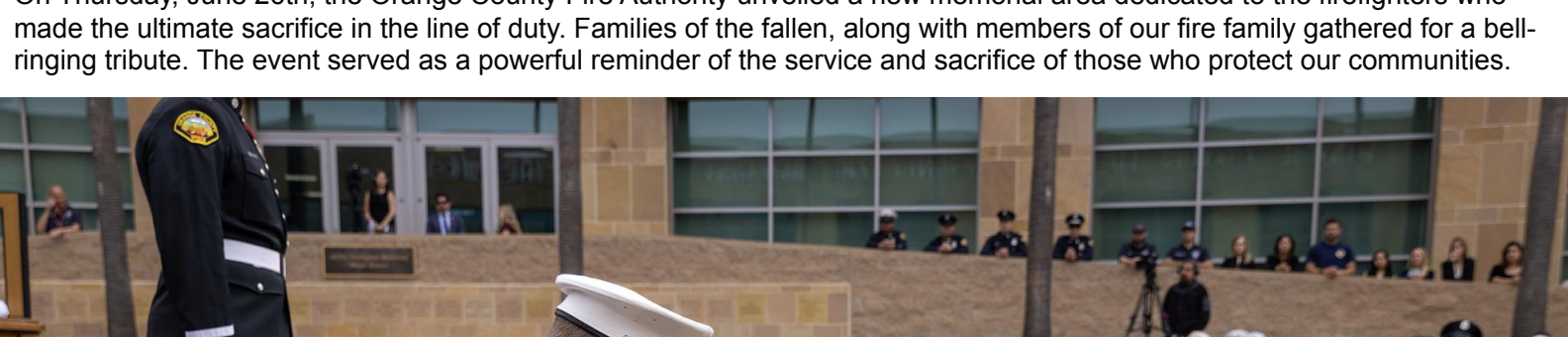

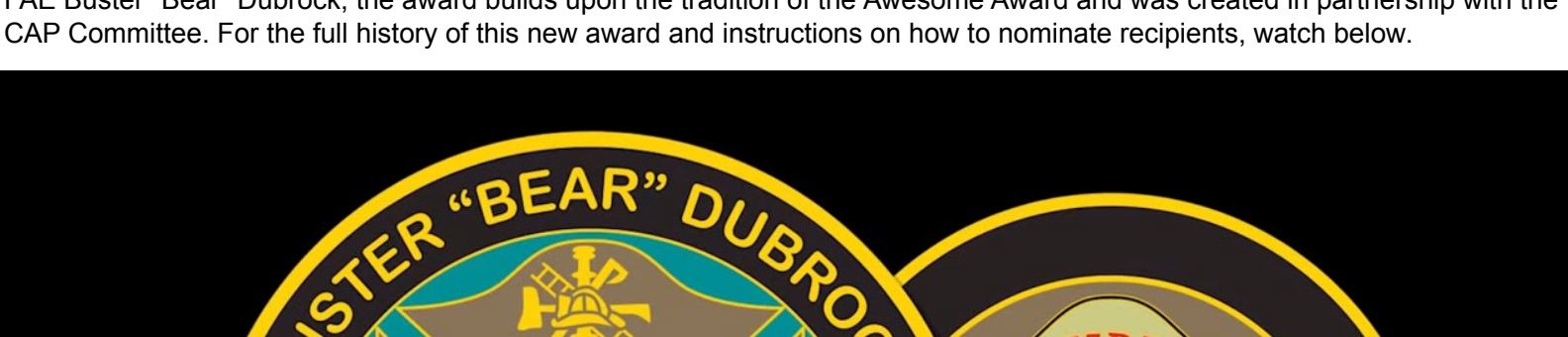
OCFA Above and Beyond Award

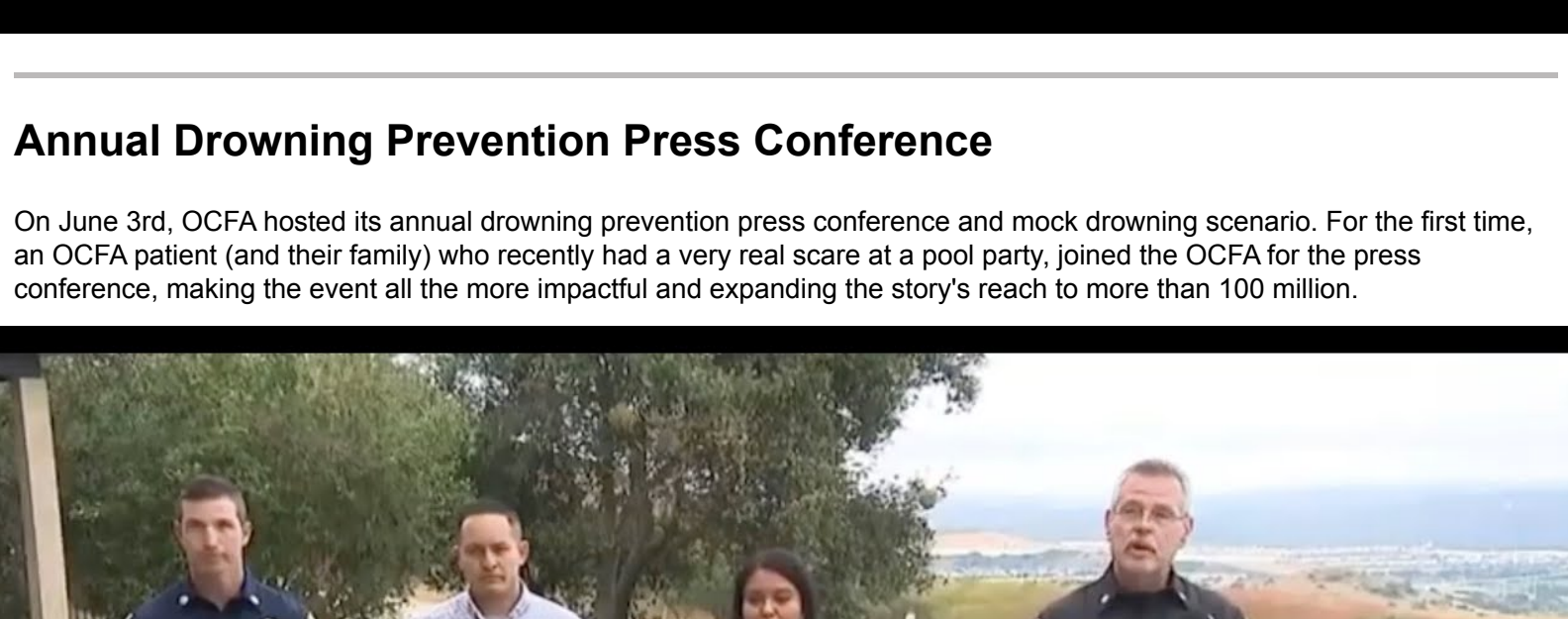

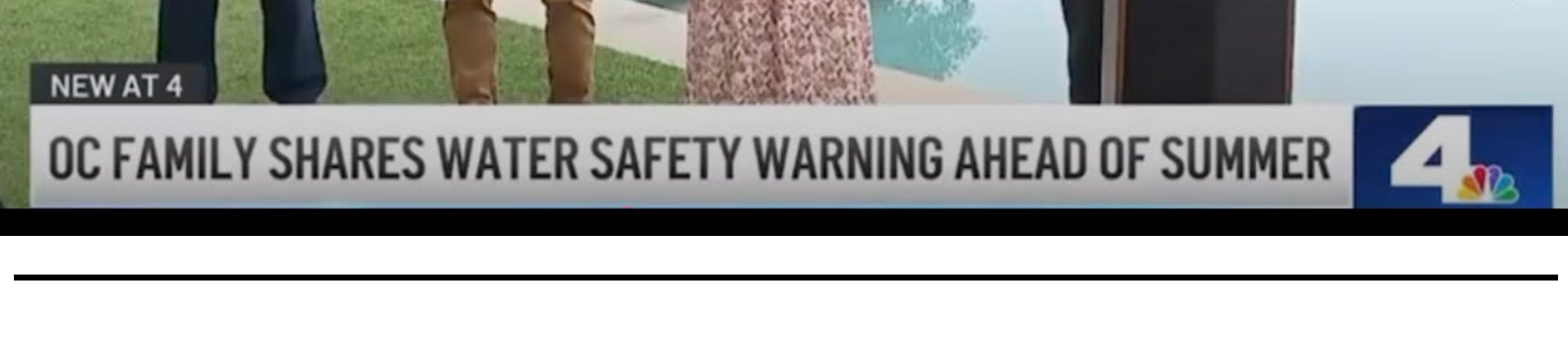
Vegetation Fire in Mission Viejo

High above the Big A, in real-time on the Jumbotron, and on the field with rotors thundering overhead.

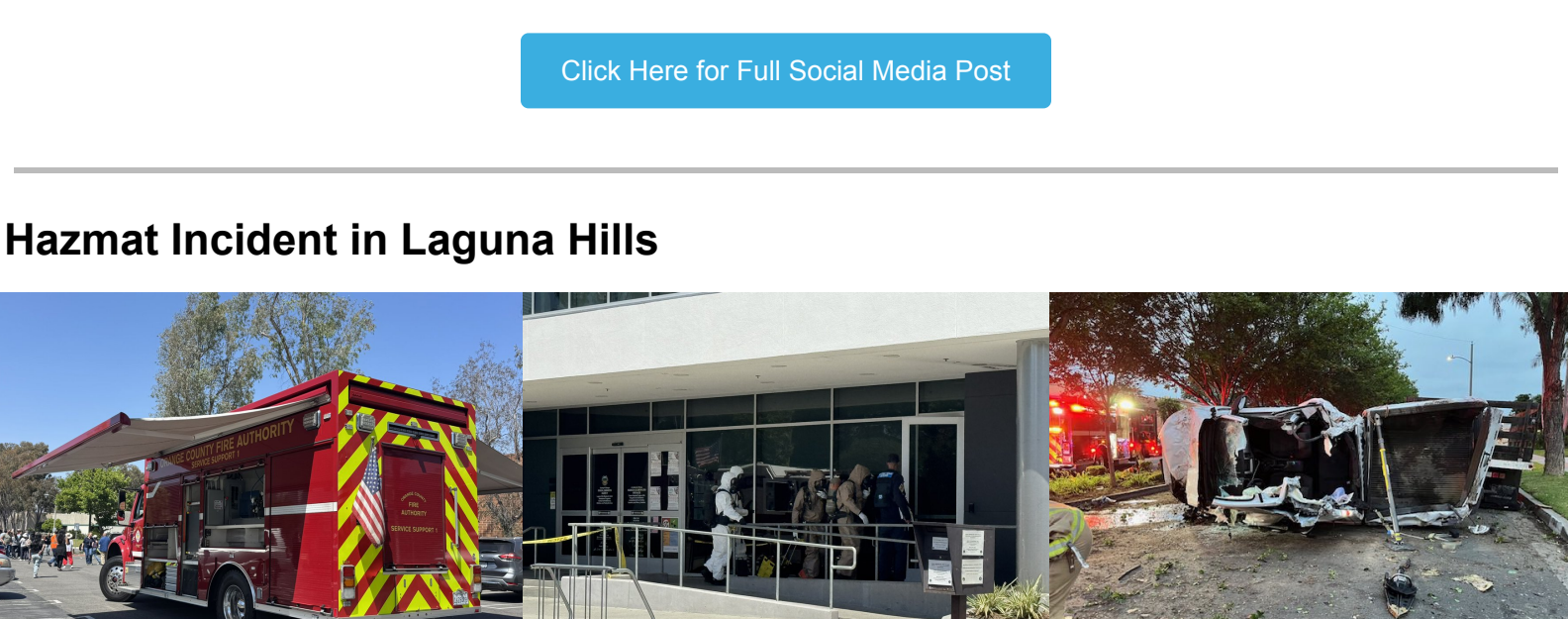
All the views were incredible as OCFA Air Operations helicopters flew over Angels Stadium in honor of First Responders & Law Enforcement Appreciation Day yesterday.

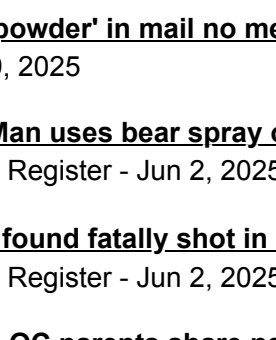
