Southern California Edison Company (SCE) hereby submits this Tier 1 Advice Letter to the California Public Utilities Commission (Commission or CPUC) that provides the requested information in Ordering Paragraph 1 of Decision (D.) 21-10-020.

PURPOSE

This Advice Letter provides information required by Ordering Paragraph (OP) 1 of D. 21-10-020 regarding SCE's restoration, rebuilding, and reconstruction activities related to the Franklin Fire. The Governor declared a State of Emergency for the Franklin Fire on or around June 18, 2025. At this time, no executive orders have been issued. The disaster declaration for the Frankling Fire was published on the State's official website on or around June 30, 2025. The Franklin Fire began on December 9, 2024 and was fully contained on December 18, 2024.

BACKGROUND

Ordering Paragraph 1 of D. 21-10-020 requires an electric Investor Owned Utility (IOU) to file a Tier 1 Advice Letter if (1) the Governor of California or the President of the United States issues a disaster declaration, and (2) there is damage to IOU's facility or a service outage. Ordering Paragraph 1 states:

"In the event of a disaster, declared either by the Governor of California or the President of the United States, that also damages their facilities or leads to a service outage, Investor-Owned Utilities (IOUs) shall file a Tier 1 Advice Letter within 15 business days from when they are allowed into

a disaster area to assess the damage to their facilities.¹ IOUs shall file this Advice Letter with the Commission's Energy Division, with a copy sent to the Communications Division at TD_PAL@cpuc.ca.gov. The Advice Letter also must be provided to the appropriate local government contained within the disaster area, including the chief executive or leader of the city, township or Tribal government. In the case of an unincorporated area, the communication must be established with the appropriate County. In the case of Tribal governments, the Advice Letter must be provided to any Tribe(s) that have Tribal lands or ancestral territory overlapping with any portion of the disaster area.

The Advice Letter shall include the following details:

- a. a report of what facilities or equipment was damaged;
- b. restoration and/or rebuild plans, including a description of what is being repaired, replaced or added, and maps of where the restoration will occur;
- c. the date the investor-owned utility received access to the damaged area;
- d. the timeline to make repairs;
- e. any changes to any energy/communication infrastructure required; and
- f. the contact information of the individual responsible for community engagement in these instances."

Below, SCE provides the requested information for the disaster declarations covered in this advice letter.

Franklin Fire

The Franklin Fire occurred in SCE service territory commencing on or about December 9, 2024 and was fully contained on December 18, 2024. On or about June 18, 2025 Governor Newsom issued a State of Emergency (SOE) Proclamation for the City of Malibu which is located in SCE service territory. However, at this time no executive orders in conjunction with this SOE have been issued. On or around June 30, 2025 a disaster declaration for the Franklin Fire was published on the State's website SCE began restoration activities on December 9, 2024. As of the date of the disaster declaration, all restoration activities related to the Franklin Fire have been completed.

A. SCE's Facilities and Equipment that were Damaged as of July 9, 2025

B. Restoration or rebuild plans

SCE began the service restoration as soon as it was safe to conduct the work. Service restoration was accomplished by replacing equipment on a like-for-like basis. All restoration activities related to the Franklin Fire were completed on or around January 19, 2025.

C. Date received access to damaged areas

SCE was not under restricted access to the affected areas and began doing damage assessments on December 10, 2024. However, access to affected areas were limited by the rugged terrain. The Franklin Fire was fully contained on December 18, 2024.

D. Timeline to make repairs

SCE completed service restoration for all affected customers from December 9, 2024 to December 18, 2024. All restoration efforts related to the Franklin Fire have been completed.

E. Changes to infrastructure

Service restoration was accomplished by replacing equipment on a like-for-like basis. Some equipment was brought up to the latest construction standards.

F. Contact information or community engagement

This was a service restoration activity accomplished by replacement of equipment on a like-for-like basis, not a rebuild effort. Because this was a service restoration effort requiring immediate action, SCE did not engage with community stakeholders prior to the restoration work as contemplated by OP 2 of D. 21-10-020 prior to commencing the work. Accordingly, SCE will not be submitting a second Advice Letter as contemplated in OP 3.

PROPOSED TARIFF CHANGES

This submittal does not require any tariff revisions and would not increase any current rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

TIER DESIGNATION

Pursuant to OP 1 of D. 21-10-202, this Advice Letter is submitted with a Tier 1 designation.

EFFECTIVE DATE

Pursuant to General Order (GP) 96-B, Rule 5.1, SCE requests that this Tier 1 Advice Letter become effective on July 22, 2025, the same date as submitted.

Why am I receiving this notice?

On August 15, 2025, Southern California Gas Company (SoCalGas®) filed an application (A.25-08-008) with the California Public Utilities Commission (CPUC) to recover costs recorded in the Distribution Integrity Management Program Balancing Account (Application). The Application seeks to recover a total revenue under-collection of \$59.1 million.

Why is SoCalGas requesting this rate increase?

This Application encompasses the implementation of the Distribution Integrity Management Program (DIMP), and recovery of related costs recorded in the DIMP Balancing Account (DIMPBA) from 2019-2023. The DIMP is a federally-mandated comprehensive program focused on the identification and reduction of distribution pipeline integrity risks to enhance pipeline and public safety. The DIMP implements targeted activities, programs, or projects that provide additional monitoring, assessment, and proactive remediation of distribution pipeline systems.

The CPUC approved the DIMP with approximately \$683 million of authorized expenditures for the years 2019-2023. SoCalGas is requesting recovery of \$59.1 million in under-collected revenue, for additional expenditures totaling \$207 million that were incurred above authorized levels for the period of February 1, 2023, through December 31, 2023.

How could this affect my monthly gas bill?

If SoCalGas's rate request is approved by the CPUC, the average residential monthly bill using 36 therms per month would increase by approximately \$0.72 or 1% per month over a 12-month period, or until the costs are recovered. The proposed average transportation rates shown below are for 2026.

How does the rest of this process work?

This Application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SoCalGas's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review SoCalGas's application, including the Public Advocates Office. The Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. Why am I receiving this notice?

On August 15, 2025, Southern California Gas Company (SoCalGas®) and Lakeside Pipeline LLC filed Application 25-04-009 for Lakeside Pipeline LLC's Senate Bill (SB) 1383 Dairy Biomethane Pilot Project Reasonableness Review with the California Public Utilities Commission (CPUC). The application is requesting a total increase of \$ 14.5 million in revenue to recover costs above the approved project estimate of \$ 20.2 million, to total \$34.7 million.

If the CPUC approves this request, SoCalGas will recover the recorded project developer costs in gas rates over a 1-year period beginning after approval of the application and SoCalGas's costs over the life of the facility. This will increase your monthly bill.

Why is SoCalGas requesting this rate increase?

The CPUC authorized the Dairy Biomethane Pilot program to implement six dairy biomethane pilot projects pursuant to Senate Bill (SB) 1383 to produce Renewable Natural Gas (RNG) and to demonstrate interconnection to the utilities' natural gas pipeline system. RNG is an important component of California's strategy to reduce greenhouse gas (GHG) emissions and achieve climate goals. These Dairy Biomethane Pilot projects support the development and integration of RNG into the state's energy system. The Dairy Biomethane Pilot projects include SoCalGas facility upgrades and pilot project developer costs.

For this application, facility and projects costs were expended by SoCalGas and Lakeside Pipeline LLC (pilot project developer). The project was completed and exceeded its initial forecasts of RNG production and carbon reductions. SoCalGas and Lakeside Pipeline LLC requests the CPUC approve the costs as reasonable and prudent to successfully demonstrate this Dairy Biomethane Pilot project consistent with the goals of SB 1383.

How could this affect my monthly gas rates?

If SoCalGas's request is approved by the CPUC, SoCalGas's rates for gas service will increase. The average residential gas monthly bill using 36 therms per month would increase by approximately \$0.12 or 0.1% per month in 2026.

The table below does not necessarily reflect the changes that you may see on your bill. Changes in individual bills will also depend on how much electricity or gas each customer uses.

The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

‘Jungle’ theme for GG park

An historic upgrading of Woodbury Park will feature a bronze sculpture created by a local Garden Grove artist.

At Tuesday night’s meeting, the city council approved a proposal to commission the jungle-themed work to Art by Jennifer, which is Jennifer Stewart, owner of the Azteca Mexican Restaurant on Main Street.

She is also president of the city’s Downtown Commission and the Garden Grove Downtown Business Association.

The total cost of the art and fabrication is put at \$163,125.

Stewart is the artist who created the sculpture of Jack Wallin in the Atlantis Play Center in Garden Grove Park and the ‘Strawberry Zest’ sculpture at a West Garden Grove fire station.

Woodbury Park is located at 13800 Rosita Place, near Woodbury Elementary School. The 3.8 acre park is undergoing a major revitalization and expansion project that will feature a recreational swimming pool, two playground areas, picnic shelters , a skate plaza, basketball courts, lighting, restrooms and a parking lot.

Construction is expected to be completed in spring 2026.

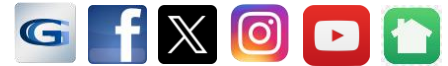

**FREE BULKY ITEM DROP OFF, HOUSEHOLD BATTERY
COLLECTION, AND PAPER SHREDDING AT
SEPTEMBER 13 EVENT**

The City of Garden Grove and Garden Grove Sanitary District, in collaboration with Republic Services, will host a community cleanup day, offering residents the opportunity to dispose of bulky items, recycle household batteries, and obtain paper shredding services for free. The event takes place on Saturday, September 13, 2025, from 9:00 a.m. to 11:00 a.m., at the H. Louis Lake Senior Center, located at 11300 Stanford Avenue.

Residents may bring unwanted bulky items, such as non-refrigerant appliances, furniture, mattresses, and carpets. Electronic waste, including printers, computers, and televisions are also accepted. This will be a self-service event in which residents will be unloading their own items, on a first-come, first-served basis, until bins are full.

Residents may recycle household batteries, such as AA, AAA, D, C, and old power tool batteries. Automotive batteries will not be accepted.

Paper shredding services will be available on a first come, first served basis to help safely dispose of personal documents. There is a limit of four boxes per vehicle.

Items not accepted include hazardous waste, LED lights, refrigerators, freezers, AC units, concrete, dirt, tires, and construction and demolition debris.

Cal Cities hits the gas on Cap-and-Trade talks

Cities can submit a letter of support using Cal Cities' sample letter

Cal Cities officers earlier this week lobbied key lawmakers — including the offices of future Senate leader Monique Limón and Asm. Jacqui Irwin — on what has become one of Sacramento's most-watched negotiations: the [future of the Cap-and-Trade Program](#).

The visits are [part of a larger effort](#) by Cal Cities and a [broad coalition](#) to reauthorize the program and ensure Cap-and-Trade funding is available to cities. Both Sen. Limón and Asm. Irwin are leading efforts to reauthorize the program, which is set to expire in 2030.

Cap-and-Trade allows businesses to buy a limited number of credits each year from the California Air Resources Board to cover their carbon emissions. Proceeds from the auction are used for a variety of programs that reduce carbon pollution and support middle-class jobs. A push from Gov. Gavin Newsom to renew the program earlier this year has set off a flurry of [procedural maneuvers](#) and stakeholder meetings in the final weeks of the session.

Cal Cities and others have argued that lawmakers must invest in local efforts to carry out statewide climate goals, such as increasing zero-emission vehicles and organic waste recycling, mitigating sea level rise, and hardening homes.

Reauthorizing the Cap-and-Trade program is also critical to accelerating affordable housing. Investments from the program have contributed to over 1,200 new projects, boosting affordable housing and building more climate-resilient communities statewide.

With other state and federal investments drying up — or gone entirely — this funding is critical, Cal Cities and its allies argue. For example, without Cap-and-Trade funding, there would be few state dollars to support the production of affordable housing and ensure the state's housing goals are met.

Members of Cal Cities' North Bay Division this week also lobbied Senate President pro Tempore Mike McGuire and other legislators on the program.

A deal is expected to land soon. Lawmakers need to get something in print by Sept. 9, three days before the end of the session.



Proposed Brown Act changes could be costly for cities

The Legislature is considering [SB 707 \(Durazo\)](#), a sweeping bill that would overhaul local government meeting requirements under the Ralph M. Brown Act. Cal Cities is opposed to SB 707 unless it is amended to address [cost and flexibility concerns](#).

Sen. María Elena Durazo has taken a collaborative approach to crafting the bill, which has resulted in many positive provisions. However, as drafted, the bill imposes costly, prescriptive mandates on cities without providing the resources or flexibility needed to implement them.

Among its requirements, SB 707 would force many city councils to:

- Provide two-way telephonic or audiovisual access for all meetings and halt business during service disruptions.
- Translate agendas into all “applicable languages” spoken by 20% or more of residents with limited English proficiency.
- Provide a space for community-submitted translations, even if they are inaccurate or misleading.
- Create and maintain multi-language webpages with agendas, instructions, and meeting procedures.
- Expand outreach and electronic systems for agenda access.

These mandates would create significant new costs — from expensive audiovisual equipment and translation services to staff training, website redesigns, and facility modifications. Cities are already facing fiscal strain due to state budget pressures, flat revenues, and new unfunded mandates. Unlike other mandates, Brown Act obligations are not eligible for state reimbursement, meaning cities must absorb the full cost of compliance.

The bill applies many of its mandates unevenly due to its overlapping definitions of legislative bodies. For example, roughly 100 smaller cities would be exempt from the new rules. However, 100 cities of the same size would need to comply simply because they are in larger counties.

Adding to the imbalance, the state itself is exempt from the very rules it seeks to impose. The Legislature, state boards, and commissions are not bound by the same translation, hybrid access, or posting requirements that cities would face.

SB 707 would take effect on Jan. 1, giving cities just a few months to redesign meeting systems, buy equipment, and train staff — all without dedicated funding. Cal Cities is urging lawmakers to delay implementation until early 2027 to give cities sufficient time to prepare and change some of the bill’s more onerous requirements.

SB 707 will be heard this Friday on the Assembly [suspense file](#), where it will either move to the Assembly Floor or be held for the year. Cities can submit a letter opposing the bill [using Cal Cities’ sample letter](#).

As negotiations continue, the bill is likely to see more amendments.



Cal Cities-sponsored bond agency issues over \$259 million in affordable housing bonds

The California Statewide Communities Development Authority (CSCDA) has issued over \$259 million in tax-exempt bonds — \$151,555,000 for Sequoia Living, Inc., \$47,910,000 for a project in Monrovia, and \$60,110,348 for a development in Palm Desert.

Sequoia Living is a Bay Area nonprofit that provides older adults from all economic backgrounds with living environments and services that enrich their lives.

In Monrovia, the funds will be used to acquire, convert, and rehabilitate the 156-unit Oak Park Apartments. The one- and two-bedroom apartments will be 100% affordable to very low-income and low-income residents of Monrovia.

In Palm Desert, the funds will be used for the new construction of 121 affordable housing units at Palm Villas at Millennium. The 100% affordable units will be rent-restricted for extremely low- and low-income residents.

CSCDA worked with the cities and others to provide the housing bonds.

Bill Talk: The (next-to-last) last Bill Talk of 2025?

A weekly update from Cal Cities, sorting through the state bill buzz

Welcome to the last week of committee hearings. This week marks the second and final [suspense file](#) of the year — and the impending death of hundreds of bills that lawmakers deem too fiscally hefty for California's less-than-healthy budget. Under normal years, this would mark the beginning of the "slow" season, barring a last-minute voting marathon. But this year could be (and for many, has been) anything but.

Apart from an all-hands-on-deck redistricting gambit, lawmakers have several pending deals they need to sort out. Some of these could leak into a special session later this year. By far the biggest is the [\\$22.3 billion Medi-Cal hole](#) left by federal funding cuts. But legislators must also figure out the future of the [Cap-and-Trade Program](#), which is currently tied up with the state's high-speed rail ambitions and wildfire response.

But that is a problem for the week after next. For now, all eyes are firmly focused on appropriations. After that, the Legislature has until Sept. 12 to pass bills, giving Gov. Gavin Newsom one month to sign or veto any that make it to his desk.

A quick peek behind the curtain: Bill Talk grew out of the much catchier "Upcoming legislative meetings on bills of interest to cities" and arguably misnamed "State Bills in Brief." Both series ended when policy committee hearings ended. Bill Talk is scheduled to end on Monday, with a look at the bills that made it out of suspense. However, if most of Cal Cities' priority bills pass out of suspense, we may continue this series during the last weeks of floor votes.

[Housing bills have suspiciously different price tags](#)

Two priority housing bills will face their final committee hearing this week. Both would require the Department of Housing and Community Development (HCD) to more actively review local housing plans but have strikingly different fiscal projections.

[AB 650 \(Papan\)](#) would allow cities to begin the housing element review process six months earlier than existing law and require HCD to provide additional information to cities. This would make it easier for cities to follow housing element law, something the Newsom Administration has made [a top priority](#). According to the [Senate Appropriations Analysis](#), the Cal Cities-sponsored bill would cost HCD \$11.1 million annually and require 52 new staff positions.

[SB 79 \(Wiener\)](#) would force cities to approve tall, dense residential housing with limited environmental review and no public engagement near specific transit stops. The measure also requires HCD to review new alternative transit-oriented development

plans in these areas, should a city want to implement the measure in a way that better fits its community. SB 79 has an estimated cost of [\\$955,000 annually](#).

This is a striking difference: Under SB 79, HCD would need to review new information in housing elements, review and approve local ordinances, and determine residential capacity on land within one-half mile of qualifying transit stops. Meanwhile, AB 650 merely requires HCD to do something it should arguably already be doing.

Given the current budget deficit, this could spell trouble for AB 650 — which has passed with unanimous bipartisan support all year. SB 79, which Cal Cities opposes, has scraped through the process with the bare minimum number of votes.

Cities should reach out to their legislators and voice their support for AB 650 and opposition to SB 79.

[Cap-and-Trade reauthorization deal expected soon\(ish\)](#)

With Cap-and-Trade set to expire in 2030, negotiations are in full swing for a late-session deal. Cal Cities and other [local government, transportation, and labor partners](#) have [urged state leaders](#) to [prioritize climate-safe infrastructure improvements](#) during negotiations.

The Cal Cities-led coalition held a [rally in July](#) on the Capitol steps, calling for the Cap-and-Trade Program to invest in:

- Local clean transportation infrastructure
- Climate adaptation programs, such as sea level rise, flood infrastructure, and organic waste infrastructure
- Land use and infill development for affordable housing and sustainable communities
- State and regional clean transit infrastructure
- Wildfire resilience infrastructure at the local level

Cities should [take action](#) and send a letter of support to their legislators for the coalition priorities that could bring much-needed climate funding to their communities.

Negotiations will continue in these final weeks of the legislative session.

[Remaining recovery housing bills face an uphill battle in appropriations](#)

After receiving a high price tag in appropriations, Sen. Catherine Blakespear decided to turn one of Cal Cities' sponsored recovery housing bills into a two-year bill. Lawmakers had placed the measure on the suspense file — reserved for bills with significant fiscal impacts that require more in-depth review.

[SB 329](#) would have required the Department of Health Care Services to meet its own internal timelines for investigating complaints against licensed treatment facilities. Just to meet their own timelines, the department estimated it would need dozens of new employees, with ongoing costs in the millions.

This left two options: Risk the bill dying in appropriations or take another stab next year. Ultimately, the bill was shelved for the year and will come back next year as something more likely to pass.

Two other sponsored recovery housing bills, [SB 35 \(Umberg\)](#) and [AB 424 \(Davies\)](#), are still on the suspense file. Both would implement recommendations from a recent state audit that found the state health agency has failed to investigate complaints against these facilities consistently and thoroughly, jeopardizing patient and community safety. Lawmakers will determine the fate of the two measures by the end of the week, along with hundreds of others.

The last measure in the bill package, [AB 492 \(Valencia\)](#), is awaiting a vote on the Senate floor. It has not received any no votes so far this year.
