Dear Senator Umberg,

The City of Garden Grove is pleased to support **SB 35 (Umberg)**, which would enhance the oversight and enforcement of existing state licensing laws for alcohol and drug treatment facilities.

Residential recovery housing provides a range of benefits to some of California's most vulnerable residents, and it is critical their needs are prioritized over profits. Compliance with state licensing laws administered through the Department of Health Care Services (DHCS) is essential to safeguarding residents' well-being and maintaining quality care.

Existing state law prohibits any drug and alcohol treatment facility that provides recovery, treatment, or detoxification services from operating without first obtaining a valid license from DHCS. Compliance with state licensing laws is essential to safeguard the well-being of residents in sober living homes.

A recent state audit revealed that DHCS has not consistently investigated allegations of unlicensed facilities providing or advertising treatment services. The department has often failed to conduct site visits and follow-ups to ensure illegal operations have stopped.

In one example highlighted in the audit, DHCS substantiated an allegation that an unlicensed facility was unlawfully providing services. However, the audit found no indication the department followed up to verify the facility's claim that it had ceased operations — nor did it conduct a site visit to confirm compliance.

To address these gaps, the auditor recommended that DHCS improve the timeliness of inspections and complaint investigations, conduct more site visits, and establish follow-up procedures to ensure unlicensed facilities cease unlawful operations.

SB 35 would implement these recommendations by requiring DHCS to meet specific timelines for investigating allegations of unlicensed treatment services. If the department fails to meet these deadlines, cities and counties could seek approval to conduct site visits and enforce licensure laws themselves. SB 35 also requires DHCS to conduct follow-up site visits to ensure unlawful activity has stopped.

By collaborating with cities, the state can leverage local resources to supplement its regulatory efforts. Cities are positioned to respond promptly to emerging issues or changes in their communities. Allowing them to partner with the state to conduct site inspections and enforce licensing laws enables swift action to address violations, ensure compliance, and protect public health and safety.

SB 35 would help meet our shared goals of ensuring recovery housing meets standards for patient care, which is central to effective treatment outcomes and community well-being. For these reasons, the City of Garden Grove is pleased to support **SB 35 (Umberg).**



13 DUI arrests made by GGPD

You might not think that the weekend leading up to Labor Day would especially be a time for drinking and driving, but checkpoints in Garden Grove resulted in a significant haul of arrests, tows and tickets.

The Garden Grove Police Department conducted checkpoints on Friday and Saturday evenings (and into the early hours of the following days) looking at over more than 1,900 vehicles.

During that time, police made 13 arrests for driving under the influence (of alcohol and/or drugs). Sixteen cars were towed and impounded and 30 tickets were written for various vehicle code violations.

Also, officers visited neighborhood as restaurants and bars to educate the community on the dangers of impaired driving and to test their knowledge by guessing their own blood alcohol content after consuming some liquor.

11 Distinguished Schools in GGUSD honored by board

Celebrations were the order of business at Tuesday night's meeting of the Garden Grove Unified School District Board of Education.

Eleven elementary schools in the GGUSD have been declared California Distinguished School for showing exceptional academic outcomes or great success in closing the achievement gap.

That's the most in Orange County and topped only by the huge Los Angeles Unified School District, which is 14 times larger than the GGUSD.

The board presented framed certificates to representatives – principals, teachers and other staff – from Anthony, Barker, Brookhurst, Cook. Eisenhower, Excelsior, Hill, Patton, Peters K-3 and 4-6 and Zeyen schools.

Also on Tuesday the board approved by a 4-0 vote – with Trustee Dina Nguyen absent – acceptance of a bid from The Wooden Floor to expand after-school modern dance offerings in concert with the Boys & Girls Club of Garden Grove. Funding comes from the State of California.

Also the board accepted a bid for cybersecurity services from Nth Generation Computing Inc. to strengthen protection for data and "safeguarding" the GGUSD's "digital environment."

The bid is for \$1,259,277 and funding comes from the Federal Communications Commission.

GGUSD serves most of Garden Grove and parts of Anaheim, Cypress, Fountain Valley, Santa Ana, Stanton and Westminster.

You have a choice of grilled (my favorite) and fried chicken along with a variety of sides. On top of that, you get a real metal fork and a real plate to eat from. A nice worker bee buses your table, too.

It's a pretty good option ...

On another point, I have been touched by the number of people who are grieving the imminent departure of the JC Penney store from Westminster Mall.

They recall memories of buying prom dresses and other nostalgic connections to what was once one of America's largest – and now shrinking – retail operations.

Long-time Garden Grovers may remember a JC Penney in the center of the old Orange County Plaza (now The Promenade). That's where my brother and I got our Boy Scout uniforms and accessories.

(Girl Scouts went to SQR in Anaheim).

It had its fans, but it was fairly small by department store standards (just 40,000 square feet) and was originally planned for a two-story facility.

But for reasons that elude logic, they decided to build the second story underground and use that for storage instead of selling.

The City of Garden Grove tried to talk them into making more use of the subterranean real estate, but no luck. It eventually became an outlet store as a new two-story (all above-ground) store was built at The City (later The Block, now the Outlets in Orange).

Governor creates new task force to address encampments

Last week, Gov. Gavin Newsom announced a new task force dedicated to addressing encampments on state properties. The group — which will focus on California's ten largest cities — is comprised of six different state agencies and departments. It will begin operations within the next 30 days.

Cal Cities has been calling on the state to do more to address encampments on state properties. These efforts include co-sponsoring SB 569 (Blakespear), which aimed to improve coordination between cities and the California Department of Transportation to better address homeless encampments on state-owned land. Unfortunately, the bill was held after the administration proposed last-minute changes that weakened the bill. "We know that addressing dangerous homeless encampments on state-owned land is an essential part [of addressing homelessness]," said Cal Cities Executive Director and CEO Carolyn Coleman in response to the Governor's announcement. "That's why I'm glad to see this announcement that brings together state agencies to better support city efforts to clear them quickly and humanely."

The state's announcement about the task force was vague on details: It is too early to know how this task force will work with local governments to ensure those living in encampments are connected to local services and housing.

California's largest cities are already grappling with the impacts of recent cuts to state homelessness funding, which could impact the very programs intended to serve individuals transitioning out of encampments.

Just three months ago, lawmakers and Gov. Gavin Newsom zeroed out funding for the Homeless Housing, Assistance, and Prevention Grant Program — the main source of homelessness funding for many communities — for the current fiscal year. For FY 2026-27, lawmakers set aside \$500 million — half the level of previous years. "While we continue to call on the state to restore funding, we also urge them to distribute the funds that are available quickly so cities can continue to support their unhoused residents without disruption," Coleman said recently.

According to the Governor's press release, the new task force will prioritize larger encampments on state rights-of-ways, such as along highways, medians, on and off ramps, and under overpasses. The group includes representatives from the California Highway Patrol, Office of Emergency Services, Department of Housing and Community Development, Interagency Council on Homelessness, Health and Human Services, and the California Department of Transportation.

Cal Cities is urging the state to ensure that best practices and lessons learned from the newly created task force translate into real solutions for small and medium-sized cities grappling with encampments on state property.

Bill Talk: Cities notch big suspense file wins, despite budget crunch

Last Friday's <u>final fiscal slashing</u> of the year contained some big wins for cities — not least of all the survival of several sponsored measures. Out of the 15 introduced this year, eight have made it to the floor for a final vote.

Lawmakers also held several bills that would have created new costs and legal liabilities for cities. Of course, some measures supported by Cal Cities failed to advance, mostly those in the environmental quality portfolio. Those measures tend to command higher price tags, making them prime targets for legislators looking to shore up a shaky state budget.

The Assembly and Senate appropriations committees meet twice a year to review the impact of hundreds of measures on the state's coffers. The Senate and Assembly this time took the unusual move of declaring that any bill that died in appropriations without being turned into a two-year bill cannot come back next year.

This (somewhat) surprising outcome means that Bill Talk will continue until the end of session. But with around 850 measures left to vote on (and no committee hearings), legislators and city leaders will need to act fast. Lawmakers have until Sept. 12 to pass any remaining measures. The last day for lawmakers to get any changes in print — and thus eligible for consideration — is Sept. 9.

Below is a round-up of the major remaining bills, victories, and losses in each portfolio.

Environmental Quality

The appropriations committees' actions last week yielded mixed results for Cal Cities' environmental quality bills. Most environmental-related measures create additional implementation costs, either at the local or state level, making them challenging to pass in a budget deficit.

Unsurprisingly, each appropriations committee held quite a few bills supported by Cal Cities, including its sponsored AB 846 (Connolly). That measure would have created a voluntary streamlined path for local agencies to consult with the California Fish and Wildlife Department on vegetation management projects in fire-prone areas. Notably, Legislation passed earlier this year as part of the budget clarified that environmental review is waived and consultation with the state is only required for CEQA reform primer for eligible wildfire risk reduction projects). While not the same streamlined pathway envisioned in AB 846, the exemption and environmental

<u>consultation</u> can serve as a helpful tool for cities looking to expedite wildfire prevention projects.

On a positive note, two Cal Cities' sponsored bills survived the appropriations cuts: <u>SB</u> <u>454 (McNerney)</u> and <u>AB 996 (Pellerin)</u>. SB 454 would create a PFAS Mitigation Fund to help cities and water agencies remove forever chemicals from their water supplies. It moved forward to the Assembly Floor, along with a second PFAS bill supported by Cal Cities, <u>SB 682 (Allen)</u>. That measure would prohibit the distribution or sale of certain products that contain PFAS.

The other sponsored measure, AB 996, would provide <u>tools for coastal and bay cities</u> to meet sea level rise planning requirements. A coalition of coastal and bay local governments has proved instrumental in advancing this measure.

Community Services

Cal Cities' recovery housing bill package faced its toughest test yet in appropriations, where three of the four measures were sent to the suspense file. The Department of Health Care Services assigned all three high cost estimates, making it difficult for lawmakers to move them forward. That left two options: Risk the bills dying in appropriations or regroup and try again next year. Sen. Catherine Blakespear chose the latter, designating SB 329 as a two-year bill with plans to return next year. Fortunately, AB 424 (Davies) advanced off the suspense file. The bill would strengthen communication between the department and cities when processing complaints against licensed alcohol and drug treatment facilities. Unfortunately, SB 35 (Umberg) was held in committee and cannot return next year. The measure would have improved oversight of unlicensed sober living homes.

AB 424 now joins <u>AB 492 (Valencia)</u> on the Senate Floor, awaiting a vote before advancing to the Governor's desk. AB 492 would require the department to notify cities whenever it issues a new license for an alcohol or drug treatment center within their jurisdiction.

Housing, Community, and Economic Development

Lawmakers approved two closely watched bills, <u>AB 650 (Papan)</u> and <u>SB 79 (Wiener)</u>, which had received oddly <u>different costs</u> despite similar requirements for the state. Sponsored by Cal Cities, AB 650 passed with unanimous bipartisan support, as has been the case all year. The measure would improve the housing element review process by allowing cities to begin their housing element drafts earlier than existing law and provide more clarity in the review process.

Also <u>staying on trend</u>, SB 79 passed off the suspense file with several changes and the bare minimum of votes, 8-6. The measure would force cities to approve residential projects near specific transit stops with limited environmental review and public engagement. Both Republicans and Democrats were split, as each party had at least one vote in support of it and one against it. As one of the few bills to receive a roll call vote on Friday, it shows just how divided the Legislature is on the issue. Significant amendments are forthcoming this week that will likely further narrow the measure. Assembly Appropriations Chair Buffy Wicks already <u>announced</u> that a provision looping in all areas near specific transit stops to follow statewide height and density standards for residential development will be removed. She also said there would be modifications to the bill's definitions and many clarifying and technical amendments, along with changes to projects inside fire hazard severity zones and historic districts.

Transportation, Communications, and Public Works

Thanks to strong member engagement, Friday's appropriations committee actions resulted in a relatively positive outcome for infrastructure-related bills. Cal Cities' sponsored AB 476 (Gonzalez) advanced out of committee, sans provisions that would have created a new crime for organized and repeated metal theft. The bill still includes reporting and licensing requirements for scrap metal sellers and now advances to the Senate Floor.

After receiving letters from Cal Cities members, the author removed provisions from an outdoor billboard permitting bill, <u>SB 364 (Strickland)</u>, that created significant safety concerns. Assembly Appropriations held <u>SB 445 (Wiener)</u>, which took <u>several forms this year</u> — all usurping local permitting review and inspection. City letters in both cases strengthened Cal Cities' efforts to preserve local control.

Notably, legislators also held <u>AB 470 (McKinnor)</u> for the year. The measure would have created an off-ramp for telecommunication providers from <u>carrier of last resort</u> <u>obligations</u>. Cal Cities had voiced concerns about the bill, which has drawn <u>considerable</u> attention.

Public Safety

Most of Cal Cities' priority policing bills passed off the suspense files with minor amendments. Several Cal Cities-supported bills related to fire insurance and wildfire mitigation also passed out of the Appropriations Committees. But lawmakers did hold a few major bills, such as AB 75 (Calderon). Supported by Cal Cities, the bill would have required insurance companies to provide notice to homeowners before taking aerial footage of their property.

Governance, Transparency, and Labor Relations

In a win for cities, Senate Appropriations held <u>AB 340 (Ahrens)</u> and <u>AB 1109 (Kalra)</u> on the suspense file. These bills would have effectively created new privileges between employees and unions. In doing so, the bills would have restricted employer investigations and added new costs and liability for cities.

AB 339 (Ortega), however, passed with amendments. This bill, like previous unsuccessful proposals, would undermine local agencies' ability to contract for public services. The amendments removed the bill's meet and confer provisions and shortened the notice requirements from 60 days to 45 days. The amendments also

expand the exemption for public works projects. Cal Cities remains opposed to the measure.

Revenue and Taxation

There was an odd lack of suspense for the Revenue and Taxation portfolio on Friday, as most of Cal Cities' tracked bills were already on the floors of the Assembly and Senate. However, legislators did act on some notable bills.

The Senate Appropriations Committee narrowed the scope of <u>AB 265 (Caloza)</u>, a measure supported by Cal Cities. It would, upon appropriation of the Legislature, establish a grant program for small businesses and nonprofits impacted by a state of emergency. The Assembly Appropriations Committee made further changes to <u>SB 710 (Blakespear)</u>, a bill previously amended to address Cal Cities' cost concerns. The measure sought to extend property tax exemptions for solar energy systems. Other priority bills include:

Erin Brockovich's "stick-to-it-iveness" will leave you inspired and empowered

Environmental activist and consumer advocate Erin Brockovich will give the Friday keynote for the <u>Annual Conference and Expo</u> in Long Beach, Oct. 8-10. Whether you know her as a longtime activist or from the 2000 namesake film, Brockovich is a powerful voice for those who cannot be heard.

Brockovich's tenacity in the early 1990s uncovered a 30-year toxic chemical leak into the groundwater around Hinkley, California. Because of the work of Brockovich and other advocates, Pacific Gas & Electric was forced to pay out \$333 million, the largest class action settlement in U.S. history at the time, to Hinkley residents.

Today, the self-described "gutsy broad" still goes head-to-head with the "Goliaths" on environmental issues worldwide, including here in California. She has written multiple books and hosted TV shows, using her notoriety to spread messages of personal empowerment and encourage others to stand up and make a difference.
