RE: Street Outreach and Medicine Program

Dear Mr. Stiles,

CalOptima Health recognizes the extraordinary role that social determinants play in a person's health experience and outcomes. Since January 2022, CalOptima Health has implemented a robust CalAIM program, providing enhanced case management and several supportive community-based services to address those social determinants of health. With an intense focus on the experience of homelessness, CalOptima Health has engaged with local homelessness authorities, including cities, and attempted to align with the systems already in place to tackle this pressing issue.

However, in engaging in this work, it remains clear that there are opportunities for improvement. CalOptima Health is well-positioned to address one of those gaps: identifying and meeting people on the street and in shelters for urgent healthcare and important preventative services. Therefore, CalOptima Health is proposing to launch a new partnership-driven program, the Street Outreach and Medical Program (Program) in the city of Garden Grove (City). CalOptima Health believes this program aligns, supplements and supports the City's Comprehensive Strategic Plan to Address Homelessness over the next five years.

The Street Outreach and Medical Program is a critical piece of a larger, comprehensive approach to caring for our neighbors living on the street and those on their journey home. This overall approach pairs three integrated key components: (1) outreach and engagement; (2) coordinated medical care that meets people where they are; and (3) comprehensive care coordination and community supports. Together, and in partnership with the City's existing resources and foundational efforts to address homelessness, these integrated components address acute health concerns and deploy integral preventative care, but also move beyond stop-gap medical services to build the types of relationships that support a person's move home.

While the primary goal of this approach is to move people forward on their path to a permanent home, its foundation is in meeting people where they are, especially those living on the street. Just as the United States Interagency Council on Homelessness points out, street outreach is conducted on behalf of the community, rather than one organization, founded on partnership and collaboration. The Street Outreach and Medical Program sits firmly in CalOptima Health's space of ensuring equitable, quality medical care, but also creates the crucial link between our community of providers and people living on the street.







# Walk, bike or roll to class

The Garden Grove Police Department encourages parents and students to join their classmates and walk, bike, or roll to class on Wednesday (Oct. 12).

Walk and Roll to School Day is celebrated annually to highlight the benefits of exercise and practicing pedestrian and road safety with other students, families, and caregivers.

"Walking to school is a great way to exercise on a daily basis and feel comfortable getting to and from school safely," Garden Grove Police Department Police Chief Tom DaRé said. "We hope this is a fun, rewarding experience for students and members of the community that shows how important it is for everyone to be safe walking, biking, or rolling."

The Garden Grove Police Department offers tips for students who walk, bike, or roll to school:

- Plan your route on roads with sidewalks or paths away from traffic. If there are no sidewalks, walk as far away from cars as possible, facing traffic.
- Use crosswalks, preferably at stop signs or signals. If there are unmarked crosswalks, cross at corners on streets with fewer lanes and lower speed limits.
- Always look left-right-left before crossing the street and continue to scan for traffic as you cross the street.
- Watch for cars entering/leaving driveways or parking spaces.
- Always wear a helmet when riding. Ride in the same direction as traffic.
- Be aware of your surroundings. When walking, keep earbuds or headphone volume low enough so you can still hear around you.

Drivers should be extra careful and anticipate more foot and bike traffic on the morning of Oct. 12, as well as be prepared to stop for school buses and children crossing the street. Drivers should always watch their speed and slow down in school zones.

Schools are encouraged to register at walkbiketoschool.org as a way of tracking participation and showing support for active, healthy, and safe transportation.

The City of Garden Grove's mixed-use, rental housing project in OC Koreatown, Garden Brook Senior Village, is now accepting a second round of applications for residential tenants. To be placed on the interest list, eligible seniors can call (714) 462-5810 or visit <a href="mailto:conam.com/property/garden-brook-senior-village">conam.com/property/garden-brook-senior-village</a>. For in-person assistance, visit the Garden Brook Senior Village front office at 10080 Garden Grove Boulevard.

To be placed on the interest list, seniors must be 62 years of age or older; pass a low barrier background and credit screening; and the applicant's income must be one-and-a-half times the rent. The senior-living units are available to households at or below 60% of the Orange County Area Median Income (AMI). Currently there are availabilities for studios and one bedrooms. The following chart shows the occupancy and income limits.

CITY'S MIXED-USE SENIOR HOUSING DEVELOPMENT IN OC KOREATOWN OPENS SECOND TENANT INTEREST LIST 2-2-2

The 8-story, 12,938 square-feet adaptive reuse project near OC Koreatown will include commercial space on the first floor; 394 senior-living units, comprised of 129 studio units, 219 1-bedroom units, and 46 2-bedroom units; community spaces including an indoor fitness area, library room with multifunctional space, and two general-use community rooms; and on-site laundry facilities.

Additionally, Garden Brook Senior Village's intergenerational partnership with the neighboring Boys and Girls Clubs of Garden Grove will include programs that foster mutually-benefitting youth and senior interactions.

The project was developed by AMG & Associates, LLC and Pacific West Communities, Inc., and the property is owned by the Hoag Foundation, a non-profit corporation supporting the Boys and Girls Clubs of Garden Grove.

# Here's what cities need to know about the state's proposed regulations for clean energy project permitting

The League of California Cities recently <u>submitted comments</u> on a set of emergency regulations that would streamline clean energy project permitting. The proposed changes would allow the California Energy Commission to approve certain clean energy projects instead of local governments.

The regulations are the result of a rushed budget trailer bill, <u>AB 205</u> (Committee on Budget), which was introduced and passed by the Legislature in the summer as part of the 2022 Budget Act. Cal Cities and other local government associations had just a few days to analyze and respond to the bill before it was passed. Cal Cities and its coalition partners opposed AB 205. The group is now working to ensure that the commission partners with local governments as they implement this new, optional permitting system.

#### What would these regulations do?

The proposed regulations would allow the commission, under the purview of a Strategic Energy Reserve, to delegate to the California Department of Water Resources blanket authority to bypass local permitting for siting of solar, wind, and certain battery backup projects.

However, AB 205 prohibits the commission from certifying a site and related facility unless it finds that the construction or operation of the facility will have an "overall net positive economic benefit to the local government that would have had permitting authority over the site and related facility."

In its letter, Cal Cities made a series of technical suggestions that would help ensure the commission receives unbiased information when determining the "overall net positive economic benefit" of a project. The letter also proposed an amendment that would ensure local governments can fully participate in any pre-filing consultation meetings

The proposed regulations are now headed to the Office of Administrative Law, which will issue a decision by Oct. 24. For more information, please contact <u>Legislative Affairs Lobbyist Derek Dolfie</u>.



# New laws and grant programs expected to help improve mental health among first responders

Cities can expect additional resources to help improve mental health among first responders over the next few years. The resources are the result of sustained advocacy from the League of California Cities and its partners, as well as an increased focus among lawmakers on improving behavioral health outcomes.

According to the Steinberg Institute, suicides have increased by 35% nationally over the last two decades. That rate is likely higher for first responders. A Centers for Disease Control and Prevention study found that first responders may be at an elevated risk for suicide because of their environments, work culture, and occupational stress. In fact, more personnel die by suicide than in the line of duty.

AB 662 (Rodriguez), signed into law at the end of session, marks an important step toward addressing the acute and chronic traumas of duty, as well as the stigmas surrounding mental health. The measure will create a peer-to-peer suicide prevention curriculum for firefighters and emergency medical services personnel. This is crucial, as general mental health practitioners often lack the background knowledge needed to provide first responders with culturally competent care. The bill was sponsored by Cal Cities, the California Fire Chiefs Association, and the Fire Districts Association of California. Cal Cities and its partners will continue to work with the Administration to secure the resources needed to facilitate this programming in next year's budget.

Gov. Gavin Newsom and the Legislature also committed \$50 million toward officer wellness grants in this year's budget, which will be distributed to local law enforcement agencies throughout the state. Much like firefighters, police officers are often exposed to a variety of incidents that lead to mental exhaustion, burnout, and overall poor mental health. Improving mental health for police officers from recruitment to retirement is imperative for both personnel and the communities they serve.

Additional information — such as funding allocations, when funds will be released, and reporting requirements — will be posted on the California Board of State and Community Corrections' website. Cal Cities will also release information as it becomes available. Both programs will be complemented by broader actions at the state and national levels. Congress worked to address the increase in suicides through the National Suicide Hotline Designation Act of 2020, which designated "988" as a three-digit number for the recently launched 988 Suicide & Crisis Lifeline.

To comply with this change and to ensure the system's longevity, Cal Cities advocated for AB 988 (Bauer-Kahan). Signed into law by the Governor, AB 988 directs a group of stakeholders — made up of county behavioral health, law enforcement, and other local agencies — to outline a five-year implementation plan. This includes the creation of a new surcharge for 988 to fund the services. The measure will ensure the state is prepared to answer the calls of all Californians in need by providing a seamless transition from the current suicide prevention system.

The combination of these efforts illustrates an overt commitment to take care of all California residents. The return on investment will be invaluable as these programs and services will save lives and improve overall wellness.

The Fire Chiefs Leadership Seminar — scheduled for Dec. 7-8 in Monterey — equips fire chiefs and fire service personnel with the tools needed to build stronger, more resilient teams and keep their communities safe.

The seminar also provides numerous opportunities to learn from other colleagues and policy experts, as well as form invaluable support networks.

This year's seminar will cover a range of topics, including statewide emergency medical service issues, conflict resolution, behavioral health, how to implement diversity and equity in succession plans, and more. # Hearing on proposed zeroemission fleet regulations set for Oct. 27; written comments due Oct. 17

A public hearing for the California Air Resources Board's proposed Advanced Clean Fleets regulations is scheduled for an Oct. 27 at the California Environmental Protection Agency in Sacramento. The proposed changes would transition California's medium-and heavy-duty diesel fleets to zero-emissions vehicles in less than 20 years.

The League of California Cities supports efforts to reduce greenhouse gas emissions in the transportation sector. However, the proposed regulatory changes ignore existing market realities, as well as sufficient time to develop and ramp up supportive infrastructure.

Under the proposed regulations, 50% of new medium-and heavy-duty fleet vehicle purchases, such as garbage trucks, must be zero-emission starting Jan. 1, 2024. That requirement will accelerate to 100% by 2027.

Cal Cities recently submitted a comment letter highlighting its concerns with how the regulation assesses the availability of zero-emission vehicles. The letter also proposed a separate exemption

process for when zero-emission vehicles are not accessible to public agencies in practice or are unsuitable for the fleet's operational needs. City officials can provide public comment during the Oct. 27 hearing virtually or in person. A Zoom link will be available via the public meeting agenda, which will be posted ten days before the meeting. Written testimony may also be provided in advance of the hearing no later than Oct. 17. A sample letter is available for cities that wish to comment in advance.
