76-unit apt. bldg. proposed

Garden Grove – like many suburban cities – appears to continue to grow taller and taller with more medium and high-density uses.

At its Oct. 17 meeting, the city planning commission will hold a public hearing on a proposal for approval of a site plan and tentative parcel map to build a 76-unit four-story residential apartment building.

The location is 12681 Haster St. between Lampson Avenue and Garden Grove Boulevard. That's the site of Garden Park Care Center, built in 1962. It's a skilled nursing and rehabilitation facility.

To the west of the site is the Haster Basin Recreation Area, formerly known as Twin Lakes Park.

The proposal is to split the lot into two parcels, keeping the care center on 2.2 acres, with 1.6 acres for the apartment complex.

Under the proposal, the development would include eight affordable housing units for "very low income" households.

The commission will meet in the Community Meeting Center, 11300 Stanford Ave.

FREE BULKY ITEM DROP OFF AT GARDEN GROVE **MUNICIPAL SERVICE CENTER ON NOVEMBER 9**

On Saturday, November 9, 2024, from 9:00 a.m. to 11:00 a.m., the City of Garden Grove and Garden Grove Sanitary District, in collaboration with Republic Services, will host a final community cleanup event for 2024, offering residents the opportunity to dispose of bulky items for free. The drop-off location will be at the Garden Grove Municipal Service Center, located at 13802 Newhope Street. The event is open to Garden Grove residents only. Proof of residency is required.

Residents may bring unwanted bulky items, such as non-refrigerant appliances, furniture, mattresses, carpets, and electronic waste, including printers, computers, and televisions. This will be a self-service event in which residents will be unloading their own items, on a first-come, first-served basis, until bins are full.

Items not accepted include hazardous waste, batteries, LED lights, refrigerators, freezers, AC units, concrete, dirt, and tires. For a complete list of banned items, visit gqcity.org/cleanup-days.

A limited amount of nutrient-rich compost will also be available, supplied by Orange County Waste and Recycling.

GARDEN GROVE TO PARTICIPATE IN NATIONAL PRESCRIPTION DRUG TAKE BACK DAY

On Saturday, October 26, 2024, from 10:00 a.m. to 2:00 p.m., the Garden Grove Police Department will participate in the Drug Enforcement Administration's (DEA) National Prescription Drug Take Back Day. The event gives the public an opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Pills can be disposed of at the Garden Grove Police Department, located at 11301 Acacia Parkway, Garden Grove 92842. The DEA cannot accept liquids or needles or sharps, only pills or patches. The service is free and anonymous, with no questions asked.

In April, Americans turned in 335 tons (over 670,000 pounds) of prescription drugs at over 4,000 sites operated by the DEA and its state and local law enforcement partners.

This initiative addresses a vital public safety and public health issue.

Medicines that languish in home cabinets are highly susceptible to diversion,
misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly
high, as are the number of accidental poisonings and overdoses due to these drugs.

Studies show that a majority of abused prescription drugs are obtained from family
and friends, including from the home medicine cabinet.

In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—pose potential safety and health hazards.

Former Senator Jim Beall honored with the prestigious League of California Cities Lifetime Achievement Award

Sacramento, CA — The League of California Cities Past Presidents Council today announced the selection of former State Senator Jim Beall as the recipient of the 2024 Past Presidents' Lifetime Achievement Award.

For decades, Beall has served California communities as a San Jose council member, a Santa Clara County supervisor, and as a Legislator in the California State Assembly and Senate. His work has focused on two critical issues: transportation infrastructure and affordable housing. In 2017, Beall authored SB 1, securing \$5.4 billion annually to repair roads, freeways, and bridges statewide. He also authored SB 595, which provided essential funding for regional transportation projects in the Bay Area.

"Jim Beall has been a true champion for California's communities," said Cal Cities Immediate Past President and Artesia Mayor Pro Tem Ali Sajjad Taj. "His leadership in securing vital funding for transportation and expanding affordable housing has made a lasting impact. His work embodies the spirit of public service, and his contributions will benefit California's cities and residents for generations to come."

Beall's leadership extended into housing with SB 3, which authorized \$4 billion in bonds to support affordable housing and veterans' homeownership programs. Throughout his career, Beall has also been a strong advocate for foster children and people living with a mental health illness or intellectual disability.

The Cal Cities Past Presidents' Lifetime Achievement Award was established in 1996 and is given annually.

Each city was chosen for its outstanding efforts and innovative programs to improve the quality of life and delivery of services in their communities. The winning cities are listed below with a link to a video featuring their initiatives:

- City of Benicia, Internal Administration

 Benicia's "Believe In Benicia" campaign addressed a \$6-9 million budget deficit by educating residents, fostering dialogue, and gaining record-breaking voter approval for local tax increases, securing the city's financial future.
- City of Brisbane, Planning and Environmental Quality
 Brisbane is making significant strides in climate action by implementing new rules
 for building audits and retrofits, which are expected to reduce citywide greenhouse
 gas emissions by over 5%.
- City of Citrus Heights, Public Works, Infrastructure, Transportation
 Citrus Heights' beautification program removed over 79 tons of debris in its first
 year. Through a coordinated, proactive effort to address blight and illegal camps,
 the city is enhancing public spaces, infrastructure, and community pride.
- City of Concord, Economic Development through the Arts
 Vibrant murals and public art installations have revitalized Downtown Concord
 thanks to the Create Concord program, which increases community access to arts
 and culture.
- City of Goleta, Enhancing Public Trust, Ethics, and Community Involvement LEAD Goleta, a bilingual six-week program designed to help residents understand and engage with local government, has empowered over 30 participants to actively participate in city governance and community decision-making.
- City of Livermore, Intergovernmental Collaboration
 Livermore partnered with its local school district to revitalize Horizons Family
 Counseling, expanding mental health support for youth and families through on-site
 counseling, workshops, and crisis intervention in schools.
- City of Modesto, Health and Wellness Programs

 The Healthy Room Project addresses juvenile delinquency by providing bedroom

makeovers for vulnerable children, improving their living conditions, strengthening community bonds, and enhancing their well-being.

- City of Modesto, Housing Programs and Innovations

 for unhoused residents that offers outreach, job training, and housing assistance.

The Hire Mo-Val program created nearly 34,000 jobs and revitalized the local economy by fostering business partnerships, offering workforce development, and offering direct hiring incentives. The program boosted household incomes by 53% and enhanced residents' well-being.

- City of Vacaville, Ruth Vreeland Award for Engaging Youth in City Government
 - Vacaville's Summer at City Hall program empowers high school students, particularly those from underprivileged backgrounds, by blending classroom education with city internships, fostering workforce development, civic engagement, and youth empowerment.
- City of Watsonville, Community Services and Economic Development Watsonville's Opportunity to Work program provides young adults with valuable skills and job training, resulting in the city hiring over a dozen participants and strengthening the local workforce.
