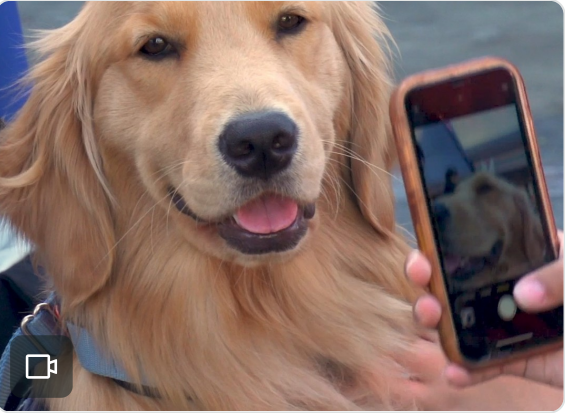

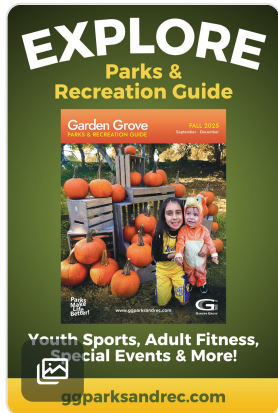

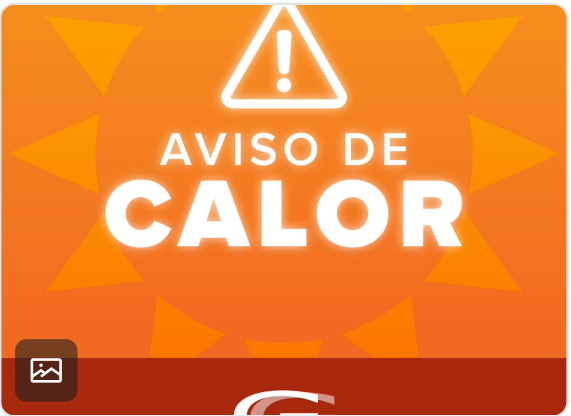

City leaders come together to mark United Against Hate Week

When it comes to combating hate, leadership matters. That was the message delivered to over 70 city officials who came together earlier this week in a Cal Cities roundtable on United Against Hate Week.

“Your voices as city leaders and your messaging to communities really makes a difference,” said Justin Lock, the executive director of [Not in Our Town](#), a California-based nonprofit that uses documentary film, new media, and organizing to stop hate and build safe, inclusive communities.

More than 200 communities in California this year are participating in United Against Hate Week, which runs Oct. 19-25.

During the roundtable, co-led by Emeryville City Manager LaTanya Bellow and Temecula City Clerk Randi Johl, city leaders shared the events and actions they are taking to mark the week. They also discussed ways they could create greater empathy for groups commonly impacted by hate crimes and build more inclusive communities all year long.

Hate crimes in California have risen by [more than 50% since 2020](#).

But while the city leaders who participated in the roundtable are concerned by the uptick in hate crimes, they are also encouraged by the collaboration of city governments, community organizations, faith-based groups, and others to foster greater respect for diversity in California cities.

Oakland launched the week by unveiling “[Together We Rise](#),” a mural in the city’s Chinatown. Pasadena designated October as [Bullying Prevention Awareness Month](#). Redwood City offered five events and [a reading list](#). The South Bay Coalition — El Segundo, Hermosa Beach, Manhattan Beach, and Redondo Beach — is organizing [a food drive](#) and Interfaith Unity Walk. Santa Cruz is holding an event at the Santa Cruz Public Library, [The Human Library: Unjudge Someone](#). San Diego created a video for social media with city officials [voicing their support](#) for the campaign. Alameda is hosting [a film screening and discussion](#) at city hall. Cities can participate in United Against Hate in other ways, including:

- [Passing a resolution](#).
- Sharing stories of community resilience through social media.
- Highlighting local initiatives or partnerships during the week of action.

The United Against Hate coalition began in the San Francisco Bay Area in 2017 but has since spread to every corner of California and throughout the country.

What does Windows 10 “end-of-life” really mean? I’ve heard that organizations can still use Windows 10 past Oct. 14.

When software or an application goes “end-of-life,” it means the vendor will no longer provide updates, patches, and support. Updates are crucial to fix bugs and performance issues, patches take care of security vulnerabilities, and support means the vendor will help customers when unique issues arise.

After Oct. 14, Microsoft will end updates, patches, and support for Windows 10. Yes, Windows 10 will still work — but it's no longer safe to use within your organization. Think of it like deciding to start leaving doors and windows unlocked 24/7. It doesn't mean burglaries will occur immediately or nonstop — but it means the risk of a burglary is greatly increased.

What are the immediate risks of running Windows 10 past end-of-life?

After Oct. 14, 2025, the following risks will increase:

- **Cyberattacks.** Without vulnerabilities patched by Microsoft, your systems now become easy targets for hackers.
- **Operational disruption.** With no more bug fixes and performance enhancements from Microsoft, you're increasing the chance of frozen, crashed, and slow computers.
- **Compatibility breakdowns.** New applications, tools, and hardware may not work with Windows 10.

What are my short-term options if I missed the Oct. 14 deadline?

Even if you've missed the deadline, a few options may help you in the near term.

- **Upgrade any eligible devices (recommended):** This is the best option, and you can do it ASAP with minimal cost and disruption. (Replacing a device is more time-consuming and costly.) If a device is eligible for an upgrade, think of the process like applying a very long Windows update. You'll need to assess your system requirements, check software and hardware compatibility, and plan your upgrade process — it still involves some critical steps and IT coordination.
- **Pay for Microsoft Extended Security Updates (ESUs):** Microsoft offers a paid extended support program for Windows 10 through 2028. While this might seem like a good shortcut, *extended support isn't a long-term plan*. You receive the bare minimum security updates, exposing you to operational performance issues and incompatibility with your future hardware and software investments.

How can I get help with Windows 10 upgrades?

If you work with an IT team or vendor, it's important to get a plan in place to reduce your risk ASAP. That plan should include:

- Assessing which devices are eligible for an upgrade versus a replacement.
- Migrating your files, applications, and settings with minimal disruption.
- Ensuring your information is kept secure during the transition.

Cal Cities-sponsored bond agency issues \$61.5 million in tax-exempt bonds for housing in San Bernardino and Buena Park

The California Statewide Communities Development Authority (CSCDA) recently announced the issuance of over \$61 million in affordable housing bonds for apartments in the cities of San Bernardino and Buena Park.

In San Bernardino, CSCDA issued \$33,060,500 in affordable housing bonds for Arrowhead Grover Phase IV Apartments.

The new construction of 92 affordable housing units will be rent restricted for extremely low and low-income residents. The one-, two-, and three-bedroom units will be reserved for families earning less than 30% to 80% of the area median income.

CSCDA also issued \$28,500,000 in affordable housing bonds for Dorado Senior Apartments in Buena Park. The 150 multifamily affordable housing apartments will continue to be 100% affordable and provide one- and two-bedroom apartments to extremely low-income and low-income senior residents.

The joint powers authority partnered with the cities of San Bernardino, Buena Park, and others to provide the bonds. The financing of the apartments will maintain the affordability of units for low-income tenants for an additional 55 years.
