WOODBURY PARK PROJECT

OBJECTIVE

To provide City Council with information regarding the Community Meeting held on Thursday, November 2, 2023 to provide residents an update on the Woodbury Park Revitalization and Expansion project.

BACKGROUND

In December 2021, the City of Garden Grove was awarded a \$6,000,000 grant from the California Department of Parks and Recreation to help fund the revitalization and expansion of Woodbury Park.

Included in the remodel of the 3.3-acre park is the installation of a new walking trail, outdoor fitness equipment, recreational swimming pool, two playground areas, picnic shelters, a skate spot, basketball courts, lighting, restrooms, and a parking lot. The project will include the expansion of the park on property that is currently part of Woodbury Elementary School, located adjacent to the park, on the southeast side of the property. This expansion will add almost a half-acre of open space that will be available for the public to use as passive or active space, expanding the park to a total of 3.8 acres.

In fall 2022, the City Council awarded a contract to David Volz Design Landscape Architects, Inc. to complete the design plans and specifications for the Woodbury Park Revitalization and Expansion Project.

DISCUSSION

On Thursday, November 2, 2023, a community meeting was held at Woodbury Park to provide residents an update on the design plans and construction for the park improvements. Community Services staff and the architect representing David Volz Design Landscape Architects, Inc. shared information on the progress of construction plans and the estimated completion timeline.

Attached is the park design that was presented during the meeting. Staff shared that this design is based on 60% completion of construction plan, and will still include additional changes to the park restrooms, playground areas, and skate plaza. A final design will be posted on the City's website where additional project information is available: gqcity.org/parksplan.

During the meeting, residents had an opportunity to raise any questions or concerns about the design of the park. Some of the feedback included concerns about park safety, particularly if there would be staff assigned to oversee the park. Residents were also concerned with park lighting, removal of existing trees that impacted their homes, overnight parking in the new parking lot, traffic within the adjacent neighborhood, streets without sidewalks, and other concerns pertaining to safe routes on streets surrounding the park. Staff provided responses to some of these concerns and assured residents that these comments would be shared with the Public Works and Police departments to discuss possible solutions. Overall, residents were excited and anxious to see these park improvements completed.

Staff also shared the following estimated project timeline:

- Complete Design Phase and Construction Plans by January 2024
- Construction Bid Process by March 2024
- Break Ground by June 2024
- Project Completion before or by Fall 2025

The meeting was well attended with over 30 residents. There were several marketing methods used to advertise this meeting, including:

- Door hangers of event flyer to households within a ½ mile radius of the project site with Spanish and Vietnamese translations
- Media releases
- Banner installed at park site
- Parent portal that sends emails to parents and families that attend Woodbury Elementary School
- Posting on City website
- Postings on City Instagram, Facebook, and Twitter accounts targeting specific zip codes
- Posting on Next Door App
- Emails to residents that attended previous project community workshops



WHY AM I RECEIVING THIS NOTICE?

On November 3, 2023, Southern California Gas Company (SoCalGas®) filed an application with the California Public Utilities Commission (CPUC) to recover costs recorded to its Catastrophic Event Memorandum Account (CEMA) and its COVID-19 Pandemic Protections Memorandum Account (CPPMA). The application is requesting a total increase in revenue requirement of \$57.3 million.

If the CPUC approves this application, SoCalGas will recover the recorded costs in gas rates over a 1-year period beginning after approval of the application. This will impact your monthly bill.

WHY IS SOCALGAS REQUESTING THIS RATE INCREASE?

The CPUC authorizes utilities to recover costs incurred to restore service to customers, repair or replace damaged facilities, and comply with governmental agency orders in connection with events that are declared as disasters or state of emergencies by state or federal authorities. As such, SoCalGas is seeking recovery for costs related to the 2017 winter storms, Thomas Fire (2017), Creek and Rye fires (2017), Skirball Fire (2017), Woolsey Fire (2018), Hill Fire (2018), Sandalwood Fire (2019), Saddleridge Fire (2019), Eagle Fire (2019), Reche Fire (2019), Wolf Fire (2019), Tick Fire (2019), Getty Fire (2019), Easy Fire (2019), the 2019 winter storms, and the COVID-19 Pandemic that began in 2020. SoCalGas is also seeking recovery of the incremental costs and waived charges it incurred associated with providing the emergency customer protection measures adopted in CPUC Decision 19-07-015.

HOW COULD THIS AFFECT MY MONTHLY GAS BILL?

If SoCalGass' rate request is approved by the CPUC, the average Non-CARE residential monthly bill using 36 therms per month would increase by approximately \$0.22 or 0.3% per month in 2025. The proposed average rates shown below are for 2025.

HOW DOES THE REST OF THIS PROCESS WORK?

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SoCalGass' application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review SoCalGass' application, including the Public Advocates Office. Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. 

CITY SEEKING RENTAL ASSISTANCE PROGRAM OPERATOR

The City of Garden Grove is seeking a qualified program operator to oversee the City's Rental Assistance Program, providing supportive housing services to individuals who are homeless or at risk of homelessness. Through a Request for Proposals (RFP) process, non-profit organizations experienced with housing support for the homeless are invited to submit a proposal for consideration at https://qq.city/ni-rfp by 5:00 p.m. on Wednesday, December 20, 2023.

Serving as the transition path from the Central Cities Navigation Center to permanent housing, the Rental Assistance Program will help individuals experiencing homelessness achieve self-sustainability through wrap-around case management services, including locating housing options, disbursing rental assistance payments, providing referrals to legal services and behavioral and health care providers, as well as job training and employment opportunities.

Slated to open in Spring 2024, the Central Cities Navigation Center will be a referral-based, transitional facility offering emergency housing and services to individuals experiencing homelessness in Garden Grove, Fountain Valley, and Westminster. The Rental Assistance Program is designed to bridge the housing gap for Garden Grove residents exiting the Central Cities Navigation Center.

City Seeking Rental Assistance Program Operator 2-2-2

Funding for the Rental Assistance Program is provided by the HOME-American Rescue Plan Act of 2021, a stimulus plan that addresses public health and economic crisis, while providing needed emergency funding for the homeless population.

CITY TO HOLD DEDICATION FOR OFF-DUTY POLICE OFFICER KILLED IN MOTORCYCLE ACCIDENT

On Tuesday, November 28, 2023, the Garden Grove City Council and the Garden Grove Police Department will honor Garden Grove Police Corporal Han Cho with a plaque dedication and unveiling. The ceremony will take place at 5:30 p.m., at the west entrance of the Garden Grove Community Meeting Center, at 11300 Stanford Avenue.

Corporal Cho was tragically killed during an off-duty motorcycle accident on Monday, August 7, on his way back from work as a Garden Grove Police officer. He served the City of Garden Grove for 28 years.

Corporal Cho began his career with the Garden Grove Police Department in 1995 as a police recruit. During his career, he worked a variety of assignments that included patrol, Gang Suppression Unit, Career Criminal Apprehension Team (CCAT), Hostage Negotiation Team, Neighborhood Traffic Unit, and as a field training officer. He rose to the rank of master officer in 2006, then to corporal in 2022. Han was a triathlete who enjoyed, running, swimming, biking, and completed numerous marathons. He is survived by his two children, parents, two sisters, a brother, and a niece.

Included in the program will be remarks by Garden Grove Mayor Steve Jones, Garden Grove Police Chief Amir El-Farra, and sister of the late Corporal Han Cho.

Murdy honored for biliteracy

Murdy Elementary School in Garden Grove has been awarded the 2024 Seal of Excellence Award for its Vietnamese Dual Immersion program by the California Association for Bilingual Education. Murdy was one of only four schools in California to receive the award recognizing schools with "exemplary biliteracy programs."

The Vietnamese Dual Language Immersion Program is in its seventh year at Murdy Elementary School and serves students in transitional kindergarten through sixth grade. It is one of very few Vietnamese immersion programs in the state.



"This award is a shining acknowledgement of the hard work and dedication of the teachers, families staff and community partners who have worked hand-in-hand to make the Vietnamese Immersion Program at Murdy successful and impactful for students," said Board of Education Trustee Lan Nguyen. "We are very proud of all that Murdy has accomplished to provide students with a high quality academic program that puts them on a path to bilingualism and biliteracy and creates stronger connections among students and their family members."

CABE's Seal of Excellence Award has a rigorous criteria which included a school visit last month. Murdy teachers and staff were proud to showcase their program's focus on curriculum

and instruction, achievements in bilingualism and biliteracy, high academic outcomes and sociocultural competence.

Murdy Elementary School is located near Little Saigon, which is known to have the largest Vietnamese population outside of Vietnam. The school will be recognized at the 2024 CABE Seal of Excellence Banquet during the organization's state conference in February and will host an award presentation in the spring.

Dear friends.

As we head towards the holidays and the end of 2023, I would like to share that OCCOG has wrapped up most of the tools and services funded with the Sub-Regional Partners (SRP), Regional Early Action Program (REAP 1.0) grant. The \$3.5 million grant, which OCCOG received in 2019, provided educational programs and tools to help OCCOG member jurisdictions increase affordable housing in Orange County. The successful on-call services bench that provides additional technical assistance and staff augmentation for planning-related activities will continue through February 2024. View a list of all the REAP 1.0 programs here.

We were all sad to see one of Tustin's two historic blimp hangars dramatically burn in the early morning hours of November 7. As the site continues to smolder the South Coast Air Quality Management District (SCAQMD) has conducted testing of debris and ash from the fire and determined the presence of asbestos. Health warnings were issued for the surrounding area and Tustin Unified schools were closed on Thursday, November 9. Also on November 9, the County of Orange declared a state of emergency and activated the Orange County Emergency Operations Center. While the holiday season can be hectic, it is important time to support local businesses and restaurants by shopping and dining in-person. November 25th is Small Business Saturday, a "holiday" launched in 2010 to bring attention to the fact that small business is the backbone of our economy. BOARD MEMBER SNAPSHOTS

Six Questions with Director Marshall Goodman

The OCCOG Governing Board includes 19 Orange County elected official and nine exofficio non-voting members who work together to represent Orange County's interests in regional planning policy. Let's meet Director Marshall Goodman.



Question 1: What area of Orange County do you represent for

OCCOG?

Answer 1: I am currently the Mayor Pro Tem of La Palma and represent District 18 for OCCOG. District 18 includes the cities of La Palma, Cypress and Garden Grove.

Q2: What is your favorite thing about living in Orange County?

A2: My favorite thing about living in Orange County has to be the diversity of people and locals. The vibrant communities that call Orange County home provide a wonderful variety of culture and experiences. This variety has in-turn provided the opportunity for our County-wide culture, which promotes and celebrates this diversity—the resulting variety of food choices is one of my favorite components. Also, the ability to hike in Fullerton and surf in Seal Beach all in the same day speaks to the wonderful diversity of our locales. Crystal Cove is one of my family's favorite Orange County destinations!

Q3: What issue made you interested in running for elected office?

A3: My journey to the La Palma City Council began with my service on the Community, Activities, and Beautification Committee. During my time as a Commissioner, the city performed a General Plan update and asked the City Committees to review the Plan and provide feedback. From that process, I was asked by a Council Member to consider running for a vacant Council seat. I ran unopposed and was elected to serve as a Council Member in 2016. Once elected, I took on economic development as a focus of my service.

Q4: What is La Palma doing to support affordable housing in the city?

A4: La Palma is part of the North Orange County Service Planning Area, which is made up of 13 cities. We joined forces to produce and operate two navigation centers using a bulk of funding that came directly from the state. La Palma is also seeking ideas to bring moderate income affordable housing to our city. Part of the issue for our policy makers is effectively conveying to our constituents that the top of the range for "moderate" level income for one person in Orange County is \$107,350—this equates to quite a few positions that provide integral services to our city including: a police officer or dispatcher; a mid-level County librarian; and, a City Clerk. I hope to further support affordable housing in La Palma, and across the county, by encouraging open and honest dialogue with my constituents and elected cohort.

Q5: As an accomplished professional drummer, songwriter and producer, how has music, and the music industry, influenced your leadership style?

A5: Being a professional musician has allowed me the opportunity to hone my consensusbuilding skills. There are a lot of different personalities in the music industry, and most who have been in a band of musicians will agree that each position tends to have pretty distinct personality traits—lead vocalists tend to be the worst if you're wondering. Having traversed the music industry and encountered the varied individuals and personalities, I have established a solid foundation for patience, empathy, and communication; as well as, an ability to be direct, assertive, and resilient. As a drummer, I enjoy symmetry and order, but at the same time I understand the importance of listening as we play in order to find opportunities for spontaneous creativity or improvisation. These are all components that I honed as a musician and use regularly as a community leader.

Q6: What is a must at your Thanksgiving dinner table?

A6: Family, discussions about what we're thankful for, and honoring my grandmother's life and ancestors by discussing the positive impact that Indigenous People had on the survival of our country's first European immigrants. Peach cobbler is a must too!

dwelling unit throughout the state. The LUCID home, designed and built by a team of students in UCI's Department of Civil and Environmental Engineering, showcased an innovative concrete structure that tied for first place in the energy efficiency performance rating category.

Six Zero-Emission On-Demand Transit Projects Funded to Increase Options for Local Residents



This spring, the Mobile Source Air Pollution Reduction Review Committee (MSRC) awarded more than \$1.9 million for six innovative projects that will deliver zero-emission on demand, flexible services to communities within the South Coast region. These projects will fill the gap between traditional "fixed-route" transit and "ride hailing technology" to increase transportation options for residents. Three of the projects are in Orange County.

The zero-emission vehicles will accommodate at least four passengers per vehicle (in addition to the driver). The vehicles must also comply with applicable Americans with Disabilities Act, Department of Transportation, and Department of Motor Vehicles requirements.

The three Orange County projects are:

- Circuit Transit Shared Mobility (City of Seal Beach) The
 City will partner with Circuit Transit to deploy three Waev
 GEM e6 vehicles to transport residents and tourists to
 many of the City's most visited areas including the pier,
 the beach, City Hall, and Main Street.
- Circuit Transit Rideshare Program (City of Huntington Beach) – The City will expand its existing microtransit service area to transport passengers who request a ride through their app.
- Old Towne Orange Microtransit Service (Anaheim Transportation Network) – ATN, in partnership with the City of Orange will launch a new on-demand microtransit service utilizing 10 Waev GEM e6 zero-emission vehicles around a one-mile radius of the Old Towne Orange Plaza.



With these projects, the MSRC aims to target communities that will most directly benefit from this type of mobility opportunity. This includes areas where microtransit services can be directly integrated into other transit systems. These will benefit areas where traditional fixed-route service would not be ideal, as well where traditional fixed-route transit does not currently meet the needs of residents. Several of these projects will launch later this year.

Register for South Coast AQMD's Free Air Quality Education Programs for Elementary, Middle and High School Students

South Coast AQMD's free air quality educations programs, Why Healthy Air Matters (WHAM), and the Clean Air Program for Elementary Students (CAPES) are open for registration. The programs were created to generate awareness of local air quality issues to elementary, middle and high school

students.

The WHAM program introduces students to academic and career paths that they can take to help clean the air. Students learn about air quality through a hands-on science, technology, engineering and math public policy, chemistry, health impacts, sources of air pollution and clean air solutions. This curriculum, aligned with Next Generation Science Standards (NGSS), is flexible to fit in-person, hybrid and/or distance learning. In Orange County, schools in Garden

Grove, Santa Ana, Mission Viejo, Fullerton, Huntington Beach, Capistrano and Fountain Valley have been participating in WHAM.

CAPES is geared toward first through sixth grade students. The program educates students about the importance of clean air, health impacts and actions students can take to improve air quality. Educators participating in this program are provided with short videos and an NGSS-aligned curriculum kit that includes lesson plans, worksheets and answer keys. In our county, schools in Orange, Santa Ana, Huntington Beach, Santa Ana and Buena Park have been participating in CAPES. The air quality education programs have collectively reached more than 31,000 students since their inception in 2019.

Last school year, South Coast AQMD implemented WHAM in a total of 409

classrooms, 70 high schools and 45 middle schools within the agency's jurisdiction, reaching more



than 10,000 middle and high school-aged students. CAPES was implemented in a total of 90 schools, reaching more than 6,000 students throughout South Coast AQMD's jurisdiction. Both programs are available at no cost for eligible schools, youth groups, clubs and organizations.

South Coast AQMD Awarded \$76 Million for a First-of-its-Kind Zero-Emission Fuel Cell Train



South Coast AQMD has been awarded roughly \$76 million by the California State Transportation Agency (CalSTA) for zero-emission projects that will help transform the goods movement sector in the San Pedro Bay Port corridor.

More than 80% of air pollution in Southern California is associated with mobile sources including trucks, trains, planes and oceangoing vessels. As such, transitioning to zero emission technologies is essential to reducing air pollution. The projects developed by this funding will create 7,600 jobs and reduce 1.7 tons of fine particulate matter (PM2.5) and 632 tons of Nitrogen Oxides (NOx)—a precursor to smog.

South Coast AQMD will use the more than \$76 million in CalSTA's Port and Freight Infrastructure Program to demonstrate one first-of-its-kind hydrogen fuel cell locomotive that will operate in and around Southern California. The project will also install 376 Direct Current Fast Chargers and 19 hydrogen refueling dispensers across seven locations for trucks used for goods movement.

This project will increase throughput to California ports by demonstrating a locomotive that can haul 50% more

freight per locomotive and deploy additional faster charging options for more than 2,100 zero-emission trucks, allowing more time to be spent on moving freight instead of recharging. South Coast AQMD is working with Wabtec Corporation and Prologis Mobility to deliver the fuel cell train and supporting infrastructure by 2027 and then demonstrate it for a year. The 2022 Air Quality Management Plan (AQMP) shows that to achieve federal air quality standards, we need to transition rapidly to zero-emission technologies in the goods movement sector to reduce PM2.5 and NOx emissions. South Coast AQMD is focused on the statewide goal of 100% zero-emissions in the transportation sector in part by facilitating and managing public and private partnerships.

The Port and Freight Infrastructure (PFI) Program seeks to improve the capacity, safety, efficiency and resiliency of goods movement to, from and through California's maritime ports. PFI aims to reduce greenhouse gas emissions, air pollution and negative economic impacts and improve public health for the many environmental justice communities adjacent to the corridors and facilities used for goods movement, while promoting high-quality road, port, freight and construction sector jobs.
