REQUEST: To allow the transfer of ownership of an existing liquor store,

Certified Market, which currently operates with an Alcoholic Beverage Control Type "21" (Off-sale, General) License without a Conditional Use Permit. Also, a request to reduce the size of the liquor store tenant space from 6,300 square feet to 3,192 square feet. The site is in the C-1 (Neighborhood Commercial) zone.
